- ◆ Faa'iidada rasumaalka, oo aan ka ahayn faa'iidada iibka guriga aasaasiga ah oo dib loogu maal geliyo guri assaasi ah ee cusub;
- ◆ Qiimaha laga dhimay ee khasaaraha ama qiimo dhaca;
- ◆ Lacagaha hawlgabka iyo dakhli sannadle ah oo nolosha oo dhan;
- ◆ Sharciga Amaanka Bulshada iyo faa'iidooyinka hawlgabka wadadda-tareenka;
- ◆ Mushaharka ciidanka iyo faa'iidooyinka aan ka aheyn daryeel-kula jooga iyo lacag-bixinta gargaarka caafimaadka;
- ◆ Mushharka iyo faa'iidooyinka ciidan ka soo dagaalamayaasha aan ka aheyn daryeel-kula jooga iyo lacag-bixinta gargaarka caafimaadka, faa'iidooyinka naafada ee ciidan ka soo dagaalamayaasha, iyo magdhawga ku tiirsanaanta; iyo
- ◆ Helayaasha faa'iido qaybinta iyo dulsaaraadka laga helo bondyada gobolka iyo degmada.
- ◆ **Dakhligan waxaa ka mid ah "dakhliga soo hara ee xorta ah" xitaa marka aan loo canshuurin ujeedooyinka IRS.**

**Muhiim ah:** Ku dar dhammaan ilaha dakhligaaga iyo qiimaha aad heshay, lamaanahaaga / la wadaagaaga guri helay, iyo wixii kula-kireystay guri helay inta lagu jirosanadka codsiga / qiimeynta (sanadka ka hor inta aan canshuurta bixinta lagaarin). Haddii aad soo sheegto dakhliga aadka u yar ama eber, ku lifaaq dukumiintiyada muujinaya sida aad buuxiso kharashyada nolol maalmeedkaaga. Isticmaal Safka/khadka K si aad u soo sheegto wixii dakhli ah ee aan lagu soo sheegin canshuur celintaada iyo aan ku qorneyn Safka/Khadka A ilaa J.

Ka waran haddii dakhligeyga uu isbeddelay bartamaha sanadka?

Haddii dakhligaagu uu aad hoos ugu dhacay (ama kordhay) ugu yaraan laba bilood inta ka hor dhammaadka sanadka iyoo aad filayso in isbeddelka dakhliga uu sii soconayo muddo aan xadidnayn, waxaad isticmaali kartaa celceliska cusub ee dakhligaaga ee bil kasta ah si loo qiyaaso dakhligaaga sanadlaha ah. Xisaabi dakhligaada adoo ku dhufanaya celceliska cusub ee dakhligaaga ee bil kasta ah (inta lagu jiro bilaha kadib marka uu isbeddelku dhacay) labo iyo toban.

**Tusaale:** Waxaad hawlgabatay bishii Sibteembar, dakhligaaga bishii wuxuu ka yaraaday \$3,500 illaa \$1,000 bilawga Oktoobar. Ku dhufo \$1,000 x 12 si loo qiyaaso dakhliga sanadlaha ee cusub. Ku sheeg qiimaha Safka/Khadka K oo ha buuxin safka/khadka A ilaa J. Bixi dukumiintiyada muujinaya dakhliga bisha ee cusub iyo marka uu isbeddelku dhacay.

### Safka/Khadka K – Ku sheeg dhammaan dakhliga reerka oo aan horey lagugu darin ama laga wada hadlin Safka/Khadka A ilaa

J. Ku dar dakhliga shisheeye ee aan lagu soo sheegin canshuur celintaada federaalka iyo dakhliga ee ay kuugu darsadeen xubnaha kale ee qoyskaaga ee aan lagu muujin Qaybta 1. Bixi ilaha iyo qiimaha dakhliga.

### **Safafka/khadadka L - O - Waa maxay dakhliga soo hara ee xorta ah ee laysku daray/leysu geeyey?**

RCW 84.36.383(4) wuxuu qeexayaa "dakhliga soo hara ee xorta ah ee isku darka ah" si ah dakhliga soo hara ee xorta ah ee lamaanahaaga ama la wadaagaaga guri iyo wixii kula kireystay, laga gooyo qiimaha aad ku bixisay ama lamaanahaaga ama la wadaagaaga guri uu ku bixiyey:

- ◆ Daawada uu qoray dhakhtar;
- ◆ Daaweyn ama daryeel qof ka mid ah guriga ama meesha kalkaalinta guriga, guriga hoyga, ama guriga qoyska ee dadka qaangaarka ah; iyo
- ◆ Caymiska Assaasiga ee daryeelka caafimaadka ee loogu talagalay Medicare. (Wakhtigaan, noocyada kale ee caymiska assaasiga ma aha ka dhimis/ka jarid la oggolyahay.)

Daryeelka ama daaweynta gurigaaga macnaheedu waa daaweyn caafimaad ama daryeel lagu helo guriga, oo ay ku jiraan daaweynta jirka. Waxaad sidoo kale ka jari kartaa kharashyada waxyaabaha loo nolosha looga baahan yahay sida oksijiin, alaabta guriga ee dadka leh baahida gaarka ah, daryeel-kula jooga ah, hawlgabada nadaafada guriga ee fudud, cunto gaariga lagu keeno (meals on wheels), feejignaanta nolosha, iyo adeegyo kale oo qayb ka ah adeegga guriga lagama maarmaanka ah ama adeegyada guriga ee haboon.

### **Tilmaamo gaar ah oo loogu talagalay safka/khadka P.**

Haddii aad lahaatay dib u hagaajin ee dakhligaaga ka mid ah kuwan soo socda iyoo aadan u soo fayl garen celinta IRS, ku soo sheeg qiimaha Safka/Khadka P oo ku dar foomka IRS ama warqada-shaqada ee aadku xisaabisay qiimaha dib u hagaajinta.

- ◆ Qaar ka mid ah kharashyada ganacsiga ee macalimiinta, kuwa ciidanka kaydka ah, fanaaniinta wax soo bandhiga, iyo mas'uuliinta dawlada ee lacag bixinta ku saaysan
- ◆ Caymiska caafimaadka ee iskii u shaqeystaha ama ku darsashada mashaarka hawlgabka, wadaagida faa'iidada, ama qorshaha hawlgabka ee sanadlaha ah
- ◆ Ka jarida koontada kaydka caafimaadka
- ◆ Kharashka guuritaanka
- ◆ Ka jarida IRA
- ◆ Masruufka isfurka guurka kadib ee la bixiyey
- ◆ Dulsaarka daynta waxbarashada, kharashka waxbarahada, iyo ka jarida kharash bixinta
- ◆ Ka jarida hawlgabadyada wax soo saarka gudaha
