- Address significant one-time behavioral health systems needs that align with MIDD goals and priorities.
- Consider MIDD 3 renewal.

Planning Process

- Solicited funding requests from existing initiatives.
- Engaged SMEs within BHRD to identify key priorities.
- Provided updates to and solicited feedback from the MIDD Steering Committee throughout process.
- Aligned with existing MIDD initiatives.

Current Picture

- 23-24 Revenues: **\$190,927,493**
- 23-24 Expenditures: **\$212,587,000**
 - Less \$5,200,000 estimated under expenditures

Undesignated fund balance (before Q2 omnibus): \$21.1 Million

 Reserved for Q2 Omnibus \$21.6 million (leaving a reserve shortfall of \$444,961)

- Sobering Center purchase restoration of funding to Behavioral Health Fund

Request for MIDD 3 renewal staffing

Existing Initiative Expansion: School-Based SBIRT (PRI-05)

Investment: \$790k to expand school district capacity to screen and serve more student This cost will span 2024 and 2025.

Existing Initiative: Zero Suicide (PRI-06)

Investment: \$400k to support trainings for providers, for trained behavioral health teams to participate in the training and to implement program elements. This cost will span 2024 and 2025.

Existing Initiative: Multipronged Opioid Strategies

Investment: \$1.5M to increase programming to address the opioid and overdose crisis. This cost will span 2024 and 2025.

Existing Initiative: Peer Bridgers (RR-11a)

Investment: \$619,297 to fund the cost of operating this MIDD more fully funded initiative. This cost will span 2024 and 2025.

Relaunch Existing Initiative: Restore Workforce Development (SI-04)

Investment: \$1.6M to re-introduce training and workforce development programming. This cost will span 2024 and 2025.

Existing Initiative: Juvenile Therapeutic Response and Accountability Court-Behavioral Health Response (TX-JTRAC-BHR)

Investment: \$380k to Urban Family to address behavioral health needs of young who are charged with serious violence and/or face a standard range disposition at Juvenile Rehabilitation.

Requested for inclusion by Superior Court

Existing Initiative: Housing Capital & Rental (RR-03)

One-time Investment: \$10M to support capital improvements of behavioral health facilities in King County.

- Integrated, transformational services/strategies designed to serve our most disenfranchised populations
- Client centered

Existing Initiative: Housing Support Services (RR-01) and Housing Capital and Rental (RR-03)

One-time Investment: \$5.6M to support purchase of a new location to permanently house the Sobering Center.

- Integrated, transformational services/strategies designed to serve our most disenfranchised populations
- Client Centered

ADMIN: MIDD 3 Renewal Staffing

Investment: \$663,600 to hire 4 Term-Limited Temporary (TLT) staff to support MIDD 3 renewal planning. This cost will span 2024 and 2025.
