DETERMINATION OF NONSIGNIFICANCE

Description of proposal:

The Recycling Depot, Inc., a currently operating business, has applied to the Seattle – King County Department of Public Health for a solid waste handling facility permit as a “Material Recovery and Piles Used for Storage Facility” located at 6004 Corson Avenue South, Seattle, Washington 98108. The facility will receive, recover, and process ferrous and non-ferrous metals, mixed scrap metals, and electronic wastes, and store sorted steel in piles prior to transport. In addition to processing the materials previously mentioned, the facility will also collect universal waste. The facility’s processing of these materials for shipping as commodities to other recycling centers is subject to Chapter 173-350 Washington Administrative Code, Solid Waste Handling Standards.
