

## SEPA ENVIRONMENTAL CHECKLIST

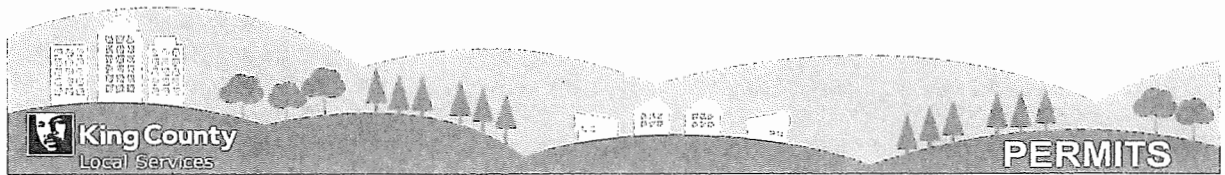
