**Project Location:** Located near 29301 SE Green River Gorge Road, Enumclaw, WA, within a City of Black Diamond easement on Washington State Parks property along the Green River in and around Green River Gorge and Hanging Gardens State Park. The Quarter-Section-Township-Range is SW-19-21-7 and the King County parcel numbers are 1921079030, 1921079032.

**Project Description:** Conveyance System Improvements to replace the existing 6-inch transmission mains from the springs collection system on the City's property to the existing North Bank Pump Station (NBPS) with a 12-inch-diameter transmission main and replace the City's existing suspension pedestrian bridge across the Green River.

**Permits requested in this application:** Shoreline Substantial Development Permit (SSDP); Shoreline Conditional Use Permit (SCUP)

The Department of Local Services (DLS) Permitting Division (Permitting) will issue a local decision on this application following a minimum, **30-day public comment period which ends Monday, February 13<sup>th</sup>, 2023**. Written comments on this application must be submitted to Permitting at the email or mailing address above. A public hearing is not required for this application prior to the DLS decision. However, the Permitting decision may be appealed to the Shoreline Hearings Board, who would conduct an appeal hearing prior to making a decision on the appeal. Details of the appeal process will be included in the notice of decision.
