The residence will be located the minimum setback, 10 feet, off of the front property line. There will be a 15-foot bsbl around the structure. The building envelope is 3, 913 square feet, which is the maximum allowed by King County. Water and sewer are available in the street. Mitigation will be equal to or greater than the area of the impacted buffer and onsite in the form of vegetative enhancement.
