  - Think through settings
    - Increase access to behavioral health treatment
    - Building of collaborative care model (primary care clinics)
      - Heavy screening for mental health and substance abuse (keeping a keen eye towards depression as well)
    - Need to create a model in which behavioral health issues are folded into primary care
    - Start with specific focus populations (i.e. behavioral health) then build capacity to help others from there
  - Team based care
  - Hot-spotting vs. cold-spotting approach
    - Finding groups using high cost utilization of system
  - Incentive based approach (must move needle to receive funding/recognition)
