GENERAL BUSINESS

MCC Minutes

Councilmember Pfeil called for MCC unanimous consent on approval of the May 16, 2023, meeting minutes unless there were objections. After calling for objections three times with no response, minutes were adopted.

DISCUSSION ITEMS

Racial Equity Feature

Minty LongEarth and Enrique Gonzalez presented, and led a discussion, on the history and meaning of Juneteenth and the importance of honoring its true meaning and using it as an opportunity to advance racial and social justice.

Board of Health Code Update

Dave Ward and Joy Carpine-Cazzanti gave an overview of their upcoming presentation at the July 20, King County Board of Health (BOH) meeting where BOH will consider proposed changes to BOH Code Section 11.04. Changes include the definition of "Department" from "Seattle/King County Department of Public Health" to "King County Department of Natural Resources and Parks" and various housekeeping items. Reason for changing the definition of "Department" is to align with the recent reorganization of the Haz Waste Program by the King County Council. If the proposed changes are adopted at the July 20 meeting, they will take effect on October 1,

2023. The BOH member representing Sound Cities Association (SCA) has been briefed by SCA staff. Bob Hennessey, who staffs Seattle City Council BOH members, will not brief them separately. They will be briefed by Susan Levy of King County Public Health.

Business Services Program

Charles Wu and Business Services team members gave a presentation on their work program including:

- On-site technical consultations with local small businesses to provide advice on safe storage, disposal, and management of hazardous materials and which regulations apply to the business.
- Providing financial incentives/reimbursements to businesses that make changes to protect workers or the environment from hazardous product use, storage, or disposal.
- Outreach to property managers and tabling at conferences to offer technical assistance and introduction to the Haz Waste Program.
- Working with businesses to encourage use of safer alternative products.
- Partnering with multi-family housing organizations to educate about safer cleaning products.

MCC Outreach Toolkit Overview

Joy Carpine-Cazzanti shared an overview of the newly created MCC Outreach Toolkit, which she emailed to MCC members and their liaisons on May 31. The Toolkit includes educational materials about the Haz Waste Program that can be shared and information to assist MCC members as they conduct outreach on behalf of the Program.
