This matter is before the Court relating to the release on personal recognizance of persons arrested on a bench warrant issued by King County District Court, and relating to the need for emergency release of persons from custody.

1. RELEASE ON PERSONAL RECOGNIZANCE

IT IS HEREBY ORDERED that all persons served with a warrant of arrest who meet the following criteria will be deemed eligible for release on their personal recognizance, and that such determination of eligibility shall be made by a commissioned police officer for the City of Redmond Police Department holding the rank of Corporal or above.

- A. The warrant was issued out of the King County District Court upon a complaint or citation filed by the City of Redmond;**
- B. The bail amount for the warrant does not exceed \$2500 bondable;**
- C. The warrant does not have the specific requirement of "CASH ONLY";**
- D. The warrant is not for an offense involving DUI; physical control; driving while license suspended in the first or second degree [DWLS 1, DWLS 2]; domestic violence; violation of an antiharassment, no contact, restraining order or protection order or stalking order;**
- E. The defendant is not severely impaired by drugs or alcohol, is able to care for themselves, and is not in possession of any dangerous weapons;**
- F. The defendant has an address and phone number which have been verified;**
- G. The bench warrant was the first warrant issued on the case.**

IT IS FURTHER ORDERED, that if these criteria are met, and if approved by the appropriate commissioned police officer referenced above, the defendant shall be given written notice to appear at the King County District Court, East Division, Redmond Courthouse at 1 p.m. on the Monday following the arrest on the warrant.

A copy of the Court's personal recognizance form, signed by the defendant, must be faxed or delivered by the Redmond Police Department to the King County District Court, East Division, Redmond Courthouse by 9:00 a.m. on the Friday preceding the Monday appearance date.

If the Redmond Police department is unable to forward the above documents to the Court by 9:00 a.m. on Friday, the defendant's appearance date shall be set for the next Monday after the documents are filed with the Court. If that Monday is a Court holiday, the appearance date shall be set for the following Tuesday at 1:00 p.m.

2. **REPEAL OF ANY PREVIOUS ADMINISTRATIVE ORDERS ON THIS SUBJECT.**

IT IS FURTHER ORDERED that any previous judicial Administrative Orders authorizing the City of Redmond Police to release on personal recognizance are hereby rescinded.
