## **IMPORTANT NOTICE TO DEFENDANTS ACCUSED OF A CRIME**

If you cannot afford a lawyer, you must be screened and determined eligible for a public defender. It is better to talk to your attorney immediately, rather than waiting. To see if you qualify for a public defender, you must contact the public defender screener below. Even if an attorney was originally assigned to you while you were in custody, you must still screen upon release to see if you continue to qualify.
