Executive Staff Follow-up from April 16, 2025, LSLU Meeting Additional Details on CAO Public Engagement 4/24/25

The Critical Areas Ordinance (CAO) update was functionally part of the 2024 Growth Management Act-required periodic Comprehensive Plan Update (2024 Update). As such, public notice of notice of comment opportunities, public updates via newsletter, resources and information on public web sites, and SEPA review for the 2024 Update also referenced the CAO update. The County also provided dedicated comment and engagement opportunities that were focused on the CAO and the supporting Best Available Science (BAS) review. Updates, communications, comment opportunities, and engagement on the CAO, both as part of the 2024 Update and separately, are summarized below.

Based on public comments and Councilmember questions raised in LSLU, this summary focuses on CAO engagement with 1) historically underrepresented communities and 2) natural resource commissions and committees. Other engagement with these communities and groups, as well as with other communities, groups; and the general public, also occurred throughout the 2024 Update process (both on the CAO and on other 2024 Update proposals). This summary focuses on the activities that included the CAO update.

Equitable engagement strategies were utilized throughout the Executive's 2024 Update development process, including but not limited to: translated social media posts; partnering with BIPOC social media micro-influencers; Spanish radio interviews; print materials (posters, handouts, rack cards, and placemats) distributed in historically underrepresented communities; survey incentives in historically underrepresented communities; place-based outreach efforts conducted in partnership with the members of the 2024 Comprehensive Plan Equity Work Group and other community-based organizations (such as the Silent Taskforce, Utopia Washington, and White Center Community Development Association); tabling at community-led events (such as Skyway Juneteenth Celebration); and partnering with community centers in historically underrepresented communities. Translation and interpretation services were also offered. Key Executive staff summary documents and Executive surveys for the 2024 Update and CAO update were translated in 6-8 languages. Public meetings with comment opportunities hosted by the Executive provided interpretation in 6 languages. Public meetings with comment opportunities hosted by the Council offered language assistance. Detailed code language and the Best Available Science Report were not translated.
