Welcome and Introductions

RAC Co-Chair and Council Vice President Jessica Forsythe called the meeting to order at 10:07 am, welcomed all in attendance to the third RAC meeting of 2025, and reviewed the agenda.

Approval of April 24, 2025 RAC meeting summary

Councilmember Sarah Perry moved to approve the April 24 meeting summary and Councilmember Evans seconded. **Members unanimously voted to approve the April 24 meeting summary**.

Good of the Order Updates (Information Item)

<u>Woodinville</u> – broke ground on 133rd roundabout and tunnel project. Community members are currently voting on tunnel skylight and art installation design.

<u>Kirkland</u> – moving forward with 132nd crossing project. There is currently a year-long closure at 85th just outside downtown during bridge and shared use pathway construction from downtown Kirkland to the transit center. They are working to expedite completion and potentially find times to open the trail when contractors aren't present given detour challenges.

<u>Redmond</u> – Eastrail segment will open Sept. 12 at 10 am; an official celebration invitation will go out soon. CM Forsythe provided a brief summary of the 'The Future of Eastrail workshop' that was held on June 13.

<u>Sount Transit</u> – continuing to work on NE 85th transit connection. May 10 celebration event opening the Downtown Redmond Link station which connects to the RCCIII was a success and station is already seeing significant use. Rep. Larsen visited to observe the trail/transit connection. They will break ground on Stride BRT facility in Bothell on Aug. 12.

Eastrail Northern Connections – Woodinville and Snohomish County (Information Item)

Jared Hill of the City of Woodinville, Emily Griffith of Snohomish County, and Curt Warber of King County provided updates on Eastrail northern connections with Snohomish County going through Woodinville. Slides were included in the meeting packet.

• Snohomish County: Centennial Trail south extension is the northernmost segment of Eastrail. They are working with multiple jurisdictions to connect to additional trails and trails systems. Corridor is currently closed to the public but they have initial funding for planning and early design and will be working on conceptual design and feasibility study this year and begin public engagement in 2026. Cost estimate in 2023 was \$120M but has likely increased. Snohomish

County does not have a parks levy like King County but has a strong capital program. The County is interested in a levy package and is having ongoing conversations with its jurisdictions.

- **Woodinville**: Eastrail will form the spine of a future linear park from the 133rd roundabout to Sammamish River Trail connection with various amenities along the approximately two miles the City has acquired. Projects include:
 - o Removal of the trestle at 131st, road widening and overpass installation
 - o Path to connect King County's Sammamish River Trail to Eastrail in Woodinville
 - o SR202 expansion between NE 175th St and NE 177th Pl, new pedestrian bridge, and trestle repurposing to replace a culvert on Little Bear Creek. Construction will begin in 2027.
 - o 133rd roundabout and tunnel broke ground this week. Will choose the final skylight design later this summer. ROW acquisition and utilities relocation will be a challenge. Tunnel added \$2.5M to project cost but was the best option for user safety. Safe Streets for All may be a potential federal funding source.
- **King County**: As mentioned by Redmond RCC III will be officially opened on Sept. 12. Eastrail main line, Eastrail spur, Woodinville Eastrail, and Sammamish River Trail all converge in Woodinville. When Woodinville connects their Eastrail segment there will be continuous trail from Bellevue through Woodinville. King County is working through prioritization of development of its trail segments and connections here in partnership with the local jurisdictions to support their goals. Currently determining how to connect Eastrail main line over the Sammamish River to Woodinville Eastrail segment. The northern portions of King County's Eastrail main line and spur are currently closed but rails have been removed, and they are ready for future development.

Site Walk of Woodinville Eastrail Corridor Area (Information Item)

Councilmember Michelle Evans, Mayor Mike Millman, and City Manager Brandon Buchanan from the City of Woodinville led a walking tour of key Woodinville Eastrail sections.



What Participants Shared:

Roles envisioned for Eastrail in the community – the Top 3:

2. An interconnected Eastside

Many visions for the future of Eastrail (43%) included connections to places – whether home, businesses, work, or neighboring communities.

3. Supporting local business

Many people (41%) imagined that the future of Eastrail would provide opportunities to stop for food, drinks, and shopping.




What Participants Shared:

Roles envisioned for Eastrail in the community (continued):

- Lively culture and arts
- Opportunities to recreate and play
- Scenic views and photo ops
- Connections to transit and micro-mobility
- Features for youth and families
- A car-free future
- Access to nature and rural land
- Safety
- Informational and historical features





What Participants Shared:

Ideas for focus and action:

- 30 individual ideas for focus and action
- We've heard a portion of these ideas before, with varying levels of action taken, and others are new
- Some are large magnitude ideas, focusing on e.g., refreshing/updating the vision for the corridor and enacting new funding approaches
- Some emphasize more discrete direct action e.g., implementing specific activation actions



What Participants Shared:

Illustrative ideas:

- Directly and purposely involve community youth in our work (#s 5, 9, 12)
- Explore, develop, and implement new public and private funding strategies and mechanisms (#s 29, 30)
- Refresh and update the vision and development plan for the corridor (#s 10, 20)
- Install amenities that support a positive trail user experience (#s 3, 6, 7, 8, 9, 23, 26)
- Implement an "Adopt-a-Trail" program (# 11)
- Incentivize/implement Trail Oriented Development (#s 25, 27, 28)

- Bolster Partnerships: Expand and strengthen the coalition of Eastrail supporters by creating
 opportunities for leaders from government, community-based organizations, private
 developers, employers, and others to engage with each other and form new relationships.
- Celebrate Achievements: Maintain the commitment of partners and supporters by demonstrating progress on Eastrail, highlighting successes, and acknowledging key contributions.

Format

The Future of Eastrail Workshop was an in-person event at the University of Washington's Global Innovation Exchange (GIX) in the Spring District of Bellevue. The event included morning refreshments, speakers, visioning activities, and a charrette. OUTCOMES

Representatives from Snohomish County also attended the event. Participants also reflected a broad cross-section of the community, including a federally-recognized tribe, private businesses, non-governmental organizations, community groups, transportation advocacy groups, and youth. Outcomes from each workshop activity are detailed in the sections below.

Visions for the Future of Eastrail

At the beginning of the event, the moderator asked participants to imagine the future of Eastrail. Participants reflected on the following questions as they wrote their vision on a blank postcard template.

- What does Eastrail look like?
- How did I get to the trail, what am I doing on the trail, and where am I going?
- Who am I with and who do I see?
- What destinations, attractions, or activities do I love on Eastrail?
- How is it changing lives and our sense of community?
- What moments or experiences make me love it the most?

This activity resulted in the following themes. A full list of responses is available in <u>Appendix B:</u> Postcard Transcriptions.

COMMUNITY AND SOCIAL COHESION

Nearly half of participants' visions for the future (46%) included images of connection to family, friends, and community. The future of Eastrail brings people together.

AN INTERCONNECTED EASTSIDE

Many visions for the future of Eastrail (43%) included connections to places – whether home, businesses, work, or neighboring communities.

SUPPORTING LOCAL BUSINESS

Many people (41%) imagined that the future of Eastrail would provide opportunities to stop for food, drinks, and shopping.

"Urban infrastructure in the past has been used to divide people, but Eastrail intentionally builds bridges for a connected future."

LIVELY CULTURE AND ARTS

In addition to local businesses, the future Eastrail corridor would provide opportunities to view cultural events, arts, and music, according to some participants (25%).

"The trail is always filled with people these days and adds a lot of ease and joy to life."

OPPORTUNITIES TO RECREATE AND PLAY

Some participants (19%) painted a vision of long bike rides, runs, or walks on the trail, with the infrastructure supporting a healthier lifestyle for eastside communities overall.

SCENIC VIEWS AND PHOTO OPS

Some participants (19%) described places to pause for views and photos along the trail.

CONNECTIONS TO TRANSIT AND MICRO-MOBILITY

Additionally, some participants (17%) described a future Eastrail corridor that is connected to frequent transit and micro-mobility.

FEATURES FOR YOUTH AND FAMILIES

Some participants (17%) visualized Eastrail as a place where several generations could gather, recreate, and play together.

A CAR-FREE FUTURE

Some participants (17%) emphasized that the future of Eastrail would provide an alternative mode of transportation for people who currently choose to drive.

"We've actually moved away from a car-centric community! We are healthier and happier!"

ACCESS TO NATURE AND RURAL LAND

Some participants (16%) are eager for the future of Eastrail to connect them to green space, nature, and rural landscapes.

SAFETY

Some participants (14%) described the visions above with a focus on safety for all users.

INFORMATIONAL AND HISTORICAL FEATURES

Finally, some participants (13%) imagined that the Eastrail corridor would include informational and historical features that helped users connect to the land and legacy of the region.

Charrette Brainstorming and Presentation

The event planning team planned a charrette activity to generate bold, innovative ideas that support and accelerate Eastrail development. Participants reflected on the questions below in small groups, each with a facilitator and notetaker. Each group had 55 minutes to brainstorm ideas, refine their top concepts, and work with a visual designer to create supporting graphics. After a short break, participants were given another 15 minutes to develop a pitch of their ideas for a presentation.

The summaries below include key findings from each charrette group. Full notes from charrette discussions can be found in <u>Appendix C: Detailed Notes from Charrette Activity</u>.

GROUP 1: FUNDING EASTRAIL DEVELOPMENT

We have made progress in advancing Eastrail, thanks to funding and resources from valuable private and public partners. That said, several key segments of Eastrail remain unfunded, representing substantial gaps that cannot be bridged through small-scale contributions alone. Realizing the full vision for Eastrail will require bold, coordinated funding solutions.

This charrette group was asked the following questions:

- How can we secure funding to complete the unfunded sections of Eastrail, given state and federal funding constraints and challenges associated with implementing new taxes or local improvement districts?
- What are some successful funding models from other communities that we can learn from?

- **Creative government funding:** Ideas included Tax Increment Financing at the state level, Safe Routes to School, lottery ticket sales, Regional Transit Authority Tax, Transportation Benefit District tax, and public-private conservancy funding.
- **Direct private investment from corporations and individual donors:** Specific examples included a membership model for trail-user contributions, community crowdfunding (e.g.,

- "buy-a-foot"), carbon credits, branding to incentive partnerships, and mile programs for trail maintenance and development.
- **Tourism:** Tourism bureaus could support funding by promoting destinations and agricultural attractions in Snohomish County.
- Activation and enthusiasm: Activation and enthusiasm around community health could promote funding from e-commerce, educational institutions, arts, and global exchange. Activation could include events like an annual bike-a-thon, festivals, races, and concerts. A portion of the proceeds or fees from these events could support funding for future development.

GROUP 2: PARTNERSHIPS FOR EASTRAIL DEVELOPMENT

Partnerships between government and private developers are essential to building out the vision for Eastrail.

This charrette group was asked the following questions:

- What are some bold ideas for partnerships to accelerate trail-oriented development, and where on Eastrail would they be most effective?
- What policy changes (e.g., zoning or land use) would help make these partnerships possible?

- **Streamlined permitting and approvals:** Predictable permitting and policies that allow private businesses to benefit from trail-oriented development may incentivize public-private partnerships to fund Eastrail development.
- **Cultural resources:** Facilitated government-to-government conversations; investments in indigenous gathering spaces, plants, and placenames; and stewardship agreements may support the protection of cultural resources and meaningful partnerships with tribal nations.
- **Policy:** Zoning and land use code changes would allow for partnerships between local governments, businesses, and housing developers to deliver on trail-oriented development.
- Trail connections: Expanding the vision for the trail to include greater connections within
 communities and beyond the eastside region to inspire partnerships with new jurisdictions
 and businesses.

GROUP 3: STRENGTHENING AND SUSTAINING COLLABORATION

Implementing the vision for Eastrail requires collaboration between owners, the cities through which Eastrail passes, private developers and property owners, adjacent neighborhoods, community members, and many others.

This charrette group was asked the following questions:

- What conditions are needed for effective collaboration to develop Eastrail?
- What obstacles make collaboration difficult, and how can we overcome them?
- As we look to the future of Eastrail, what role should the Regional Advisory Council and Eastrail Partners play in supporting effective collaboration?

- **Shared vision:** Creating a shared vision and clarity around responsibilities will support a feeling of ownership among stakeholders, supporting sustained collaboration.
- **Community engagement:** Investing in equitable community engagement, listening to opposition and concern, and planning events to inspire the community will build trust and momentum for strong collaboration with the public and local leaders.

- **Public-private partnerships:** Partnerships with private businesses to improve connections, housing opportunities, and amenities may bolster collaboration with businesses and communities that live, work, and play along the trail.
- Public ownership and art: Ideas like adopt-a-park and public art corridors could further bolster a feeling of ownership within the community, sustaining collaboration for funding, operations, and maintenance.
- **Communication and capacity:** Collaboration would be supported by easy to access information about the status and goals of Eastrail development; transparency around funding partners; clear roles and responsibilities; and capacity within leadership.

GROUP 4: ACTIVATING EASTRAIL

The future of Eastrail envisions a trail that is vibrant and welcoming. We need to consider how we will draw people and activity to Eastrail.

This charrette group was asked the following questions:

• What are some bold ideas for activating Eastrail and where specifically would these ideas be most effective along the corridor?

- How do we incentivize private developers to create activated and vibrant spaces along the trail?
- What should public agencies do to keep these spaces safe, welcoming, and economically beneficial to all community members?

- **Markers and signage:** Clear wayfinding can highlight the character of the trail and support connections to attractions.
- **Culture and interactive art:** A trail detailed with multilingual and multicultural, interactive, and accessible art will be inviting for all users.
- **Trail amenities:** Trash cans and bathrooms, charging stations, refreshment stands, and busking stations can support activation along the corridor.
- **Events and parades:** Events in all seasons and places for play will support ongoing use and a sense of community along the trail.
 - One participant imagined an annual event called "Miles of Me" that would foster a sense of belonging for youth. Participants would ride a number of miles based on their age or height, and place markers to connect them to their milestone on the trail.
- **Lighting:** Trail electrification would support 24-hour safety, vendor infrastructure needs, and activation for multiple use cases.
- **Vendors:** Space and amenities for food trucks and pop-up vendors would help bring community members together along the trail.

GROUP 5: ONE CORRIDOR, MANY WAYS TO MOVE


Eastrail is a multi-modal corridor, which means it is designed to accommodate a variety of different transportation uses, including walking, rolling, and transit.

This charrette group was asked the following questions:

- How can we make the most of Eastrail as a mobility corridor, helping people move around the Eastside and the region—whether on the trail, by transit, or through connections to other transportation options?
- What have we learned from communities about their mobility needs, and how can we help address those needs with Eastrail?
- How should we improve connections between the trail and transit, and where along Eastrail should we focus our efforts?

- **Micro-mobility:** Seamless regional micro-mobility, including parking and wayfinding, will help community members make the most of the corridor.
- **Safety:** Mode separation, safe routes to school, and improved street crossings and connections will improve feelings of safety along the trail.

- **Activation:** Events and amenities that engage youth and educate community members about opportunities on the corridor will promote access for all users.
- **Policy:** Policies that support separation from streets, amenities, and affordable housing will enable users to connect to the trail with greater ease and comfort.
- **Trail features:** Grassy recreational areas, bike lockers, access to discounted new mobility devices, trash cans, charging stations, bathrooms, and water fountains will support use across modes.
- **Transit:** Clear, well-timed, accessible, and safe connections to a variety of modes will support the mobility needs of trail users.





Options Discussed for Addressing EGA's Departure:

- 1. Keep the seat on the RAC for the role EGA was performing, and immediately identify and secure a new entity(ies) to take that seat
- 2. Keep the seat on the RAC, but leave it unfilled while RAC works though a timely process to identify a new entity(ies) to take that seat
- 3. Eliminate the RAC seat and reduce the number of RAC member entities
 - AND Over the longer term, decide on how to sustain a community voice in future RAC meetings



Anticipated Steps for Revising RAC Membership to Formalize EGA's Departure:

- 1. Letter from EGA to RAC Co-Chairs indicating its intention to leave the RAC (received October 17, 2025)
- 2. RAC consensus agreement on confirming EGA's departure and the resulting modification of RAC membership
- 3. Letter of Interest among RAC member entities affirming the membership revision

SECTION 2b. New RAC Membership:

The RAC will add or remove members, membership agencies and jurisdictions based on the following processes:

- Consensus agreement of the current RAC membership.
- Signed letter of interest by all parties acknowledging the change to the membership structure.
- 4. Revision and execution of the MOU to show the new membership

SECTION 2a. RAC Membership:

The RAC membership will be driven by the RAC vision. Members will include owner jurisdictions (King County, City of Kirkland, City of Redmond, Sound Transit, City of Woodinville, and Snohomish County) as well as easement holders (PSE, King County and Sound Transit), and cities directly adjacent to the corridor who hold permitting and land use authority, (City of Bellevue and City of Renton), and the Eastside Greenway—Alliance. King County will have four representatives, the King County Executive (or his/her designee), and three members from the County Council. The Eastside Greenway Alliance will have one member appointed to serve as representative of the Alliance, All other parties will have one representative from each party as a member of the RAC.

- 5. King County Council Motion approving the MOU (for KC) and formalizing the new RAC membership
- 6. RAC member resolution publicly acknowledging the contributions of EGA to progress on Eastrail priorities and thanking EGA and its member entities for these contributions

RAC Membership Revision – Eastside Greenway Alliance

Current Circumstances of Eastside Greenway Alliance:

- EGA has been a valuable member of the RAC since 2017
 - Provided a supportive voice from the stakeholder community on the RAC
 - Coordinated the engagement of several non-governmental entities that support Eastrail
 - Lead and supported implementation of actions to address high priorities
- The formation and effectiveness of Eastrail Partners has added a new avenue for community engagement
- EGA member entities remain supportive of Eastrail but have decided to disband their group

RAC Membership Revision – Eastside Greenway Alliance

Priorities for the Eastside Greenway Alliance:

- 1. Rebrand the Eastside Rail Corridor as a way to communicate the vision to the public
 - Eastrail rebranding completed in 2019
- 2. Secure funding for trail
 - funding for the Wilburton Trestle (including \$3m State; \$500k Group Health; \$1m from Bellevue)
 - advocacy for strong investment (\$50m) via the 2019 to 2025 KC Parks levy
- 3. Government partners identify a long-term plan to complete the trail by forming a **Blue Ribbon Funding Commission**.
 - The Funding Commission recommended the formation of a friends of group, which set the stage for Eastrail Partners




