- understanding of the confidentiality, privacy policies, and procedures of their school district concerning student data and student data protection, as it relates to the documentation of the screening and brief intervention process of the King County SB-SBIRT program and the Data Share Agreement that is in place between their school district and King County."
- Added Provider requirement "Provide King County, on an annual basis to be reviewed during the annual site visit, a clear written policy regarding how the school district responds to public records requests for SB-SBIRT data and, specifically, how the policy protects student Personal Identifiable Information as a result of participating in the SB-SBIRT program;"
- Added Provider requirement "Each district shall provide a full list of school and contractor staff who perform the brief intervention at the beginning of each school year, and ensure that they complete the training attestation in a timely fashion."
- Removed Provider requirement "The Motivational Interviewing Workgroup to support staff in maintaining their skills in Motivational Interviewing, which is the framework of the brief intervention, throughout the school year."
