Growth Management Planning Council (GMPC) Caucuses

3 from King County

2 from Seattle

4 from Sound Cities Association

Two must be GMPC members and one must serve on the Sound Transit Board



Non-elected Representatives

9-11 individuals with expertise in affordable housing, including displacement

One must represent a housing authority operating in King County

Appointment Process

- Appointed every odd numbered year by the GMPC Chair with GMPC concurrence
- Each GMPC caucus recommends its own members for appointment
- If a non-elected individual is unable to complete their term, a represented organization may suggest a replacement
- Members serve in a provisional capacity with full voting rights pending appointment

Recommended Membership

- 15 returning members
- GMPC Chair needs to fill at least two and up to five vacancies
- AHC staff recommend the GMPC Chair appoint Saghar Amini, Advocacy and Policy Organizer with Habitat for Humanity of Seattle-King & Kittitas Counties
- Staff will provide recommendations to the Committee who will in turn make a recommendation to the GMPC
- Staff seek AHC concurrence on the recommended slate and input on the process to fill the remaining vacancies






Meaningful Action

Overview | Lake Forest Park

- 13,006 people (<1% of King County) | \$92,292 median household income
- 77% of residents identify as White, more than the countywide percentage
- 81% of the housing stock is single family and no units of emergency housing or permanent supportive housing
- Many properties in the city once subject to racially restrictive covenants, which restricted the residence of people of color in the early 20th century
- Expansion of Sound Transit high-capacity bus rapid transit Stride in 2028

Strengths | Lake Forest Park


1. Thorough documentation of the local history of racially exclusive land use and housing practices in alignment, including information on properties once subject to racially restrictive covenants (CPP H-5)


Recommendations | Lake Forest Park

- 1. Identify capacity for emergency housing (CPPs H-1, H-11)
- 2. Prioritize extremely low-income households (CPP H-2)
- 3. Complete the housing inventory and analysis (CPP H-3)
- 4. Provide for affordable housing to rent and own throughout the jurisdiction (CPPs H-5, H-9, H-18(a))
- 5. Expand and support the supply of income-restricted housing near high-capacity and frequent transit (CPPs H-16, H-17)
- 6. Submit necessary implementation details (CPP H-27)

Overview | Kent

- 133,378 people (5.9% of King County) | \$90,416 median household income
- Kent ranks among the most racially and ethnically diverse cities in the nation
- Black, Hispanic, and Native Hawaiian/Pacific Islander households more likely to be cost burdened than other racial and ethnic groups
- Currently served by Sound Transit's Sounder train and King County Metro's RapidRide A, with a Sound Transit Link light rail station opening in 2026
- Significant recent in-migration of low-income households, likely due to increased housing prices outpacing wages in other areas of the county





Strengths | Kent

- 1. Thorough housing inventory and analysis, evaluation of existing programs, identification of gaps, and documentation of the local history of racially exclusive and discriminatory land use and housing practices (CPPs H-3, H-4, H-5)
- 2. Commitment to ongoing collaboration with diverse partners on the provision of resources and programs to meet countywide housing needs, including ongoing membership in South King Housing and Homelessness Partners (SKHHP) and collaboration with the AHC (CPPs H-6, H-7)
- Unique and meaningful programs that help ensure healthy and safe homes for residents, including the rental housing inspection and home repair programs in (CPP H-24)


Recommendations | Kent

- 1. Prioritize extremely low-income households (CPP H-2)
- 2. Identify capacity for allocated housing needs by income level (CPPs H-1, H-11)
- 3. Explicitly plan for income-restricted affordable housing in proximity to high-capacity transit (CPP H-17)
- 4. Provide more detailed implementation strategies (CPP H-27)

Overview | Duvall

- 8,517 people (<1% of King County) | \$178,821 median household income
- 70% of Duvall's population is White, more than countywide
- Over 80% of current housing stock are single family homes and less than 2% multifamily housing
- 2023 average rents in Duvall were significantly higher than nearby cities of Snoqualmie, North Bend, and Redmond

Strengths | Duvall

- 1. Thorough housing action plan that demonstrates engagement with diverse members of the community to inform housing policy (CPP H-7)
- 2. Careful analysis of effectiveness of existing housing policies and strategies to meet housing needs, and commitments to address gaps in existing partnerships, policies, and dedicated resources for meeting housing needs (CPPs H-4, H-12)

Recommendations | Duvall

I. Identify sufficient land capacity (CPPs H-I, H-II)

- 2. Prioritize extremely low-income households (CPP H-2)
- 3. Complete the housing inventory and analysis (CPP H-3)
- 4. Collaborate with populations most disproportionately impacted by housing cost burden (CPP H-8)
- 5. Document racially exclusive and discriminatory land use and housing practices and adopt intentional, targeted actions to repair harm (CPPs H-4, H-5, H-9, H-20)
