






GUÍA DE INICIO RÁPIDO DEL PORTAL KC SCRIPT: PAGO DE SUS MULTAS DEL TRIBUNAL

Esta guía de inicio rápido le mostrará cómo pagar en línea sus multas del tribunal (LFO – siglas en inglés de "obligaciones financieras legales").

Nota: para hacer esto, debe iniciar sesión en su cuenta del portal.

! Por ahora, los delincuentes juveniles no pueden pagar las multas del tribunal en línea.

<p>1. Oprima Pay Court Fines (Pagar multas del tribunal) en la barra de menú negra.</p>	
<p>2. Escriba el nombre de su pago en el cuadro Submission Title (Título del envío).</p>	
<p>3. Escriba su número de caso. Oprima el botón Search (Buscar).</p> <p>Nota: si su número de caso contiene una letra C, reemplace la C con el número 1.</p>	

4. Verifique que la información del caso sea correcta, y luego escriba el importe a pagar.


