




此快速入門指南將說明如何透過「待審核命令」向法庭提交擬議命令。




<p>1. 選取頂部導覽欄中的「E-Filing」。</p>

然後選取「**Next Step**」（下一步）按鍵。




6. 要提交擬議命令，請選取「**Order Type**」（命令類型）。
