King County Superior Court 2021 Annual Statistical Report

Department of Judicial Administration

2021 Highlights

The coronavirus pandemic has greatly impacted the 2020 and 2021 statistics.

This annual statistical report presents information on filings, resolutions, pending caseload, and trials in King County Superior Court (KCSC). Because of the year-end update and adjustment, a slight difference may exist between the statistics in this annual report and the statistics in the quarterly reports.

- Filings (Table 1). The total number of cases filed in 2021 was 6% lower than that in 2020 (-6%). In 2021, the filing volume (including "Matters Filed with Clerk") was 43,131 cases. Total judicial filings (after excluding "Matters Filed with Clerk") decreased by 6.6% from 2020 (-6.6%), totaling 40,249 cases. When compared with 2020, decrease in 2021 filings occurred in the following major categories: criminal filings (excluding criminal appeals) down 20.7%, civil down 11.3%, juvenile offender down 54.8%, juvenile dependency down 17%, and juvenile termination down 29.6%. Domestic and Involuntary Treatment Act (ITA) filings in 2021 remained at the same level as in 2020. An increase in filings was observed in probate (+10.5%), guardianship (+45.8%), and parentage (+17.9).
- Resolutions (Table 2). The total resolutions (including "Matters Filed with Clerk") in 2021 were 44,965 cases, comparable to the number of resolutions in 2020 (+2%). The court resolved more cases than the filings received in 2021. In particular, the court had more criminal resolutions than the criminal filings in 2021 due to a sizeable dismissal of Blake cases. However, the overall resolution volume was significantly lower than the pre-COVID level.
- Pending Caseload (Table 3). The overall pending caseload at the end of 2021 was 19,567 cases, showing a noticeable decrease from the end of 2020 (-14.8%) due to the low filings in most case types. All major case types had shown a decrease in pending caseload when compared to 2020: criminal down 20.3% (-20.3%), civil down 19.9% (-19.9%), domestic down 2.9% (-2.9%), and juvenile offender down 50% (-50%). Criminal pending caseload decreased from the historical high in 2020 due to Covid-19, however, the current pending criminal volume is still significantly higher than the pre-COVID level. It is worth noting that the court has many more un-resolved serious criminal cases in homicides, sex crimes, burglary 1st degree, and assaults (1st and 2nd degree).
- <u>Trials</u>. The court had more trials in 2021 than 2020, totaling 903 trials (243 jury trials and 660 non-jury trials) in 2021. This is a remarkable achievement during the pandemic time.
- MRJC vs. SEA (Table 4). Of the total 43,131 cases (including Matters filed with the Clerk) filed in 2021, 33% were MRJC cases. In 2021, the MRJC accounted for 45%, 41%, and 39% of total criminal, civil and domestic case filings, respectively. The MRJC resolutions (33%, as a percentage of total resolutions in KCSC) in 2021 were comparable to the 33% of filings at MRJC. At the end of 2021, the MRJC pending caseload was 36% of the entire court caseload, with 43% of the total active criminal cases, 33% of the total pending civil cases, and 42% of the total pending domestic cases.



Resolution

A case is resolved if all issues in the complaint are fully adjudicated.

Suspended Case

A case is placed in suspense status from active status during the reporting period.

Suspense Status

A case is on suspense status if it is on warrant, appeal, stay, mediation, arbitration ("Deferred Prosecution" is not a suspense status, but is treated as a resolution).

Trial

A hearing set before a judge or jury in which all the issues in the case are meant to be resolved. A trial normally includes opening statements to the court or jury stating what evidence will show, introduction of witnesses and exhibits for direct and cross examination, final arguments to the court or jury in which counsel argue both the evidence and the law, and judgment by the court or jury stating what the facts of the case are and what law applies to the facts. In a jury case, it also includes the selection of the jury. A trial can be held for one or more cases. A single trial may be held to adjudicate more than one case (as defined above).
