### **Summary**

#### • Filings

**<u>2019 filings.</u>** The total filings in 2019 were: DEP=759 (SEA: 474, KNT: 285), TER=225 (SEA: 142, KNT: 83), ARY/CNS=158 (SEA: 69, KNT: 89), TRU=1706 (SEA: 760, KNT: 946).

**<u>2020 filings.</u>** The filings in 2020 were: DEP=435 (SEA: 302, KNT: 133), TER=291 (SEA: 148, KNT: 143), ARY/CNS=71 (SEA: 30, KNT: 41), TRU=501 (SEA: 179, KNT: 322), OTHERS=116 (SEA: 72, KNT: 44).

**<u>2021 filings.</u>** The filings in the first two quarters of 2021 were: DEP=206 (SEA: 133, KNT: 73), TER=97 (SEA: 51, KNT: 46), ARY/CNS=27 (SEA: 10, KNT: 17), TRU=4 (SEA: 2, KNT: 2), OTHERS=86 (SEA: 53, KNT: 33).

#### • Resolutions (approval or dismissal of petitions)

Resolution is defined as either the "approval" or the "dismissal" of the petition.

**<u>2019 resolutions.</u>** The total resolutions in 2019 were: DEP=652 (SEA: 400, KNT: 252), TER=187 (SEA: 120, KNT: 67), ARY/CNS=145 (SEA: 59, KNT: 86), TRU=1632 (SEA: 711, KNT: 921).

**<u>2020 resolutions.</u>** The resolutions in 2020 were: DEP=498 (SEA: 308, KNT: 190), TER=170 (SEA: 100, KNT: 70), ARY/CNS=98 (SEA: 40, KNT: 58), TRU=1769 (SEA: 901, KNT: 868), OTHERS=94 (SEA: 59, KNT: 35).

**<u>2021 resolutions.</u>** The resolutions in the first two quarters of 2021 were: DEP=242 (SEA: 166, KNT: 76), TER=125 (SEA: 60, KNT: 65), ARY/CNS=32 (SEA: 16, KNT: 16), TRU=360 (SEA: 70, KNT: 290), OTHERS=98 (SEA: 66, KNT: 32).

#### • Pending Resolution

At the end of the second quarter of 2021, the pending resolution (petitions are neither approved nor dismissed yet) caseload was: DEP=252 (SEA: 155, KNT: 97), TER=345 (SEA: 207, KNT: 138), ARY/CNS=25 (SEA: 14, KNT: 11), TRU=479 (SEA: 345, KNT: 134), OTHERS=126 (SEA: 66, KNT: 60).

#### • Pending Completion

At the end of the second quarter of 2021, the caseload in the "post-resolution" phase (resolved but still pending completion) in the DEP/ARY/CNS/TRU categories was: DEP=1411 (SEA: 784, KNT: 627), ARY/CNS =68 (SEA: 44, KNT: 24), TRU=40 (SEA: 15, KNT: 25), OTHERS=423 (SEA: 297, KNT: 126).

#### • Age of Pending Resolution Cases

At the end of the second quarter of 2021, there were a number of cases (older than 180 days since filing) which remained as unresolved (still pending the approval or dismissal of the petitions): DEP=122, TER=273, ARY/CNS=14, TRU=475.

#### • Age of Pending Completion (resolved) Cases since the Approval of Petition

Of the cases that have been resolved but pending completion (still involving court actions) at the end of the second quarter of 2021, most of them are within 1 year, except for DEP and ARY cases. There were 234 DEP cases and 44 ARY/CNS cases still pending completion 5 years after the approval of the original petition.

#### • Number of Fact-findings (FF)

**<u>2019 fact-findings.</u>** The number of fact-findings in 2019 were: DEP=318 (SEA: 109, KNT: 209), TER=163 (SEA: 101, KNT: 62), ARY/CNS=31 (SEA: 2, KNT: 29), TRU=35 (SEA: 16, KNT: 19).

**<u>2020 fact-findings.</u>** The number of fact-findings in 2020 were: DEP=191 (SEA: 93, KNT: 98), TER=175 (SEA: 108, KNT: 67), ARY/CNS=33 (SEA: 14, KNT: 19), TRU=2 (SEA: 1, KNT: 1).

**<u>2021 fact-findings.</u>** The number of fact-findings in the first two quarters of 2021 were: DEP=125 (SEA: 73, KNT: 52), TER=118 (SEA: 70, KNT: 48), ARY/CNS=8 (SEA: 3, KNT: 5), TRU=0 (SEA: 0, KNT: 0).

#### • Number of Hearings (non Fact-findings)

**2019 hearings.** The number of non fact-finding hearings in 2019 were: DEP=9502 (SEA: 5295, KNT: 4207), TER=328 (SEA: 228, KNT: 100), ARY/CNS=251 (SEA: 81, KNT: 170), TRU=297 (SEA: 88, KNT: 209).

**<u>2020 hearings.</u>** The number of non fact-finding hearings in 2020 were: DEP=5734 (SEA: 3362, KNT: 2372), TER=299 (SEA: 215, KNT: 84), ARY/CNS=122 (SEA: 32, KNT: 90), TRU=40 (SEA: 4, KNT: 36).

<u>2021 hearings.</u> The number of non fact-finding hearings in the first two quarter of 2021 were: DEP=3543 (SEA: 1988, KNT: 1555), TER=307 (SEA: 134, KNT: 173), ARY/CNS=43 (SEA: 6, KNT: 37), TRU=0 (SEA: 0, KNT: 0).

### Terminology

#### Filings

Number of petitions (cases) filed.

#### Resolutions

Number of petitions (cases) resolved, either by "approval" or "dismissal" of petitions. Unlike the definition of "resolution" for other Superior Court case types, the "resolution" for these case categories does not indicate the end of judicial involvement if the petition is approved.

#### **Pending Resolution**

Number of active cases that have not been resolved, namely the petition has neither been approved nor dismissed yet.

#### **Resolved, Pending Completion**

Number of cases for which the petition has been approved, but issues (sometime significant issues) still remain in which the court is actively involved.

#### **Resolution Age**

Time (days) from filing to resolution, less suspense time if applicable.

#### Pending Resolution Case Age

Time (days) from filing to the last day of the reporting period for these cases that still remain unresolved (no approval or dismiss yet), less suspense time, if applicable.

#### Pending Completion Case Age since the Approval of Petition

Time (days) from filing from the approval of the original petition (resolution) to the last day of the reporting period for those cases that still remain uncompleted (resolved, but with court activities), less suspense time, if applicable.

#### Number of Fact-findings (FF)

This is an estimate of actual fact-finding hearings held due to siblings belonging to one family unit having data entered on each case for the same fact-finding hearing proceeding.

#### Number of Hearings (non Fact-findings)

Number of all hearings other than fact-findings entered during the reporting period. The number of hearings is further divided into "pre-resolution" and "post-resolution" hearings depending on the time of the hearings in relation to the resolution date.
