2022 Highlights

The coronavirus pandemic has greatly impacted the 2020, 2021 and 2022 statistics.

This annual statistical report presents information on filings, resolutions, pending caseload, and trials in King County Superior Court (KCSC). Because of the year-end update and adjustment, a slight difference may exist between the statistics in this annual report and the statistics in the quarterly reports.

- <u>Filings</u> (Table 1). The total number of cases filed in 2022 was 15% higher than that in 2021 (+15%). In 2022, the filing volume (including "Matters Filed with Clerk") was 49,593 cases. Total judicial filings (after excluding "Matters Filed with Clerk") increased by 10.4% from 2021 (+10.4%), totaling 44,424 cases. Filings were the highest since the COVID pandemic, but still lower than the pre-COVID level. When compared with 2021, notable increases in 2022 filings occurred in the following major categories: criminal (excluding criminal appeals) up 6.4%, civil up 15.9%, ITA up 9.8%, and juvenile offender up 40.4%. On the other hand, guardianship filings were down 9.4%, and parentage down 13.5% when compared with 2021. In addition, the court started to receive significant number of truancy filings and civil matters filed with the clerk again in 2022.
- <u>**Resolutions**</u> (Table 2). The total resolutions (including "Matters Filed with Clerk") in 2022 were 47,858 cases, 6% higher than 2021 (+6%). However, the court resolved fewer cases than the filings received in 2022; the total resolution volume was 1,737 fewer cases than the total filings. The court resolved fewer cases than the filing volume in all case types, except domestic, parentage and ITA. The overall resolution volume was significantly lower than the pre-COVID level.
- Pending Caseload (Table 3). The overall pending caseload at the end of 2022 was 20,095 cases, showing a slight increase from the end of 2021 (+2.7%). When compared to 2021 notable decreases in pending caseload include: criminal down 11%, parentage down 11%, and ITA down 47%. On the other hand, the pending caseloads increased in the following case categories: civil up 9%, ARY and CHINS up 32%, dependency up 16%, and offender up 5%. The significant decrease in criminal pending was mainly due to the court resuming the use of warrants for defendants not appearing for court proceedings. Please note cases in warrant status are not in the "pending caseload" category. Even with the decrease in 2022, the criminal pending caseload is still significantly higher than the pre-COVID level. It is worth noting that the court has many more unresolved serious criminal cases in homicides, sex crimes, burglary 1st degree, and assaults (1st and 2nd degree) since COVID-19.
- <u>**Trials**</u>. The court had fewer trials in 2022 than 2021, totaling 818 trials (224 jury trials and 594 non-jury trials) in 2022. The court had 19 fewer jury trials and 66 fewer non-jury trials when compared to 2021
- <u>MRJC vs. SEA</u> (Table 4). Of the total 49,593 cases (including Matters filed with the Clerk) filed in 2022, 34% were MRJC cases. In 2022, the MRJC accounted for 38%, 41%, and 39% of total criminal, civil and domestic case filings, respectively. The MRJC resolutions (33%, as a percentage of total resolutions in KCSC) in 2022 were comparable to the 34% of filings at MRJC. At the end of 2022, the MRJC pending caseload was 37% of the entire court caseload, with 41% of the total active criminal cases, 33% of the total pending civil cases, and 41% of the total pending domestic cases.



Resolution

A case is resolved if all issues in the complaint are fully adjudicated.

Suspended Case

A case is placed in suspense status from active status during the reporting period.

Suspense Status

A case is on suspense status if it is on warrant, appeal, stay, mediation, arbitration ("Deferred Prosecution" is not a suspense status, but is treated as a resolution).

Trial

A hearing set before a judge or jury in which all the issues in the case are meant to be resolved. A trial normally includes opening statements to the court or jury stating what evidence will show, introduction of witnesses and exhibits for direct and cross examination, final arguments to the court or jury in which counsel argue both the evidence and the law, and judgment by the court or jury stating what the facts of the case are and what law applies to the facts. In a jury case, it also includes the selection of the jury. A trial can be held for one or more cases. A single trial may be held to adjudicate more than one case (as defined above).
