
<u>Highlights</u>


- <u>Criminal Cases</u>. The criminal filings in the first two quarters of 2023 were higher than in 2022, showing a 8% increase from the same time of 2022. The total criminal case filings (excluding RALJ) in the first half of 2023 were 2,655 cases, with MRJC accounting for 34% of the total cases. The resolutions of criminal cases in the first two quarters of 2023 were 2,582 cases, lower than the filing volume. The pending criminal caseload at the end of June 2023 was 4,286 cases (excluding RALJ). Of the 4,286 pending criminal cases, 37% were the MRJC cases.
- <u>*Civil Cases.*</u> Filings in civil cases (case type 2) in the two quarters of 2023 were higher than 2022 as well, totaling 8,825 cases and showing an increase of 14.9% from the same period in 2022. The civil resolutions were slightly lower than the filing volume, totaling 8,383 cases in the same reporting period. The pending civil caseload was 7,124 cases at the end of June 2023, a low volume when compared with pre-Covid level. At the end of June 2023, MRJC had 34% of the pending civil caseload.
- **Domestic Cases.** Domestic case (case type 3) filings in the first half of 2023 were higher than 2022, with 7.2% increase. In the two quarters of 2023, a total of 3,271 domestic cases were filed. The resolutions of domestic cases did not match the filing volume in the same period. The pending domestic caseload was 4,448 cases at the end of June 2023, with 41% being the MRJC cases.
- *ITA Cases.* The filings of ITA cases in 2023 continued an upward trend. A total of 2,872 ITA cases were filed in the first half of 2023, up 2.1% from the same time in 2022. The number of ITA cases remaining to be adjudicated at the end of June 2023 was 309 cases.
- Juvenile Dependency/Termination (DEP/TER) and At-risk Youth (ARY)/Child-in-Need of Service (CHINS) Cases. In 2023, dependency filings were down 14.7% from 2022, terminations up 8%, and ARY/CHINS/others up significantly (+87.1%) from the same time in 2022. Court also continues to receive a significant number of truancy cases in 2023 after a pause during the Covid pandemic. At the end of June 2023, the numbers of cases pending disposition in the non-offender juvenile categories are: 240 dependency cases, 180 termination cases, and 129 ARY/CHINS/Other cases.
- Juvenile Offender Cases. The juvenile offender filings in 2023 increased significantly from 2022. In the first half of 2023, 375 offender cases were filed, showing a 71% increase from 2022. The resolution pace for juvenile offender cases was just a bit slower than the filing pace in the same period. At the end of June 2023, there were 309 juvenile offender pending cases.
- *Pro Tem Use.* In the two quarters of 2023, the daily Pro Tem use by the court was 3.4 and 3.8 FTEs, respectively.
- *Post-resolution Modifications (Table 1-A).* In 2023, there were 271 post-resolution modifications filed (both parenting plan and relocation modifications) year-to-date.
- <u>Active re-opened cases and family law modification cases (Table 4-A)</u>. At the end of June 2023, there were 851 active re-opened cases and 552 active family law modification cases.



Resolution

A case is resolved if all issues in the complaint are fully adjudicated.

Suspended Case

Suspense Status

Trial

A hearing set before a judge or jury in which all the issues in the case are meant to be resolved. A trial normally includes opening statements to the court or jury stating what evidence will show, introduction of witnesses and exhibits for direct and cross examination, final arguments to the court or jury in which counsel argue both the evidence and the law, and judgment by the court or jury stating what the facts of the case are and what law applies to the facts. In a jury case, it also includes the selection of the jury. A trial can be held for one or more cases. A single trial may be held to adjudicate more than one case (as defined above).
