Summary

Filings:

In 2022, the total ITA filings were 5,665 cases, with an average filing of 472 cases per month in 2022.

In 2023, a total of 5,541 ITA cases were filed. Of the 5,541 ITA cases received in 2023, 82 ITA petitions were filed by families, and 668 were from other jurisdictions. The monthly average of filings in 2023 were 462 cases.

In 2024, 5,438 ITA cases were filed, averaging 453 cases per month.

In 2025, 5,602 ITA cases were filed, with a monthly average of 467 cases. This compares with the monthly average of 472, 462 and 453 cases filed in 2022, 2023 and 2024, respectively.

Resolutions:

In 2024, the court resolved 5,476 ITA cases, averaging 456 cases per month. In 2024, the resolution pace matched the filing volume.

In 2025, the court resolved 5,487 ITA cases, with a monthly average of 457 cases. This compares with the monthly average resolution of 493, 451 and 456 cases in 2022, 2023 and 2024, respectively. The resolution volume in 2025 was slightly lower the filing volume.

Pending:

The resolution pace in 2025 has fallen behind the filing pace. At the end of December 2025, there were 586 ITA cases pending resolution.

Orders:

The court enters a significant number of ITA orders every quarter. There were 4,650 and 4,532 ITA orders entered per quarter in 2021 and 2022, respectively. In 2023, an average of 4,260 ITA orders were entered per quarter. In 2024, the court issued a total of 17,967 ITA orders, with an average of 4,491 per quarter.

In 2025, the court signed 20,328 orders for ITA cases, averaging 5,082 orders per quarter and a larger volume than previous years. This compares with an average of 4,532, 4,260 and 4,491 ITA orders per quarter in 2022, 2023 and 2024, respectively.

Hearings:

The number of ITA hearings varies from quarter to quarter. In 2022, there were 255 ITA hearings per quarter on average. In 2023, the court held 287 ITA hearings per quarter on average. In 2024, there were 1,071 ITA hearings, averaging 267 hearings per quarter.

In 2025, the court had 1,103 ITA hearings, with an average of 276 hearings per quarter. This compares with an average of 255, 287 and 267 ITA hearings per quarter in 2022, 2023 and 2024, respectively.

Terminology

Filing

The number of petitions filed, initiating new ITA cases during the reporting period.

Resolution

The number of petitions (cases) resolved, either by “approval” or “dismissal” order during the reporting period.

An ITA case has been resolved when the Court enters a 14-Day, 90-Day, or 180-Day Order of Detention, Less Restrictive Alternative, or when the Court enters an Order of Dismissal.

Unlike the definition of “resolution” for other Superior Court case types, the “resolution” for these case categories may not indicate the end of judicial involvement when the petition is approved.

Pending Resolution

The number of active cases that have not been resolved, namely, the petition has neither been approved nor dismissed yet.

Completion

ITA cases are completed when a Notice of Release, Notice of Completion of Program, or an Order of Dismissal are filed. When an Order of Dismissal or Notice of Release is filed, and the case has not been resolved by a previous Order, the Order of Dismissal or Notice of Release will resolve and complete the case.

Pending Completion

Indicates the number of cases for which the petition has been approved, but issues (sometimes significant issues) remain in which the court may become actively involved.

Resolution Age

Is the time (days) from filing to resolution, less suspense time if applicable.

Pending Resolution Case Age

Indicates the time (days) from filing to the last day of the reporting period for these cases that remain unresolved (no approval or dismissal of the petition), less suspense time, if applicable.

Number of Petitions

The total number of petitions entered during the reporting period.

Number of Orders

The total number of orders entered during the reporting period.

Number of Hearings

The total number of hearings held other than fact-finding during the reporting period.
