Quarterly Report Summary

King County Superior Court

- **Criminal Cases.** The criminal filings in 2025 were 5,172 cases, at the same volume as in 2024. MRJC accounted for 40% of the criminal cases filed in 2025. The resolutions of criminal cases in the same period exceeded the filing pace, totaling 5,628 cases. At the end of December 2025, 3,849 criminal cases (excluding RALJ) remained active. Of the 3,849 pending criminal cases, 45% were the MRJC cases.
- **Civil Cases.** Filings in civil cases (case type 2) continued an upwards trend since the third quarter of 2023. The filings in case type 2 (general civil) in 2025 were significantly higher than that in 2024, showing a 14.5% increase from 2024 and totaling 28,469 cases. The increase in civil filings was primarily due to the rise in unlawful detainer cases and civil protection petitions. MRJC accounted for 39% of the civil cases filed in 2025. In 2025, the court resolved 26,956 cases in civil (case type 2). The overall civil resolutions were lower than the filing volume in the same period, resulting an increase in active civil pending caseload. At the end of December 2025, there were 10,598 civil cases pending disposition, with MRJC having 35% of the pending civil caseload.
- **Domestic Cases.** Domestic case (case type 3) filings in 2025 were almost identical to that in 2024, different by 49 cases only. A total of 6,582 domestic cases were filed in 2025, and 38% were filed in the MRJC. The number of resolutions of domestic cases matched with the filing volume in 2025. The court resolved 6,562 domestic cases in 2025. At the end of December 2025, the pending domestic caseload was 4,726 cases, with 39% being the MRJC cases.
- **ITA Cases.** The filings of ITA cases in 2025 remained at a high level, but seemed to have reached a plateau. In the past 6 years, the annual ITA filings were well over 5,000 cases. A total of 5,602 ITA cases were filed in 2025, the second highest volume in court's history. In 2025, the court resolved 5,485 ITA cases. There were 586 ITA cases remaining to be adjudicated at the end of December 2025.
- **Juvenile Dependency/Termination (DEP/TER) and At-risk Youth (ARY)/Child-in-Need of Service (CHINS) Cases.** In 2025, termination and truancy filings were lower than that in the same period of 2024. On the other hand, filings in both dependency and ARY/CHINS/others were up 8% from 2024. At the end of December 2025, the numbers of cases pending disposition in the non-Offense juvenile categories were: 336 dependency cases, 67 termination cases, 213 ARY/CHINS/Other cases, and 1,597 truancy cases.
- **Juvenile Offense Cases.** The juvenile offense filings in 2025 decreased by 12% from 2024, with a total of 827 juvenile offense cases filed in 2025. The court disposed 930 juvenile offense cases, exceeding the filing pace in the year. At the end of December 2025, there were 359 pending juvenile offense cases, a low volume.
- **Pro Tem Use.** In the four quarters of 2025, the daily Pro Tem use by the court was 3.4, 4.7, 3.4, and 4.1FTEs on average, respectively.
- **Post-resolution Modifications (Table 1-A).** In 2025, there were 549 post-resolution modifications filed (both parenting plan and relocation modifications).
- **Active re-opened cases and family law modification cases (Table 4-A).** At the end of December 2025, 1,022 re-opened cases and 472 family law modification cases remained active.

Total Judicial Cases Only ("Matters Filed with Clerk" excluded)

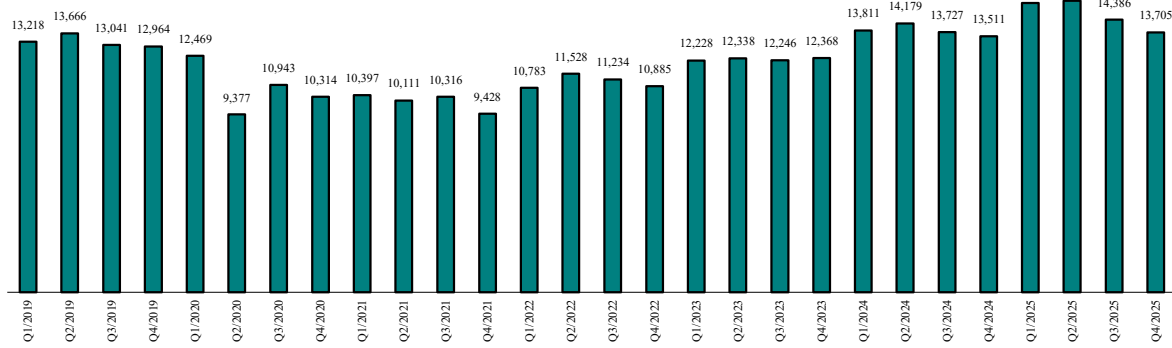


Chart 1-B. Quarterly Filings: Criminal and Juvenile Offense Cases

■ Criminal ■ Juvenile Offenses

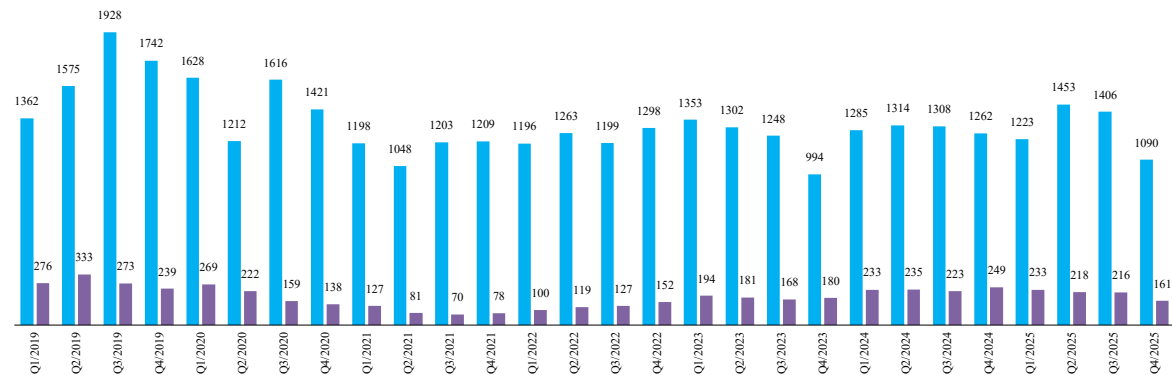
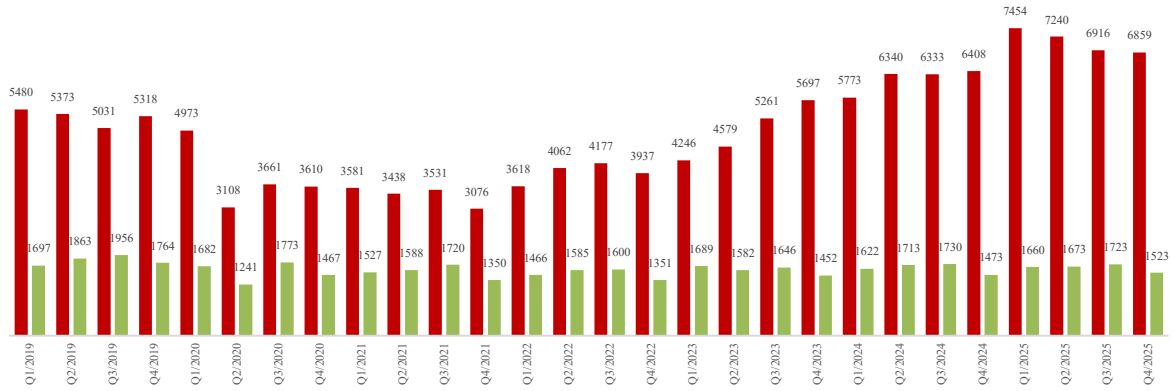


Chart 1-C. Quarterly Filings: Civil and Domestic Cases

Total Judicial Cases Only ("Matters Filed with Clerk" excluded)

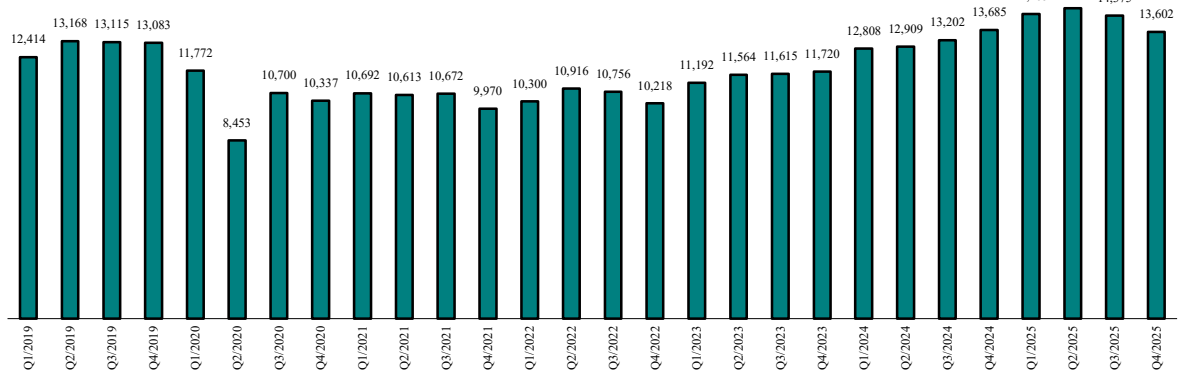


Chart 2-B. Quarterly Resolutions: Criminal and Juvenile Offense Cases

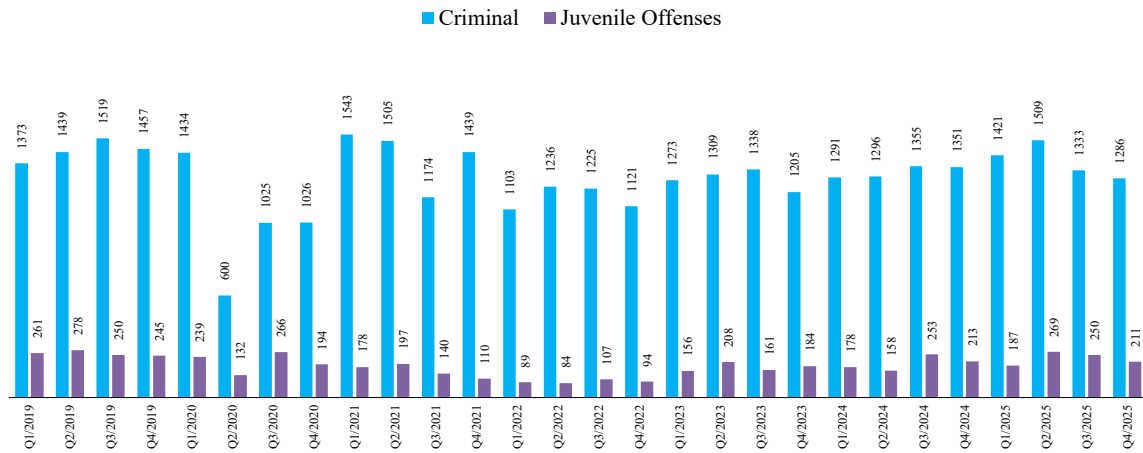
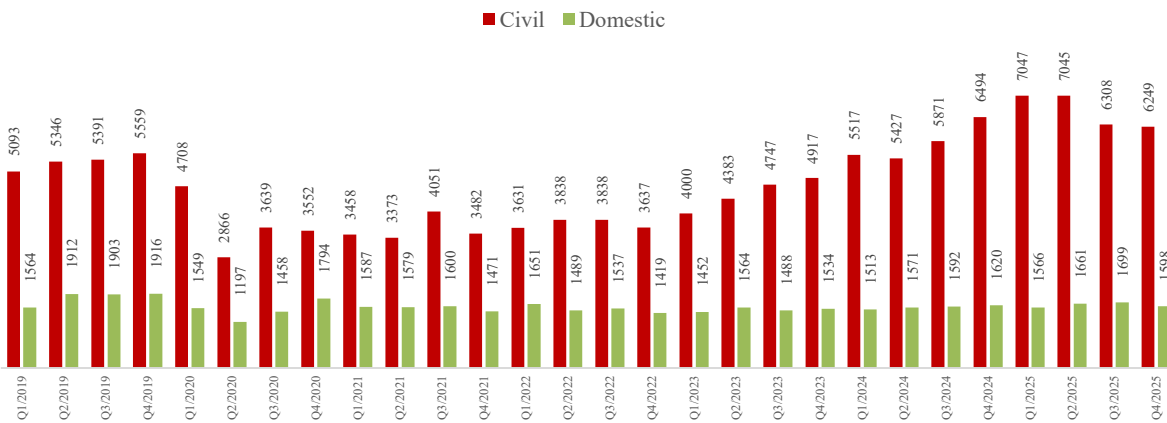


Chart 2-C. Quarterly Resolutions: Civil and Domestic Cases

Total Judicial Cases Only ("Matters Filed with Clerk" excluded)

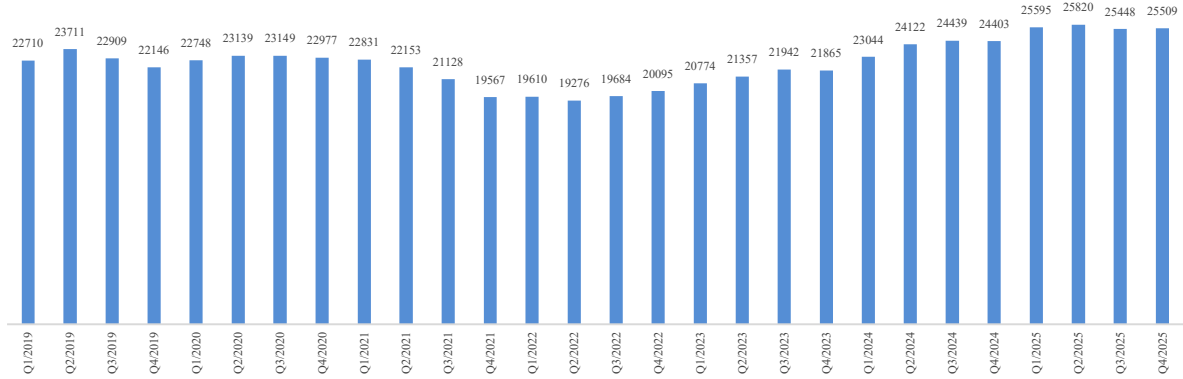


Chart 4-B. Pending Caseload at Quarter End: Criminal, Domestic, and Civil Cases

■ Criminal ■ Civil ■ Domestic

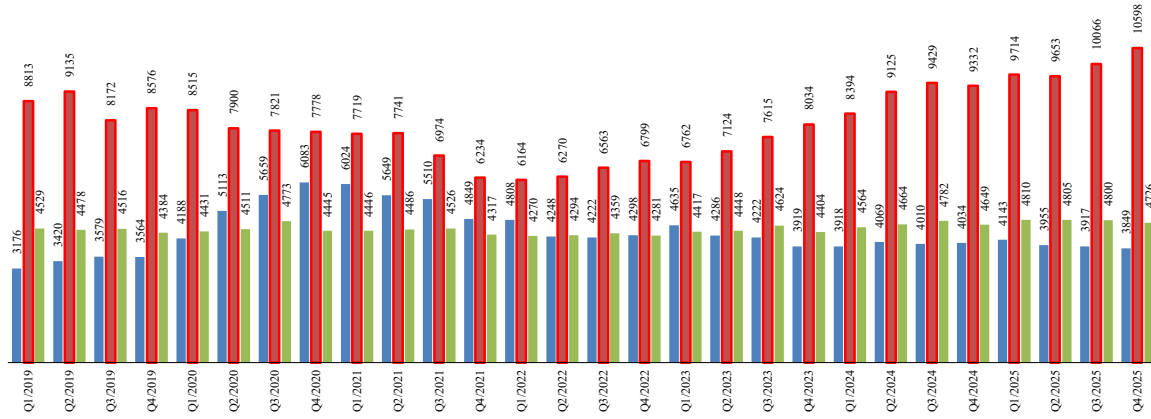
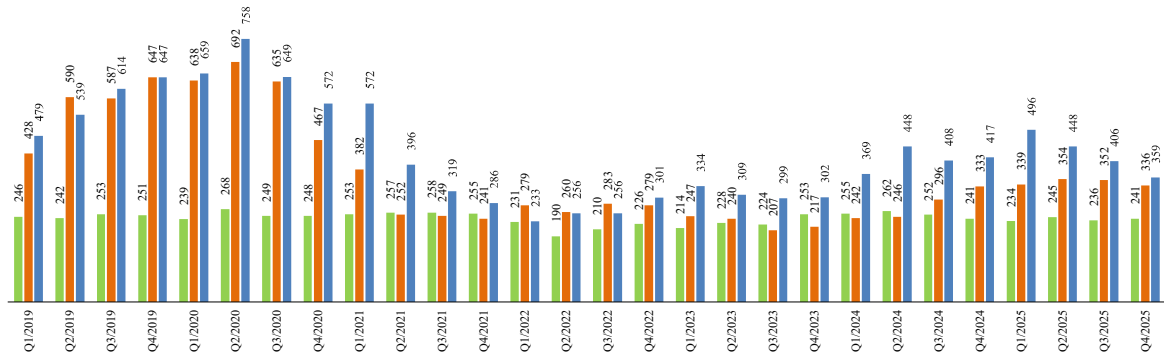


Chart 4-C. Pending Caseload at Quarter End:

Glossary and Definition

Active Status

A case is active if it is not on suspense status (see Suspense Status).

Completion

A case is completed if dispositive document is filed with the court following resolution.

Jury Trial

A hearing is reported as a jury trial if the jury is impaneled.

Non-Jury Trial

A hearing is reported as a non-jury trial if an opening statement is made, waived, or reserved.

Pending Case

A case is defined as pending if it is unresolved and active (not in suspense).

Post-disposition Modifications

Petition to modify parenting plan after the resolution of the original case, based on the modification schedule.

Resolution

A case is resolved if all issues in the complaint are fully adjudicated.

Suspended Case

A case is placed in suspense status from active status during the reporting period.

Suspense Status

A case is on suspense status if it is on warrant, appeal, stay, mediation, arbitration ("Deferred Prosecution" is not a suspense status, but is treated as a resolution).

Trial

A hearing set before a judge or jury in which all the issues in the case are meant to be resolved. A trial normally includes opening statements to the court or jury stating what evidence will show, introduction of witnesses and exhibits for direct and cross examination, final arguments to the court or jury in which counsel argue both the evidence and the law, and judgment by the court or jury stating what the facts of the case are and what law applies to the facts. In a jury case, it also includes the selection of the jury. A trial can be held for one or more cases. A single trial may be held to adjudicate more than one case (as defined above).
