Summary

- **Filings**

2023 annual filings. The filings in 2023 were: 319 dependency cases, 168 termination cases, 111 at-risk-youth and children-in-need of service cases, 1,560 truancy cases, and 351 others.

2024 annual filings. The filings in 2024 were: 430 dependency cases, 127 termination cases, 90 at-risk-youth and children-in-need of service cases, 1,571 truancy cases, and 609 others.

2025 YTD filings. The YTD filings in 2025 were: 360 dependency cases, 60 termination cases, 55 at-risk-youth and children-in-need of service cases, 1,057 truancy cases, and 573 others.

- **Resolutions (approval or dismissal of petitions)**

Resolution is defined as either the “approval” or the “dismissal” of the petition.

2023 annual resolutions. The resolutions in 2023 were: 319 dependency cases, 223 termination cases, 110 at-risk-youth and children-in-need of service cases, 887 truancy cases, and 323 others.

2024 annual resolutions. The resolutions in 2024 were: 255 dependency cases, 163 termination cases, 85 at-risk-youth and children-in-need of service cases, 1,390 truancy cases, and 517 others.

2025 YTD resolutions. The YTD resolutions in 2025 were: 319 dependency cases, 55 termination cases, 55 at-risk-youth and children-in-need of service cases, 1,327 truancy cases, and 556 others.

- **Pending Resolution**

At the end of September 2025, the pending resolution (petitions are neither approved nor dismissed yet) caseload was: 352 dependency cases, 82 termination cases, 43 at-risk-youth and child-in-need of service cases, 1,568 truancy cases, and 199 others.

- **Age of Pending Resolution Cases**

At the end of September 2025, there were cases older than 180 days since filing which remained as unresolved (still pending the approval or dismissal of the petitions): 169 dependency cases, 50 termination cases, 23 at-risk-youth and child-in-need of service cases, 1,082 truancy cases, and 76 other cases.

- **Number of Fact-findings (FF)**

2023 annual fact-findings. The number of fact-findings in 2023 were: 222 for dependency cases, 140 for termination cases, 75 for at-risk-youth and children-in-need of service cases, 39 for truancy cases, and 268 for others.

2024 annual fact-findings. The number of fact-findings in 2024 were: 198 for dependency cases, 64 for termination cases, 44 for at-risk-youth and children-in-need of service cases, 85 for truancy cases, and 456 for others.

2025 YTD fact-findings. The 2025 YTD numbers of fact-findings were: 273 for dependency cases, 35 for termination cases, 21 for at-risk-youth and children-in-need of service cases, 51 for truancy cases, and 508 for others.

- **Number of Hearings (non Fact-findings)**

2023 annual hearings. The number of non fact-finding hearings in 2023 were: 7,477 for dependency cases, 785 for termination cases, 173 for at-risk-youth and children-in-need of service cases, 302 for truancy cases, and 708 for others.

2024 annual hearings. The number of non fact-finding hearings in 2024 were: 7,952 for dependency cases, 450 for termination cases, 149 for at-risk-youth and children-in-need of service cases, 528 for truancy cases, and 622 for others.

2025 YTD hearings. The 2025 YTD numbers of non fact-finding hearings were: 5,828 for dependency cases, 277 for termination cases, 59 for at-risk-youth and children-in-need of service cases, 512 for truancy cases, and 4570 for others.

“Others” category includes the following case types: DDP - Developmental Disability; DGN - Dependency Guardianship; RVS - Relative Visitation; EFC - Extended Foster Care, Dependency; GFC - Guardianship Foster Children; RPR - Reinstatement of Parental rights; and VYG - Vulnerable Youth Guardianship.

Terminology

Filings

Number of petitions (cases) filed.

Resolutions

Number of petitions (cases) resolved, either by “approval” or “dismissal” of petitions. Unlike the definition of “resolution” for other Superior Court case types, the “resolution” for these case categories does not indicate the end of judicial involvement if the petition is approved.

Pending Resolution

Number of active cases that have not been resolved, namely the petition has neither been approved nor dismissed yet.

Resolved, Pending Completion

Number of cases for which the petition has been approved, but issues (sometime significant issues) still remain in which the court is actively involved.

Resolution Age

Time (days) from filing to resolution, less suspense time if applicable.

Pending Resolution Case Age

Time (days) from filing to the last day of the reporting period for these cases that still remain unresolved (no approval or dismiss yet), less suspense time, if applicable.

Pending Completion Case Age since the Approval of Petition

Time (days) from filing from the approval of the original petition (resolution) to the last day of the reporting period for those cases that still remain uncompleted (resolved, but with court activities), less suspense time, if applicable.

Number of Fact-findings (FF)

This is an estimate of actual fact-finding hearings held due to siblings belonging to one family unit having data entered on each case for the same fact-finding hearing proceeding.

Number of Hearings (non Fact-findings)

Number of all hearings other than fact-findings entered during the reporting period. The number of hearings is further divided into “pre-resolution” and “post-resolution” hearings depending on the time of the hearings in relation to the resolution date.
