Tallaabda 4-aad: Xaqiijinta Lacag-celinta

Haddii ay jirto lacag celin lagu samayn doono, lacag celinta waxaa lagu bixin doonaa jeeg ama kaarka Dhibitka midkood.
- Kiisaska oo dhan ma aha kuwo u qalma lacag-celinta lagu codsado habkan. Hoos waxaa ku qoran qaar ka mid ah xaaladaha caadiga ah iyo waxa aad ka heli doonto karraaniga.
 - Kiisaska aan lahayn xukun u qalma lacag-celinta - Karaanigu waxa uu kuu soo diri doonaa warqad tilmaamaysa in aanay jirin mid ka mid ah xukunnada kiisaska oo u qalma lacag-celin.
