



## I/I in the Regional Wastewater System

- Studies show 50-70% of I/I is from private side sewers
- As much as 3/4 of pipe capacity used up by I/I at peak flow






Planned Conveyance System Improvement Plan Projects



# Where has the Regional I/I Program been?

In 2015-2018, explored and evaluated I/I Program concepts to:

- Prevent or reduce future I/I
- Reduce existing I/I
- Reduce scope of future conveyance projects in the separated sewer portion of the regional wastewater system

## **Explore and Evaluate I/I Concepts**

- Reviewed existing sewer standards, inspection programs and private side sewer programs
- Reviewed national case studies and best practice
- Described and evaluated conceptual options
- Recommended conceptual options to move to further evaluation

## **Outcomes of Evaluation**

MWPAAC recommended concepts for further evaluation:

#### 1. Regional BMPs

Standardization of 3-5 regional BMPs spanning new construction, repair, rehabilitation, and/or demolition for use by local agencies.

#### 2. Inspector Training and Certification

Development and/or hosting of regional inspection training and a certification program on both new and existing construction inspections.

#### 3. Private Side Sewer Inspection Program with Financial Assistance

Development of private side sewer inspection program triggered by property transfer and/or potential other method along with a grant/loan program to mitigate financial burden on disadvantaged ratepayers.


