### 1. MWPAAC Chair's Report – Pam Carter

Chair Pam Carter called the meeting to order and welcomed members. Pam asked members to remember to mute themselves when not speaking and also noted that a request was made to have members turn off cameras.

Olivia Robinson, WTD Government Relations, took attendance by roll call. A quorum was in attendance.

A motion was made and seconded to approve the April MWPAAC meeting summary. The motion carried by voice vote.

Pam provided an update on the Regional Water Quality Committee (RWQC). The May 5 meeting included two briefings:

- Executive Recommended Sewer Rate and Capacity Charge which has now passed through committee with a do pass and now it's on consent with full Council.
- Clean Water Plan Resource Recovery and Wastewater Conveyance including I/I Actions.

The next RWQC meeting on June 2 will have the same agenda topics as we have today.

### 2. Wastewater Treatment Division Director's Report – Kamuron Gurol, Division Director, Wastewater Treatment Division (WTD)

Kamuron Gurol, WTD Division Director, thanked Mark Isaacson for his report last month. He thanked the MWPAAC Executive Board whom he met with last week to talk about his priorities. He shared this is week number four as WTD Director. He started the day after WTD had a bypass event at West Point.

Kamuron shared that over the last month he has toured some of WTD's facilities to get to know staff, understand operations and what WTD is responsible for. His priorities, from the Department and Natural Resources and Parks Director, Christie True, in the near-term include the sewer rate, asset management, rate structure and increase for 2022, and providing a smooth path going forward with annual increases. The work with MWPAAC on the rate is a great example of collaboration and this is a value he will continue moving forward in his job. The Clean Water Plan will set investments we make for decades to come. Kamuron shared he'll be joining the next Elected Officials' Workshop on June 11. WTD wants to make sure MWPAAC has ample opportunity to weigh in during the process. WTD will continue to provide briefings at MWPAAC, hold workshops and support any other way MWPAAC

wants to engage so that members have the information they need and can provide guidance. Kamuron reported that power quality issues at West Point are also a high priority. WTD is subject to a Washington State Department of Ecology administrative order to address the power quality issues. The King County Executive issued an emergency declaration to address the power quality issues. WTD will be implementing a battery-based system which is moving into design right now. The type of battery system being implemented will be very effective and will address the bypass events. WTD will also be doing outreach to the Magnolia district so they can learn about the system. WTD hopes to have schedule and cost estimates for MWPAAC in July. The last item he talked about was priority asset management. WTD really appreciates how MWPAAC has been invested in this topic. WTD is doing a lot of work with end of life equipment issues and will continue to engage MWPAAC going forward.

Chair Carter thanked Kamuron for his report and looks forward to seeing him at future meetings.
