Chair John McClellan welcomed MWPAAC members to the meeting.

Chair McClellan asked for a voice vote for approval of the August meeting summary. The minutes were approved as written.

Chair McClellan provided on update for the Sept. 7 RWQC meeting noting that meetings are now hybrid. The following briefing were provided:

- Overflows at Pump Stations and Other Wastewater Facilities: Causes and Responses
- Combined Sewer Overflows: CSO Background and Context, Georgetown Project, Budget Implications and Upcoming Projects


There will be no RWQC meeting in October as there are no committee meetings during budget.

Announcements:

Steve Hitch has been appointed as the chair for the Comprehensive Engineering and Planning Subcommittee (E&P) and will serve through the end of the year. In January, MWPAAC will hold elections for that position as well as the Vice Chair of MWPAAC.

Chair McClellan shared that Alderwood staff sits on the 811 board, if members have any questions or are interested in that, contact him for information.

WTD sent out a poll re: how members want to be informed about overflow events. To date, 12 member agencies have responded. It did close but will be reopened for a couple more weeks. There will be a discussion at an upcoming general meeting on the best approach to provide information to members who are interested.

2. Wastewater Treatment Division Director's Report – Kamuron Gurol, Division Director, Wastewater Treatment Division (WTD)

Kamuron Gurol, WTD Director reported on the Executive's Budget Proposal. It was presented and transmitted to Council on Sept. 27. The proposed budget includes the following WTD proposed items:

- 96 FTEs
- Initial work on Mouth of Duwamish (MOD) CSO Control Program
- West Point Power Quality Improvement Project

As for next steps, the Council will hold budget panels over the next couple weeks. The Budget and Fiscal Management Committee is expected to vote on the budget on November 8, with final Council action by November 15. Kamuron reported that WTD has already received a question from Council, and we expect questions to continue over the next week or two.

Kamuron provided an update on the status of the Clean Water Plan, which was put on pause about ten months ago. WTD has additional work to do, and it is also important to define a north star vision moving forward. Kamuron will be meeting with partners over the next few weeks to discuss how to move forward in the coming months. He will also continue to provide updates at MWPAAC.

Kamuron asked members to review the Cash Funding Issue Paper that was sent out last week via email in advance of the MWPAAC Rates & Finance Subcommittee meeting on October 6. We look forward to MWPAAC's feedback.

Kamuron provided an update on the Suquamish Settlement Agreement that was emailed to members last week. Kamuron reviewed the terms of the settlement agreement:


- The County will pay 2.5 million to the Tribe to establish a Tribal Mitigation Fund compensating for all Tribal impacts for the past five years and any future wastewater overflow/discharge events for an additional three years through December 31, 2024.
- The County also agrees to pay \$50k for any emergency bypass from West Point, regardless of volume, that occurs in 2025 or 2026.

West Point Infrastructure Projects

- Within 18 months the County will develop a plan for future replacement of all
 Uninterruptible Power Supply (UPS) assets and will replace 11 UPS assets within two years.
- The County will implement certain Voltage Sag Mitigation measures by December 31, 2024.
- Within 10 years from the Effective Date of the Settlement Agreement, the County agrees to replace the four existing raw sewage pumps.
- We agree strongly in the importance of these investments.

Supplemental Environmental Projects

• The County agrees to fund Supplemental Environmental Projects totaling \$2.4 million, which would be completed within five years.

Ben Marre, Seattle Public Utilities reported out on the Asset Management (AM) work group. He shared the purpose of the group is to seek to improve knowledge of and confidence in Wastewater Treatment Division's AM program through transparent sharing of information, seeking feedback from contract partners with expertise in AM, and soliciting input on what information should presented to MWPAAC on the topic before the upcoming sewer rate process. Ben reported the second and third meetings of the group have slipped a bit due to summer schedules. The next couple of meetings are scheduled for October 27 and November 7. Earlier we talked about bringing some AM content to MWPAAC General and E&P in October, so look for that.

Chad Merrill, Project Control Unit Manager presented an update on Economic Impacts on WTD's Capital Program. The full presentation can be found here. The presentation included information on:


