Chair John McClellan welcomed members to the meeting and provided an update on the June 5 RWQC meeting.


- MWPAAC's rate letter to the King County Council was shared and RWQC will also be writing a rate letter acknowledging MWPAAC's comments.

Chair McClellan provided a brief update on the MWPAAC Bylaws amendment specific to membership and appointments. The Executive Board is seeking to be more efficient in how members are being appointed. That section of the bylaws is currently being reviewed by the PAO and once that is completed, an update will be provided.

Wastewater Treatment Division Director's Report – Kamuron Gurol,
Division Director, Wastewater Treatment Division (WTD)

Kamuron Gurol, WTD Director, reported the 2025 Sewer Rate and Capacity Charge was approved by the County Council on June 12. Kamuron extended his thanks to MWPAAC members for their insightful questions throughout the process. He's looking forward to continued outreach in the coming year. He noted that he didn't hear objections to the 2025 rate but did hear a lot about concern over future rate increases. WTD is working on tools for extending and approving capital rate forecasting that should be useful in the coming years. He thanked MWPAAC members for engagement in that process.

Kamuron reported on a state funding opportunity. WTD's Georgetown Wet Weather Treatment Station (GWWTS) is set to receive \$200,076 in grant funding through the Climate Commitment Act (CCA) to install a large solar panel array. WTD hosted an event on June 17 at the GWWTS where Gov. Inslee highlighted the project and grant funding source.

Kamuron reported at 11 a.m. today, WTD, Seattle Public Utilities, the U.S. Environment Protection Agency, and the Washington State Department of Ecology will announce agreement has been reached to modify the federal consent decree (CD) for both King County and the City of Seattle. The County Executive will transmit the ordinance to the County Council. The CD modification will include larger projects, better coordination with Seattle, and an extension on the deadline. WTD will send out an email to MWPAAC with more details.



A: The numbers do not suggest the order of priority and may be changing to bullets or format in a table to remove the visual sense of the prioritization. WTD is looking at ways to edit and revise the guiding principles so they are not suggesting prioritization.
