HISTORIC PRESERVATION OFFICER'S REPORT: Meisner offered a brief report on the Renton downtown survey, reviewing the collaboration with the Renton Downtown Partnership, including recruiting volunteers from the RDP to help with fieldwork and research. Meisner noted that the interlocal agreement with Beaux Arts Village is moving forward. The BAV town clerk has forwarded the ordinance to Meisner for County Council scheduling. Meisner also reported on the upcoming Regional Preservation Workshop, with and interactive presentation by 4Culture on their Field Services, and a presentation on river changes in south King County.

PUBLIC COMMENT (*general*): Tom Hitzroth commented about his history as the Chair of the KCLC, noting that when he served they had too few Landmarks Commissioners seated.
