I am writing in support of the King County Department of Natural Resources and Parks – Parks Division’s (KCDNRPPD) application to the U.S. Department of Transportation’s Rebuilding American Infrastructure with Sustainability and Equity (RAISE) Discretionary Grants program. KCDNRPPD is seeking \$25,000,000 for the Closing the Eastrail Gap: I-90 Segment Project.

Transportation-related emissions are the largest contributor to air quality issues in King County. The Eastside has seen significant population and job growth in the last 10 years, resulting in the need for infrastructure investments that encourage mode shifts to incentivize non-motorized mobility. The Eastrail Multi-Use Trail will be an uninterrupted 42-mile north-south trail built on a historic railroad line that will connect communities on the east side of Lake Washington and provide new opportunities for non-motorized recreation and transportation. This regional trail is a key piece of the region’s efforts to manage growth while also addressing climate change by improving multi-modal options and connections as an alternative to single-occupancy car trips.

RAISE Grant funds will be used to close the final gap in the 26-mile, southern segment of the Eastrail regional trail. It will retrofit two existing bridges, including the large steel bridge spanning I-90, and build 1.7 miles of paved trail to link Bellevue and Renton. The project closes a critical gap in the shared-use Eastrail regional trail, by creating a safe, accessible connection across the I-90 highway from Coal Creek Parkway, Factoria, and Eastgate to the Wilburton neighborhood. Once complete the project will support transit-oriented development along the Eastrail in Bellevue (Spring District, Wilburton, Factoria, and Eastgate) and connect to transit stations, light rail, and the employment and retail hubs in Bellevue and Renton. Additionally, Eastrail will serve as a driver of recreation and tourism by its scenic location paralleling Lake Washington, connection to the Mountains to Sound Greenway Trail, and proximity to Mercer Slough Nature Preserve.

I write in support of an application submitted by King County's Department of Natural Resources and Parks Division for the Department of Transportation's *Rebuilding American Infrastructure with Sustainability and Equity Grant (RAISE) Discretionary Grant Program* for the Closing the Eastrail Gap: I-90 Segment Project.

King County is seeking RAISE grant funding to close the final gap in the 26-mile southern segment of the Eastrail regional trail. The 42-mile trail along the east side of Lake Washington runs from Renton to Snohomish, a rapidly growing area in the Pacific Northwest region. It is estimated that 2.3 million people will live within eight miles of the project by 2050. A critical gap in the shared-use Eastrail regional trail will be closed by retrofitting two existing bridges and building 1.7 miles of paved trail between Renton and Bellevue, completing a seamless link with the Mountain to Sound Greenway Trail. The gap requires users to navigate I-405, 118th Street, and I-90 on roadways without dedicated facilities. The I-90 Segment Project will improve multi-modal connections as an alternative to single-occupancy car trips, addressing climate change and transportation-related emissions, the largest contributor to air quality issues in King County.

Additionally, the completion of this project has wide-reaching implications for the surrounding areas. Most immediately, the nearby majority-minority communities of Factoria, Eastgate, and Wilburton will benefit directly from closing the Eastrail gap, all of which have seen significant population and job growth in the last 10 years. This has resulted in the need for additional infrastructure investments. The improvements to regional recreation and sustainability will have long-lasting positive impacts for these communities and others that are connected to the Eastrail regional trail.

We wish to pledge our strong support for King County's application to the U.S. Department of Transportation's Rebuilding *American Infrastructure with Sustainability and Equity (RAISE)* Grant Program for the Closing the Eastrail Gap Project. This project will close the final gap in the 26-mile southern segment of the Eastrail regional trail in Bellevue, WA.

According to the Puget Sound Regional Council (PSRC) King County's current population of 2.2 million is projected to grow by 38% in the next twenty-five years. The Puget Sound region has invested in a future that incentivizes transportation mode-shifts and contributes to our regional goals of reducing VMT, and greenhouse gas emissions, improving public health, and increasing safe, accessible transportation options for all King County residents.

The project will connect two majority-minority communities currently divided by sixteen lanes of highway by retrofitting the I-90 steel bridge, repurposing a wooden trestle bridge and constructing 1.7 miles of new, paved trail between Mercer Slough Nature Park to the north and Coal Creek Parkway to the south.

Once complete, this project will close a major gap in the 26-mile Eastrail and provide safe and accessible active transportation between fast-growing employment hubs, high-capacity transit, and one of Washington State's most important manufacturing areas. This trail segment will also create a seamless connection to the Mountains to Sound Greenway Trail and is a critical link in the expansive regional trail system.

The Eastrail is a partnership success story, with jurisdictions, non-profits, businesses, transit agencies, and utilities within King County investing \$265M over the last 15 years to acquire the corridor and construct existing trail segments over the broader corridor area. These investments have driven down our region's emissions by providing a safe and welcoming commuting alternative and countless recreational opportunities.

These investments exhibit a robust and reliable track record of local and regional financial support for Eastrail. The largest source of these funds, the 2020 – 2025 Parks, Recreation, Trail and Open Space Levy passed with 70% of the vote and provided \$50.5 million in funding toward Eastrail projects. The next Levy funding period – 2026 to 2031 coincides with the timing of construction for this segment. We will continue to work closely with our public and private partners to identify a combination of local, private and levy funds that would augment Federal grants.

Closing the Eastrail Gap will improve safety and quality of life in Puget Sound region by improving multi-modal connections that respond to climate change, meet the infrastructure demands for a growing and economically active region and provide greenspace, respite and recreation. We support the application from King County and thank you for your consideration of the numerous benefits King County's Closing the Eastrail Gap Project will provide Puget Sound residents.



Leafline Trails Coalition works to realize a 900-mile trails network – the Leafline Trails Network – that provides equitable access, improved health, enhanced mobility, economic benefits, and recreational opportunities to thriving communities across the central Puget Sound region. One of our main objectives is to build a resilient trails network that offers safe, reliable and healthy transportation options that connect to high-capacity transit. Today, this network is 56 percent complete, with 300 miles of the existing network located in King County.

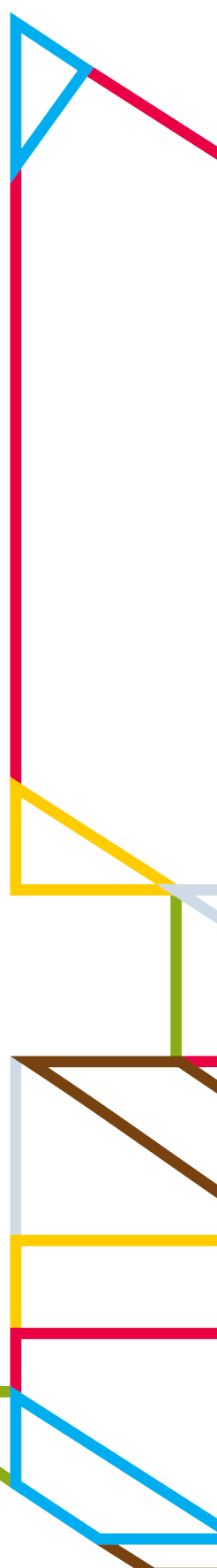


