- September 30, 2020 Deadline for property owners to complete encroachment removal
- December 2020 Advertise construction contract
- Spring 2021 Close trail and begin construction

Pre-Construction Activities:

- February 2020 Completed survey and installation of Parks boundary identification markers
- June 2020- Complete final survey updates for design
- May Sept.2020 Relocate existing utilities as needed
