NOTICE OF ISSUANCE AND AVAILABILITY FINAL ENVIRONMENTAL IMPACT STATEMENT FOR THE 2019 COMPREHENSIVE SOLID WASTE MANAGEMENT PLAN

Pursuant to WAC 197-11-460 and WAC 197-11-510 notice is hereby given that King County has issued a final Environmental Impact Statement (EIS) for the 2019 Comprehensive Solid Waste Management Plan.

Proponent/ Lead Agency: King County Department of Natural Resources and Parks, Solid Waste Division (the Division)

Issuance date: March 7, 2019

Project Description: Washington State law requires that each county, in cooperation with the cities located in the county, prepare a coordinated comprehensive solid waste management plan as outlined in RCW 70.95.080. Thirty seven cities in King County, all but the cities of Seattle and Milton, participate in the King County solid waste system.

The 2019 Comprehensive Solid Waste Management Plan (2019 Plan) presents strategies for managing King County's solid waste over the next 6 years, with consideration of the next 20 years is currently with the Metropolitan King County Council (Council) for adoption. The Plan includes policies, goals, and recommended actions for: the existing solid waste system, forecasting and data, sustainable materials management, the solid waste transfer and processing system, landfill management and solid waste disposal; and solid waste system finance. The 2019 Plan updates the Division's adopted 2001 Comprehensive Solid Waste Management Plan.

In accordance with the State Environmental Policy Act (SEPA), the final, non-project EIS evaluates the potential significant environmental impacts of the facilities, programs, and services described in the 2019 Comprehensive Solid Waste Management Plan; describes mitigation measures that can be used to avoid such impacts or reduce them below significant levels; and, where possible, draws conclusions about whether there may be any significant unavoidable adverse impacts of several project and program alternatives described in the 2019 Plan. Where choices among alternatives are presented, the beneficial impacts of the alternatives are described. The final EIS covers aspects of the built and natural environment including, but not limited to, the following areas: earth, air, water, plants, animals, energy, natural resources, environmental health, land use, transportation, public services, and utilities.

The level of detail of the analysis in this final EIS is consistent with the broad programmatic issues described in the 2019 Plan. Based on the analyses in the final EIS, as well as other relevant information and analyses in the 2019 Plan, King County and participating cities will select the facilities, programs, and services to be included in the regional solid waste management system. As actions are proposed to implement the final 2019 Plan, this final EIS will be used to the maximum extent possible to satisfy State Environmental Policy Act review requirements. Additional project-specific environmental review may still be needed on some projects.

The final EIS also includes the comments that were received on the draft EIS and responses to those comments.
