Notice 7: Sewer pipe rehabilitation is complete on the west side! Construction work is in progress on the east side of the Lake Hills Sewer Relining Project.

King County crews have completed relining the sewer pipe in the west section of Bellevue's Lake Hills neighborhood. Travelers along 120th Avenue Northeast and 124th Avenue Northeast will notice removal of diversion pipes and removal bike detours.

Here is what you will notice:

- Restored access to the pedestrian pathway along 120th Avenue Northeast. Bike detours and dismount bike signage are removed.
- Diversion pipes serving for temporary sewage services are removed.
- Restoration of excavated surfaces for burying temporary diversion pipes and landscaping works are in progress.
- Construction is in progress on the east section of the project on Bel-Red Road and north of Bel-Red Road on 130th Avenue Northeast, 132nd Avenue Northeast, and 134th Avenue Northeast.
- Intersection closed at Northeast Spring Boulevard and Bel-Red Road continuing through October 2023. Access to business on Northeast Spring Boulevard up to the closed intersection with Bel-Red Road is maintained via detour from the 136th Place Northeast.
- Vehicles are not allowed to cross through private parking lots from Bel-Red Road to access Northeast Spring Boulevard or vice versa.
- **Extension of eastbound closure** of Northeast Spring Boulevard, between 130th Avenue Northeast and 136th Place Northeast. No vehicle or bicycle access on the eastbound side through October 2023.
- Intersection closed at 134th Avenue Northeast and Northeast Spring Boulevard.
- Westbound Northeast Spring Boulevard will remain open to westbound vehicles and to pedestrians.

What to expect:

- Typical work hours are 7 a.m. to 7 p.m. weekdays with occasional night and weekend work.
- There will be noise and odor from the temporary pumping system and other construction activities.
- Sewer service will be maintained.

The <u>interactive construction map</u> shows active construction updates on the streets between 120th Avenue Northeast and Northeast Spring Boulevard as well as Bel-Red Road where temporary pipes, road and sidewalk closures, equipment staging, and other rehabilitation construction activities will occur for up to seven months.

We will continue to keep the community, nearby businesses, and impacted properties informed as construction progresses.
