# NORTH MERCER ISLAND/ENATAI Sewer Upgrade Project

July 14, 2022

## Expect construction crews and activity starting on 90th Place Southeast as early as July 18

### Background:

As early as July 18, King County crews will begin preparing 90th PL SE for construction as part of the North Mercer Island/Enatai Sewer Upgrade project. Before building a new sewer line, we will prepare the roadway for construction and relocate existing services like storm, sewer, and water to make space for the new sewer pipe.

Construction will include parking revisions, temporary driveway impacts, and service interruptions for everyone who lives or travels on this street.

Read below for more on the schedule and see the reverse for what to expect.

### Details:

- **Pre-construction activities starting as early as July 18:**
  - Crews will bring equipment/materials to the area and begin installing erosion control, removing signage, and relocating mailboxes as needed.
  - They will trim, install tree protection, and remove vegetation and trees in the public right-of-way.
  - They will also install no parking signs along 90th PL SE.
- **Storm drain installation and roadway widening starting as early as July 25:**
  - Crews will install new storm drains on the southside of the roadway and backfill roadway shoulders to expand the roadway for construction.
  - Some residences will experience a temporary driveway interruption as part of this work.
- **Water and sewer relocation starting as early as September:** This work depends on coordination with the City of Mercer Island. We will share more information about timing as the work gets closer.

## What to expect:

- All work will be performed in the public right-of-way.
    - **We will not access private property during this work unless we have a signed agreement.**
    - We know many residents have improved these areas with landscaping. In some areas, we will need to dig up trim or remove plantings in the right-of-way to make space for the construction. We will deliver a notice detailing what vegetation we will impact so neighbors can remove and replant it as needed.
  - Permitted work hours are 7 a.m. to 7 p.m. Monday to Friday and 9 a.m. to 6 p.m. on Saturday.
    - The work schedule is subject to change depending on weather and other factors.
  - **Some homes may be subject to temporary daytime driveway access interruptions**
    - If you need to enter or exit your driveway while crews work in front of your house, please contact the 24-hour construction hotline, 206-263-1915.
    - Crews will lay metal plates over excavations to restore access as needed. It may take crews up to 15 minutes to set up a safe surface for you to cross.
  - There will be one lane of alternating traffic around the work area.
    - Please drive slowly and pay attention to flaggers directing traffic.
  - There will be noise, dust, and vibrations typical of an active construction project.
  - Emergency vehicle access will be maintained during construction.
  - Services such as garbage, recycling, compost, and mail will not be interrupted.
