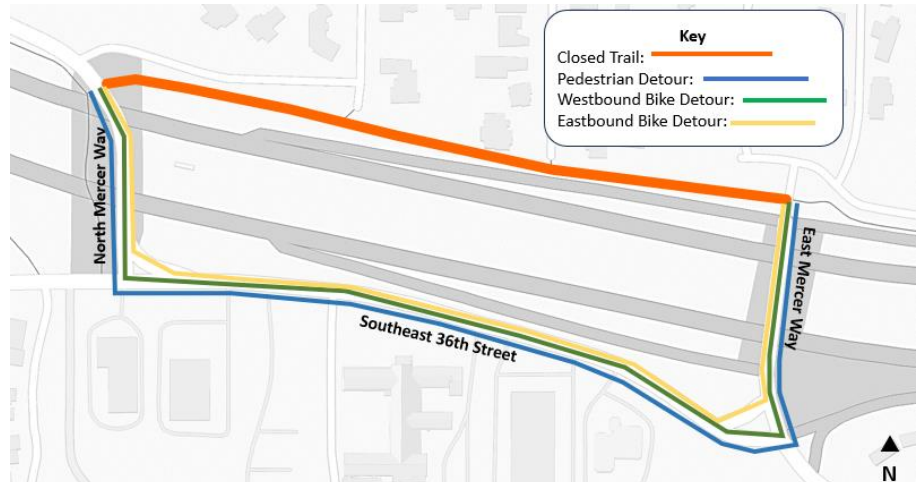
# NORTH MERCER ISLAND/ENATAI Sewer Upgrade Project

October 2023

## I-90 trail closing between North Mercer Way and Southeast 35th Place as early as October 23\*

Expect pedestrian and bike detours as early as October 23\*.

Crews will begin removing trees along the I-90 trail between North Mercer Way and 96th Ave S.E. as early as October 24\*. We are coordinating directly with the City of Mercer Island about tree protection, removal, and restoration. As a part of this project, we are planting 600 new trees across Mercer Island to replace the nearly 400 trees we are removing. Read our [Plan for Trees factsheet](#) to learn more.

This work will cause pedestrian and bike detours. As early as October 23\*, pedestrians and cyclists will be detoured around the work area via North Mercer Way, Southeast 35th Street and East Mercer Way. Please follow all posted signs and detour routes.

Following tree removal, crews will begin pipe installation along the trail as early as October 26\*.

### Do you live on Northeast Mercer Island near Southeast 35th Street or Southeast 35th Place? JOIN US FOR AN IN PERSON NEIGHBORHOOD CONVERSATION THIS FRIDAY:

Project staff and the contractor will meet at the **intersection of S.E. 35th St and 96th Avenue Southeast starting at 4:30pm on October 20**. During the meeting, we will share information about what to expect during upcoming construction activities.

We will meet rain or shine, so please dress for the weather and wear sturdy shoes for walking.

**What to expect:**

- Typical work hours are 7 a.m. to 7 p.m. Monday to Friday and 9 a.m. to 6 p.m. on Saturday for the duration of this work.\*
- The area surrounding trees will be restored after removal.
- Noise, dust, and vibrations typical of an active construction project.
- Intermittent/continuous noise and vibration during tree removal and stump grinding.
- We will detour people walking and biking on the I-90 trail around active work areas.
