



## NORTH MERCER ISLAND/ENATAI Sewer Upgrade Project

### 90th Place S.E. & 89th Place S.E. Community Conversation Event

#### Summary

**Date:** Thursday, May 2, 2024

**Time:** 3PM-4PM

**Location:** 90th Place S.E. & 89th Place S.E., Mercer Island, 98040

#### Event Purpose

Grinding and paving of the road at the bottom of 90th PI S.E. is planned for May 28 and 29. Paving activities are very impactful to neighbors since there is limited access to the cul-de-sac and the work includes driveway approaches. This neighborhood conversation allowed the project team to share information with neighbors about what to expect during the paving process.

#### Event Format

Project representatives and neighbors met at the intersection of 90th PI S.E. and 89th PI S.E. The group gathered to share information and questions.

#### Attendance

The North Mercer Island/Enatai Sewer Upgrade project team interacted with three community members from two households. The project team included representatives from King County construction management, King County community services, and King County's contractor (Walsh).

#### Summary of Discussion

Most of the conversation was between the project team and two neighbors. Both are property owners who live next to where paving will occur. They asked questions about access during upcoming work and driveway restoration plans.

One other neighbor stopped in during their walk and received a quick overview of the work to come.

#### FAQs:

##### Where will you be grinding and paving?

Crews will begin grinding and paving at the entrance of 89th PI S.E. before moving down the hill towards the bottom of 90th PI S.E. and Shorewood Drive.

##### Is the landscaping all done?

No, landscape restoration will happen after paving is complete.

### Will we be able to drive in and out of the area?

Access to homes on 90th Pl S.E. and 89th Pl S.E. will be limited during grinding and paving. When crews are grinding the roadway (usually one day before paving), residents may need to wait up to 10 minutes while driving through the paving area. Please drive carefully over rough pavement, follow instructions from crews, and plan for short delays.

Once crews begin paving, they cannot stop or allow cars to drive on the newly paved roadway. This means that during work hours, all driveways on 90th Pl S.E. and 89th Pl S.E. will be temporarily inaccessible. Flaggers will direct single-lane traffic through a section of Shorewood Drive near 90th Pl S.E. We expect paving to last one day.

During paving, crews are holding parking spots for neighbors along Shorewood Dr. Residents who will need to use their cars during working hours should move them by 7 a.m. Residents who live on 90th Pl S.E. between 89th Pl S.E. and Shorewood Dr will not be able to park in the street during paving. Please move your cars by 7 a.m. Crews will walk neighbors up and down the street to cars and homes during paving.
