




TB Case Count and Case Rate,1993-2024, King County, WA









Proportion of TB Cases by Gender, 2024, King County, WA




TB Case Rates per 100,000 by Sex, 2011-2024, King County, WA




Proportion of TB Cases by Age Group (Years), 2024, King County, WA




Reported TB Cases by Age Group (yrs), 2011-2024, King County, WA






TB Case Rates by Age Group (years), 2011-2024, King County, WA




TB Case Rates per 100,000 by Age Group (years) and Sex, 2024, King County, WA






Proportion of TB Cases by Country of Birth, 2024, King County, WA




Proportion of TB Cases by Region of Origin, 2024, King County, WA




Region of Origin Among Persons Reported with TB, 2011-2024, King County, WA






Proportion of US-born and Non-US-born TB Cases, 1993-2024, King County, WA




Proportion of TB Cases by Disease Site, 2024, King County, WA




Proportion of TB Cases by Disease Site 2011-2024, King County






HIV Coinfection by Age Among Persons Reported with TB, 2011-2024, King County, WA




Proportion of TB Cases by Occupation in Past Year, 2024, King County, WA




Proportion of TB Cases by Occupation in Past Year, 2011-2024, King County WA




Risk Factors Among Persons Reported with TB, 2024, King County, WA




Proportion of TB Cases Experiencing Homelessness in Past 12 months, 2024, King County, WA
