- **Municipal landfills**
\$408.00 + \$1.09/ton
- **Limited purpose landfill**
\$7,548.00 + \$204.00/hour for each hour over 37 hours, not to exceed 60 hours
- **Inert waste landfill**
\$8,772.00 + \$204.00/hour for each hour over 43 hours, not to exceed 60 hours
- **Compost (yard debris)**
\$23,664.00 + \$204.00/hour for each hour over 116 hours
- **Compost (other feedstocks)**
\$6,120.00 + \$204.00/hour for each hour over 30 hours, not to exceed 49.5 hours
- **Transfer stations**
\$7,548.00 + \$204.00/hour for each hour over 37 hours, not to exceed 52.5 hours
- **Permanent moderate risk waste facilities**
\$7,548.00 + \$204.00/hour for each hour over 37 hours, not to exceed 73.5 hours
- **Material recovery and recycling facilities**
\$9,996.00 + \$204.00/hour for each hour over 49 hours, not to exceed 63 hours
- **Energy recovery and incineration facilities**
\$6,120.00 + \$204.00/hour for each hour over 30 hours, not to exceed 42 hours
- **Closed landfills**
\$7,548.00 + \$204.00/hour for each hour over 37 hours, not to exceed not to exceed 48 hours

\$552.00 + \$30.00 per vehicle
- **Biomedical waste transporter**
\$1,632.00 + \$204.00/hour for each hour over 8 hours
- **Other solid waste facility**
\$2,662.00 + \$204.00/hour for each hour over 12 hours, not to exceed 18 hours
- **Treatment/storage piles (includes tire piles)**
\$3,672.00 + \$204.00/hour for each hour over 18 hours, not to exceed 27 hours
- **Surface impoundments and tanks**
\$5,304.00 + \$204.00/hour for each hour over 26 hours, not to exceed 33 hours
- **Permit application and plan review fees**
\$816.00 + \$204.00/hour for each hour over 4 hours
- **Special services - per hour**
\$204.00/hour
