BLS SUPPORT FOR SMALL AGENCIES FUND

The **BLS Support for Small Agencies Fund** helps smaller agencies with both KCIT support and modest one-time hardware/software purchases that are critical in the provision of EMS services.

- Criteria for Small Agency designation includes agencies whose Assessed Value (AV) is less than 1% of total AV for KC EMS Fund agencies (as indicated in the BLS allocation worksheet) and does not contract with larger EMS agency for services.
- Funding supports the procurement of equipment, hardware, software and connectivity solutions necessary for participation in the regional EMS system along with KCIT staff assistance with installing, implementing, configuring, and troubleshooting equipment and related connectivity.
- Agencies contact the EMS Division Administration Section requesting use of the funds; the EMS Division will respond to the agency to confirm the proposed usage meets the program's intent.
- KCIT staff purchases the equipment and provides support to the EMS agency if needed.
- Agency emails the required equipment transfer documentation to the EMS Division Administration Supervisor for processing.

Typical Characteristics of Small Agencies

- AV typically less than 1% of total KC EMS Fund agencies, currently less than \$5 billion
- Rural, Exurban
- Limited administrative and support staff
- May include a significant % of volunteer FF/EMTs
- Not considered a small agency if contracting with larger agency for services
