Access & Outreach Program

Build Systems: Work to achieve system-wide changes that reduce health disparities in King County. The **First Friday Forum (FFF)** brings together community-based organizations, health care Navigators, and our state partners to discuss important policy issues affecting residents of King County.

Ensure Access: We work to reduce barriers to health insurance and other public benefits. Public Health is the **Lead Navigator Organization** in King, Snohomish, and Jefferson counties under the Affordable Care Act (ACA). The King County Navigator network has 40 agencies, 390 navigators. We work directly with the most vulnerable living and working in King County. We provide infrastructure support, which includes training, coaching, and counseling.

Enroll the most vulnerable into program & service: We assist residents to enroll into the following programs: Apple Health, Classic Medicaid, Qualified Health Plans, Basic Food, Energy Assistance Programs, Orca LIFT, Breast Cervical Health Program, childcare assistance programs, and the ABCD Dental Program (Access to Baby and Child Dentistry).

Our team is multilingual and multicultural with experienced and knowledgeable Navigators, Health Educators, and Program Managers.

HEALTH INSURANCE OPTIONS

HEALTH INSURANCE EXPANSION – QUALIFIED HEALTH PLANS

Everyone who lives in Washington can buy health and dental insurance through Washington Healthplanfinder regardless of immigration status.

The cost of buying health insurance will depend on your household income, family size, and where you live. You may qualify for Cascade Care Savings, which means the state will pay for part of your health insurance if your income falls under the ranges below.



Look for the Cascade Care Logo to get more value at a lower cost.

There are three levels of health insurance plans available through Washington Healthplanfinder: Bronze, Silver, and Gold. The amount your health insurance company pays depends on which level you pick. The Bronze plan pays about 60%, the Silver plan pays about 70%, and the Gold plan pays about 80% of your medical bills.

Bronze	Silver	Gold
These plans cost less per month but pay for less of the cost when you need care.	These plans cover more of your costs when you need care but may cost more. If you qualify for Cascade Care Savings these plans may cost less than Bronze plans.	These plans cost more per month but pay more of the cost when you need care. If you qualify for Cascade Care Savings and have significant health care needs these plans may be a good fit.

Open enrollment starts November 1st through January 15th. Sign up by December 15 for coverage to start January 1st.

CHANGES FOR 2026

Qualified Health Plans

Marketplace eligibility ends for all lawfully present immigrants with incomes under 100% of the FPL on **January 1, 2026**. (<https://www.kff.org/policy-watch/potential-impacts-of-2025-budget-reconciliation-on-health-coverage-for-immigrant-families/>)

ACA Marketplace Coverage Eligibility for Lawfully Present Immigrants (effective January 1, 2027)

Only lawful permanent residents (LPRs or “green card” holders), Compact of Free Association (COFA) migrants residing in the U.S., or certain immigrants from Cuba are eligible for subsidized ACA Marketplace coverage. Refugees, asylees, and people with Temporary Protected Status are no longer eligible.

Apple Health/Medicaid

Elimination of Medicaid and CHIP eligibility for many lawfully present immigrants. Under current law, in addition to meeting other eligibility requirements, lawfully present immigrants must have a “qualified” immigration status to be eligible for Medicaid or CHIP. Qualified immigrants include lawful permanent residents (LPRs); refugees; individuals granted parole for at least one year; individuals granted asylum or related relief; certain abused spouses and children; certain victims of trafficking; Cuban and Haitian entrants; and citizens of the Freely Associated States (COFA migrants) residing in states and territories. In addition, many lawfully present immigrants must wait five years after obtaining qualified status before they may enroll in Medicaid; states may waive the five-year wait for children and pregnant individuals.

A provision in the final version of the bill that was signed into law will restrict the definition of qualified immigrants for purposes of Medicaid or CHIP eligibility to LPRs, Cuban and Haitian entrants, citizens of the Freely Associated States (COFA migrants) lawfully residing in the US, and lawfully residing children and pregnant adults in states that cover them; thereby eliminating Medicaid eligibility for many lawfully present immigrants.

This provision will become effective October 1, 2026.

APPLE HEALTH EXPANSION

Apple Health Expansion is a new program designed to provide full-scope health care coverage to people age 19 or older who do not qualify for other Apple Health programs based on their immigration status.

Due to program funding, the number of people who can enroll in Apple Health Expansion is limited. This will ensure clients receive the highest value care possible. The enrollment cap has been met. You can still complete an application to be considered if a space opens. Selection is done randomly.

Eligibility:

- Must intend to reside in Washington.
- Must be age 19 or older.
- Must meet income guidelines.
- Not qualify for other Apple Health (Medicaid) programs based on immigration status,
 - Immigrants who have not met the five-year waiting period to become eligible for Apple Health are not eligible for Apple Health Expansion.
- Are not eligible for qualified health plans with advanced premium tax credits or federally funded medical programs.

CHILDREN'S MEDICAL

Children up to age 18 may be eligible for the free or low-cost Apple Health for Kids regardless of their legal status. Children can also access dental, vision, and many other services when enrolled in Apple Health.

Eligibility:

- Must intend to reside in Washington.
- Must meet income guidelines.
- Immigration Status is not a factor.

PREGNANCY MEDICAL

If you are pregnant, you may be eligible for Apple Health for Pregnant Women. Full medical coverage is throughout delivery.

Eligibility:

- Must intend to reside in Washington.
- Must meet income guidelines.
- Immigration status is not a factor.

Women found eligible for Pregnancy Medical can also receive Maternity Support Services (MSS) and Infant Case Management (ICM) (this is in conjunction with WIC).

These programs help pregnant women find local doctors, midwives, and other community resources to support a healthy pregnancy. The ICM program provides support and referral to needed medical, social, educational, and other resources in the community.

Women, Infants & Children Nutrition Program (WIC)

WIC is a supplemental food program for women who are pregnant or breastfeeding, infants, and children. WIC also provides health screening, nutrition and health education, breastfeeding promotion and support, and monthly monetary benefits for nutritious foods.

AFTER-PREGNANCY MEDICAL

After-Pregnancy Medical is comprehensive Apple Health (Medicaid) coverage for individuals to access health care services any time in the 12 months after their pregnancy ends.

Eligibility:

- Have been pregnant within the last 12 months.
- Must reside in Washington.
- Must meet income guidelines.
- Not be eligible for a different Apple Health program.
- Immigration status is not a factor.

ALIEN EMERGENCY MEDICAL (AEM)

AEM is a program for individuals who do not meet citizenship or immigration status requirements. It can also be for qualified individuals who have not met the 5-year bar and have a qualifying medical emergency. This program will pay for treatment related to the emergent medical condition only. It does not provide coverage for routine medical services.

Eligibility

You must have an emergent medical condition and meet income requirement.

Emergent Medical Condition:

Qualifying emergent medical conditions include:

- ✓ Emergency room care
- ✓ Hospital admission or outpatient hospital surgery
- ✓ Cancer treatment plan
- ✓ Dialysis treatment
- ✓ Anti-rejection medication for an organ transplant

FAMILY PLANNING ONLY

Family Planning Only provides coverage for a variety of family planning services to both men and women to prevent unintended pregnancies.

Eligibility:

- Must intend to reside in Washington.
- Must meet income requirements.
- Must be either:
 - Uninsured and not eligible for Apple Health (Medicaid).
 - Insured and seek confidential services. Only applies to the following:
 - Teens 18 years and younger.
 - Victims of domestic violence.

What's covered?

- ✓ One comprehensive preventive family planning visits every year (365 days) and any necessary family planning-related follow-up visits.
- ✓ Counseling, education, and/or risk reduction.
- ✓ Education and supplies for Food and Drug Administration (FDA) approved contraceptives, natural family planning, and/or abstinence.
- ✓ Permanent methods such as tubal ligations (tubes tied), hysteroscopic sterilization, or vasectomy.
- ✓ When appropriate, pregnancy testing and cervical cancer screening.
- ✓ Sexually transmitted infection screening, testing, and treatment, when clinically appropriate, according to nationally recognized guidelines, or medically necessary for safe and effective use of the client's chosen contraceptive method.
- ✓ Human papillomavirus (HPV) and Hepatitis B vaccinations.

BREAST, CERVICAL, AND COLON HEALTH PROGRAM (BCCHP)

BCCHP helps eligible clients get screened for cancer and access treatment. If you or your family have a personal history of cancer, please talk to your medical provider.

Breast Cancer Screening: It's recommended that women should be screening at ages 40-64. Men, transmen, and transwomen should discuss personal risk with a medical provider and get screened accordingly.

Cervical Cancer Screening: For women 21-29, a Pap test is recommended every 3 years. Women ages 30-64 should be tested for Human Papillomavirus (HPV) every 5 years, or a Pap test alone every 3 years. Transmen should discuss personal risk with a medical provider.

Eligibility:

- Must be uninsured or underinsured.
- Must meet age requirement.
- Not eligible for WA Apple Health (Medicaid).
- Choose not to enroll in a qualified health plan or missed open enrollment.
- Have a high deductible for breast/cervical diagnostics > \$500.
- Must meet income requirements.

HOSPITAL CHARITY CARE

Washington state laws require hospitals to provide residents with certain types of care for free or at a lower cost if they cannot afford to pay for medical treatment. Charity Care covers “medically necessary” treatment. This includes inpatient hospital stays and emergency room visits.

****What if you never applied for Charity Care and your hospital bill went and now a collection agency is calling me?** A collection agency may not report medical debt to a credit bureau for at least 180 days from the date the collection agency received the debt. You should immediately apply for Charity Care and contact the collection agency. The agency must stop all collections activity until the hospital processes your application.

DEFERRED ACTION FOR CHILDHOOD ARRIVALS (DACA)

What is DACA?

DACA is a program that protects undocumented immigrants who came to the United States as children under circumstances beyond their control from deportation. On June 15, 2012, the Secretary of Homeland Security announced that people who meet these criteria and meet several other guidelines may request consideration of deferred action for a period of two years, subject to renewal. If approved for DACA you are eligible for a work permit. Deferred action does not provide lawful status. **U.S. Citizenship and Immigration Services (USCIS) is currently not taking new applications. **

DACA Health Insurance Options

While residents who are approved for DACA have the right to work and avoid deportation, they do not have a lawful immigration status. Therefore, you're not eligible for most medical programs. **You can apply for:**

- ✓ Qualified Health Plans
- ✓ Apple Health for Kids (up to age 19)
- ✓ Apple Health Pregnancy Medical
- ✓ Alien Emergency Medical (AEM)
- ✓ Prescription Assistance Program
- ✓ Family Planning Only
- ✓ Hospital Charity Care
- ✓ Breast Cervical Colon Health Program (BCCHP)
- ✓ Dental Care at our Public Health Centers
- ✓ Each program is included in this resource guide.

DENTAL CARE

ACCESSING DENTAL SERVICES

ACCESS TO BABY AND CHILDREN DENTISTRY (ABCD) PROGRAM

Access to Baby and Child Dentistry (ABCD) is a system of care in King County that connects Apple Health (Medicaid) with specially trained dentists in their communities. It's important that young children get care early, as a child with dental disease may have oral health problems throughout life. Cavities can be painful and interfere with a child's ability to focus and learn in school, eat, speak, and even play. Yet, cavities are almost entirely preventable, and prevention saves money for everyone.

Why ABCD? Making sure that your children have healthy teeth and mouths for a lifetime begins early. Baby teeth help children chew food and speak clearly. They shape children's faces and guide adult teeth into place. Cavities in baby teeth can cause pain and affect a child's ability to sleep, learn and pay attention.

Eligibility:

- Any Apple Health (Medicaid) eligible child from birth through age 5 years old are automatically enrolled.
- Any child enrolled in the Developmental Disabilities Administration (DDA) home and community-based waiver services between ages 6 -12 years old.

Program Benefits:

- ✓ Increased access to dental care throughout King County
- ✓ Increased number of dental services (i.e., 3 fluoride varnish applications per year, 2 Family Oral Hygiene Instruction consultations per year, etc.)
- ✓ Assistance in finding a dentist that will fit your needs and language preferences
- ✓ Assistance in coordinating transportation to and from the dental office
- ✓ Assistance in coordinating interpreter services for the dental visit

BASIC FOOD PROGRAM (EBT/SNAP)

The Basic Food Program (SNAP, EBT, or Food Stamps) helps families buy more food for their families. Once you have been approved you will receive an Electronic Benefit Transfer card (EBT) that will allow you to buy fresh fruit, vegetables, meat and much more at participating stores.

Eligibility is based on monthly income and family size. Legally admitted immigrants who meet specific program rules may be eligible for food benefits.

WOMEN, INFANT AND CHILDREN (WIC) SUPPLEMENTAL NUTRITION PROGRAM

WIC is a supplemental food program for women who are pregnant or breastfeeding, infants, and children. Pregnant women, new moms & children under five can get healthy food and lots more through this program.

Eligibility:

- You live in Washington State, and have medical or nutrition needs
- Dad, grandparents, and other caregivers of children under the age of five may also sign kids up for WIC. Foster children under age five and foster teens who are pregnant are eligible for WIC.

GET BACK ON THE ROAD

The Department of Licensing (DOL) can no longer suspend driver's licenses because a driver failed to pay non-criminal traffic tickets and/or failed to appear at a related hearing.

Suspended licenses will be reinstated, which means licenses will no longer be suspended. DOL is not allowed to automatically suspend a driver's license for unpaid traffic tickets until January 2023. If your license is expired, you must renew it. This may include taking the written and driving test.

Your license will not be suspended for unpaid non-criminal moving violations like speeding tickets. DOL can still suspend your license for criminal traffic violations like Driving Under the Influence (DUI) or reckless driving.
