Goals for Strategic Planning Discussions

- 1. Begin strategic planning for the 2025-2027 HRSA 330h Health Center funding cycle.
- 2. Discuss the current state of the Community from the perspective of the Community Advisory Group.
- 3. Discuss the current state of the Health Care for the Homeless Network (HCHN) program, including COVID homelessness response efforts and other emerging issues.
- 4. Identify strategic priorities to inform our next RFP/SAC and other areas for resource development/advocacy.

Background and Purpose

HCHN receives funding through HRSA's Bureau of Primary Health Care (BPHC), under the Health Center Program, as authorized by Section 330 of the Public Health Service (PHS) Act, specifically a special populations pot of grant dollars reserved for persons experiencing or at risk for homelessness (**330h**).

The purpose of this program is to improve the health of underserved communities and populations by assuring continued access to comprehensive, culturally competent, high-quality health care services, which includes medical, dental, behavioral health (mental health, substance use disorder), and enabling services.

The Governance Council (GC) is the community-based co-applicant board mandated by HRSA's BPHC to oversee the program. Public Health, as a "public entity grantee," reserves certain general authorities over the status of the health center, fiscal, and personnel matters.
