CALL TO ORDER

1. Welcome & Introductions
Maria Arns welcomed attendees, including members of the CAG, to the meeting of the HCHN Governance Council (GC). Full quorum present.

2. Minutes

GC members reviewed the minutes from the 6/17 meeting. Jeff Sakuma made motion to approve the minutes, Maria Arns seconded; vote was unanimous in favor of the motion, with Debbie Adams abstaining.

PUBLIC COMMENT

Harold Odom made a public comment highlighting the significant increase in people experiencing homelessness in King County despite commitments to equity and racial justice. He suggested that King County change practices in hiring consultants, provide more training/support for frontline workers, and focus on efforts that address the root causes of homelessness.

Denise Hawthorne expressed appreciation for Harold's comments. She shared how HCHN prioritizes trauma-informed care and the ways equity is centered in procurement processes, but acknowledged the limited resources available.

RACIAL EQUITY MOMENTS

Amanda shared experiences at a recent conference, where she met with an attendee from Togo and discussed the importance of empowering women.

PRIORITY ITEMS

1. 330h Project Director Annual Review

Vazaskia Crockrell, Community Health Services Division Director, met with the GC to share her formal evaluation of Semone Andu, as the 330h Project Director, and solicited feedback from members.

Kristina Sawyckyj made motion to approve 330h Project Director Semone Andu's performance evaluation, Maria seconded; vote was unanimous in favor of the motion.

2. Preview – 2025-2027 HRSA Service Area Competition & Budget

Denise and Bahareh Zebarjad, HCHN Finance Manager, joined to preview HCHN's submission and proposed budget for HRSA's 2025-2027 Service Area Competition (SAC); the 330h grant which provides Public Health's FQHC status. PowerPoint is attached.

Denise added that the GC will formally vote on the SAC, and the other HRSA grant applications that Jessica highlighted in the 6/17 meeting, at the August GC.

3. GC Membership/Vacancies

Rekha said the GC is reviewing the membership slate at this meeting, in preparation to vote in August. She shared information on current nominees, including the new community health center (CHC) representative, and noted that there will be more discussions to come on the voting process.

 - a. Behavioral Health Workgroup 8/13 There were no updates.

b. Community Advisory Group – 8/7

Kristina said the CAG worked on developing guiding principles for presenters in advance of joining meetings. She said they also discussed opportunities to join the GC, and the current state of the CAG-specific budget. She added that Harold will facilitate a discussion on gun violence prevention at the next meeting.

c. Executive Committee – 8/14

Kristina said that attendees discussed the GC agenda and membership. Maria added that they also discussed the name change of the GC Racial Equity Workgroup to "DEI & Racial Justice" and its' focus on shelter access for people using durable medical equipment.

GC attendees discussed inclusivity and the meaning of DEI.

d. DEI & Racial Justice Workgroup – 7/23

There were no updates.

2. HCHN Admin Update

a. Refugee/Immigrant Work Updates

Rekha said that HCHN is continuing to provide supports to the encampments at Riverton, Kent, and Burien and discussing sustainability models. Someireh asked if there were any opportunities HCHN could pursue with the \$32 million dollar aid for asylum seekers passed by the state legislature. Denise said that funding will be allocate more towards housing.

- b. Communicable Disease Updates
 - i. COVID

There were no updates.

c. Other Updates

Rekha added that there were no new budget updates but highlighted the partnership King County is pursuing with Harborview Medical Center/UW Medicine to identify ways to maintain existing services at Public Health clinics. She shared there will be more information to come in the fall, as negotiations are ongoing.

She also said that HCHN is initiating conversations with the contractors awarded through HCHN's recent RFP process. Attendees discussed the new contractors, and the process to close out with the other two agencies that will not continue with HCHN in 2025.

3. Open Forum

There were no other updates.
