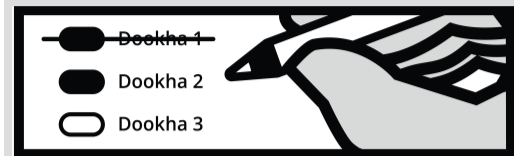

Duqa Magaalada iyo Golaha Magaalada ee Seattle ayaa ansixiyay Xeerka 127053, ee khuseeya beddelaadda maalgelinta loogu talagalay dayactirka gaadiidka ee magaalada oo dhan iyo horumarinnada.

Haddii la ansixiyo, soo jeedintaan waxay beddeli doontaa canshuur wakhtigeedu dhammaanayso si loo maalgeliyo mashaariicda badqabka iyo marin u helitaanka, sida: laamiga, dayactirka geesaha waddada iyo buundada, iyo casriyaynta kaabayaasha; horumarinnada gaadiidka; hagaajinta isku xirka tareenka fudud; geesaha waddada oo cusub; iyo dhimmista wasakhda.

Waxay oggolaanaysaa canshuur kordhin siddeed-sanno ah oo ururinta laga bilaabi doono sannadka 2025 oo ah qiyaas ahaan \$0.65/\$1,000 ee qiimeynta la qiimeeyay, ilaa iyo ugu badnaan \$2.71/\$1,000. Xaddidaadaha canshuurta ee 2026-2032 waxa lagu xisaabin doonaa iyadoo la isticmaalaayo caddadka canshuurta caadiga ah ee 2025. Ka dhaafitaanka RCW 84.36.381 ee dadka muwaadiniinta waayeellada iyo naafada ayaa khuseeya.
