Voter registration information

Requirements

To register to vote in Washington, you must be:

- · A citizen of the United States
- A legal resident of Washington state
- At least 18 years old by election day
- If you are 16 or 17, you can sign up as a Future Voter and be automatically registered to vote when you qualify
- · Not disqualified from voting due to a court order
- Not currently serving a sentence of total confinement under the jurisdiction of the Department of Corrections for a Washington felony conviction
- Not currently incarcerated for a federal or out-of-state felony conviction

How to register

Online

You can register or update your registration online at VoteWA.gov. Make sure you register online by the April 14 deadline for the April 22 Special Election.

By mail

Download and print a registration form from kce.wiki/VoterReg to register or update your registration and mail it to our office by the April 14 deadline for the April 22 Special Election.

In person

You can register in person through April 22, Election Day, at a vote center. For more information on locations and hours of vote centers, visit www.kingcounty.gov/elections.

Keep your voter registration current

Update your registration if you have moved or changed your name, or if your signature has changed. Simply update your information online or submit a new registration form by April 14 for the Special Election or visit us in person through April 22, Election Day, at one of the vote centers listed on the King County Elections website.

Ballot information

On Tuesday, April 22, 2025 in King County, Washington, a Special Election conducted entirely by mail will be held.

Replacement ballot

Call King County Elections to obtain a replacement ballot if your original ballot packet is lost, spoiled, or destroyed.
