#### RCW 29A.08.112 Voters without traditional residential addresses.

- (1) No person registering to vote, who meets all the qualifications of a registered voter in the state of Washington, shall be disqualified because he or she lacks a traditional residential address. A voter who lacks a traditional residential address will be registered and assigned to a precinct based on the location provided.
- (2) For the purposes of this section, a voter who resides in a shelter, park, motor home, marina, unmarked home, or other identifiable location that the voter deems to be his or her residence lacks a traditional address. A voter who registers under this section must provide a valid mailing address, and must still meet the requirement in Article VI, section 1 of the state Constitution that he or she live in the area for at least thirty days before the election.
- (3) A nontraditional residential address may be used when a voter resides on an Indian reservation or on Indian lands.
- (4) A federally recognized tribe may designate one or more tribal government buildings to serve as a residential address or mailing address or both for voters living on an Indian reservation or on Indian lands. However, a voter may not use a tribally designated building as the voter's residential address if the building is in a different precinct than where the voter lives.
- (5) A person who has a traditional residential address and does not reside on an Indian reservation or on Indian lands must use that address for voter registration purposes and is not eligible to register under this section.

#### RCW 29A.04.151 Residence.

"Residence" for the purpose of registering and voting means a person's permanent address where he or she physically resides and maintains his or her abode. However, no person gains residence by reason of his or her presence or loses his or her residence by reason of his or her absence:

- (1) While employed in the civil or military service of the state or of the United States;
- (2) While engaged in the navigation of the waters of this state or the United States or the high seas;
  - (3) While a student at any institution of learning;
  - (4) While confined in any public prison.

Absence from the state on business shall not affect the question of residence of any person unless the right to vote has been claimed or exercised elsewhere.

#### Washington Constitution. Article VI. Section 4: Residence, Contingencies Affecting.

For the purpose of voting and eligibility to office no person shall be deemed to have gained a residence by reason of his presence or lost it by reason of his absence, while in the civil or military service of the state or of the United States, nor while a student at any institution of learning, nor while kept at public expense at any poor-house or other asylum, nor while confined in public prison, nor while engaged in the navigation of the waters of this state or of the United States, or of the high seas.

#### DECLARATION OF DEPUTY PROSECUTING ATTORNEY

I, Lindsey Grieve, am a senior deputy prosecuting attorney with the King County Prosecuting Attorney's Office. I am assigned to handle voter registration challenges on behalf of the Prosecuting Attorney.

- 1. On April 4, 2024, I was notified by Washington State Deputy Solicitor General Karl Smith that he had corresponded via email with Washington resident, Nancy Gleason. In their correspondence, a copy of which is enclosed, upon being informed by Mr. Smith that she could not use here P.O. Box as a voter registration address, Ms. Gleason stated that she provided "a different King County property address" as her voter registration address. Mr. Smith explained that state law requires that she vote at her how residential address, to which Ms. Gleason responded, "I have always followed the law but not now." Mr. Smith encouraged Ms. Gleason to provide King County with her correct residential address, as is required by state law.
- 2. Attorneys and staff of the King County Prosecuting Attorney's Office ("Prosecuting Attorney Staff") and at my direction, staff of the King County Elections Department ("Elections"), have exercised due diligence to verify that Ms. Gleason does not reside at the above address listed in her voter registration record. The following steps were taken to contact the challenged voter and to learn her actual residential addresses.
- 3. Elections staff conducted research into Ms. Gleason's residence and determined that Ms. Gleason listed her address as 1501 Tacoma Ave S, #415, Tacoma, WA with the Department of Licensing and that an online directory, Cyberbackgroundchecks.com, listed that same address as her current residence. Ms. Gleason's mailing address for voting purposes is P.O. Box 98568, Des Moines, WA.
- 4. Elections staff sent two letters to Ms. Gleason. The first letter was sent on or around April 25, 2024 to Ms. Gleason's mailing address of P.O. Box 98568, Des Moines, WA 98198. The second letter was sent on or about May 17, 2024 to both Ms. Gleason's mailing address and her voter registration address of 20400 SE Pipe Line Rd, Renton, WA 98058. Both letters, explained the legal requirements for voter registration and asked Ms. Gleason to correct her registration. Copies of the letters are enclosed.
- 5. At my direction, Elections staff sent a letter from the Prosecutor's Office by mail, return receipt requested, to all three addresses associated with Ms. Gleason, including 1501 Tacoma Ave S, #415, Tacoma, WA 98402. The letter explained the legal requirements for voter registration and asked Ms. Gleason to correct her registration. The letter was sent on or around July 10, 2024. A copy of the letter is enclosed.
- 6. At my direction, Elections staff searched an online telephone directory to determine if Ms. Gleason had address listings in the county.

- 7. At my request, Elections staff searched county property records, specifically the King County Assessor's property assessment database, to determine whether Ms. Gleason owns property in the county.
- 8. It is my understanding from Elections staff that Ms. Gleason is not registered to vote at any other address in the state according to the statewide voter registration database.
- 9. At my direction, Elections staff searched the voter registration database of another state, Oregon, to determine if Ms. Gleason is registered to vote in any other state.

I declare under penalty of perjury of the laws of the State of Washington that having exercised due diligence to verify the evidence presented, that to the best of my knowledge and belief based on the above statements, including Ms. Gleason's own admission that she is improperly registered to vote that Ms. Gleason does not reside at the address provided in her voter registration record.

Ms. Gleason,

It's important that we all register to vote at our residential addresses. That ensures that we're voting for our local elected officials and not for elected officials who don't represent us. The laws requiring that we register to vote at our residential address are state laws and were in place long before Donald Trump was president. The specific language in RCW 29A.08.010 was <u>adopted in 2006</u>. Similarly, the determination of what information is publicly disclosed is, in relevant part, the result of a <u>state law amendment in 2005</u>.

If you have safety concerns related to public disclosure of your address, you may be eligible to participate in the <u>Address Confidentiality Program</u>. The addresses of participants in that program are not publicly disclosed.

As I previously urged you, please update your voter registration address to your current residential address. Information about how to do so is available here:

https://kingcounty.gov/en/dept/elections/governance-and-leadership/voting-in-king-county/voter-information/change-my-address. Unless you confirm that you have done so, I feel compelled to share this information with King County so that they can take appropriate action to ensure accurate voter rolls.

Dear Ms. Gleason,

Thank you for contacting the Attorney General's Office regarding elections in Washington. As one of the attorneys who practices in the area of elections law, I'm happy to respond. There's a fair bit to unpack, so let's jump in.

First, state law establishes that a voter's name and address, along with other information, is publicly disclosable. That's in RCW 29A.08.710(2).

Second, King County is correct that a voter's proper precinct is determined by the voter's residential address. That is required by <u>RCW 29A.08.010(2)</u>. I strongly encourage you to provide King County with your correct residential address, as that is required by state law.

Third, the presidential primary is unique in that the major political parties can require that voters sign a declaration in order to participate. That's authorized by <u>RCW 29A.56.050</u>. While Washington generally uses the "Top Two" system, it's different for president. Major political parties choose their own nominees, and minor parties and independent candidates have an alternative process for appearing on the general election ballot.

Fourth, King County is rolling out processes to make it easier for voters to cure any ballot issues. Some voters have found it challenging to return a cure form, so there are alternative ways to confirm your identity. While new signatures are added to past signatures for comparison purposes, they don't replace them. So while your digital signature might look different, your prior ink signature will still be available for comparison in the future, too.

If you would like to see changes related to state election laws, , I encourage you to contact your state legislators. You can look them up at this website: <a href="https://app.leg.wa.gov/DistrictFinder/">https://app.leg.wa.gov/DistrictFinder/</a>. You can also contact the major political parties and share with them your views on their requirement that voters sign a party declaration in order to participate in their presidential nomination processes.

I hope that this information is helpful to you. Please note that the information in this letter is my own and should not be construed as an official opinion of the Attorney General or any of our client agencies.

Unfortunately I have decided to forfeit my vote for President Biden in the 2024 Presidential Primary in Washington State because of serious republican interference with votes. I have been a registered voter in Washington State for over 50 years and have never encountered a problem until 2016. I am an independent voter and usually vote democrat because their policies align with my personal beliefs. However, I made the mistake of voting for republican Kim Wyman for Secretary of State because she seemed to have the most experience.

Against the will of the people in 2017 she sent Washington State voter rolls to Trumps voter manipulation expert and that's when my problems began. I have been voting through my King County P.O. Box address, which I use for all but my very personal mail, for 28 years. Yet my 2018 midterm ballot was sent to my home address, which is highly confidential. I called King County Elections to find out why and they told me I had to vote in the district of my residence, which is not true. The only "rule" I'm familiar with is that a person can only vote once. I was livid and told them to restore my P.O. Box address as my district and they refused. I had to give them a different King County property address and they put me into a "very red" district so my vote wouldn't count as much. I told them if I got one piece of mail at my property address I would sue King County for invasion of privacy. Their mail is coming to my P.O. Box but I still have to vote in a "red" district.

This month I mailed my Presidential primary ballot on March 4, 2024 in plenty of time for the March 12 cutoff. On March 8 I received a call from the "voter verification line" and was told my vote would not count because I hadn't checked a box on the envelope for democrat or republican. I didn't even know there was one. Apparently there is also some verbage on the back of the envelope, some kind of pledge I think that I wasn't aware of. The gentleman was going to send me a form to fill out and mail back by March 21 if I wanted my vote to count. I wanted it counted on March 12 so went to the online form but found they were asking for a lot of personal information they don't need and required a digital signature, which I will not do. The form also said the signature would be used for future comparison. My digital signature, like most people's, does not look at all like my legal signature so I refused.

I planned to go to the post office and sign and mail the form back tomorrow but decided against it for a couple of reasons. Washington is a "top two" candidate state where votes for the top two candidates determines who will be in the runoff, regardless of party affiliation. Candidates are not required to show a party preference. Why should I have to?

This morning I received another call from King County's "signature validation" line and when I called back the woman wanted some personal information by phone. This is highly unusual. Some years ago I forgot to sign the ballot envelope and a KC elections worker called and courteously told me the problem then mailed a form for me to fill out and send back. This morning I refused to give any personal information. The woman tried to appease me by saying many people had forgotten to mark a box, that they aren't picking on me. She said thousands of ballots were returned without the mark. That is when I decided to take action against this obvious voter manipulation.

I picked up my mail today and there were two forms from King County. Both said my signature was being questioned although I signed as I always have and I found it puzzling because the first caller said the reason was I didn't pick a party affiliate box. Both letters wanted more information that they do not need. As I said earlier, I am an independent voter and it is MY business only who I vote for. Asking for party affiliation must be removed from all Washington State and county ballot envelopes immediately.

Today's news reported that the new Trump controlled national republican party headquarters have been taken over by Lara Trump and she plans to direct all money to him. They also curtailed minority outreach offices and now want "volunteers" to be election watchers and lawyers. It's preposterous.

Washington State and all voters must be made aware of how targeted republican's voter interference goes, as my situation proves. I am very outspoken on newspaper comment sites and they do not like it but they will not stop me from helping to protect OUR democracy.

Please take whatever actions you can to put an end to these outrageous actions now, befo

Re: Your King County Voter Registration

King County Voter:

Washington State law requires that you use you the address where you physically reside as your residential address for voting purposes. See RCW 29A.08.010 (2). This ensures that you receive a ballot tailored to the candidates and measures on which you are eligible to vote and that you do not vote for elections in which you are ineligible to vote.

This office has learned that you admitted in an email to an employee of the Washington State Attorney General's Office that you are using a residential address for voting purposes that is not the address where you physically reside. The Director of King County Elections sent you two letters requesting that you provide your current and correct residential address. Having received no response, she referred the matter to this office.

As noted above, state law requires that your residential address for voter registration purposes be the address where you physically reside. Please note, there are some exceptions listed in RCW 29A.04.151 (see page 3 of this letter). Additionally, you may use an address other than your residential address, such as a P.O. Box, as the mailing address where you receive your ballot.

#### RCW 29A.04.151 Residence

"Residence" for the purpose of registering and voting means a person's permanent address where he or she physically resides and maintains his or her abode. However, no person gains residence by reason of his or her presence or loses his or her residence by reason of his or her absence:

- (1) While employed in the civil or military service of the state or of the United States;
- (2) While engaged in the navigation of the waters of this state or the United States or the high seas;
- (3) While a student at any institution of learning;
- (4) While confined in any public prison.

Absence from the state on business shall not affect the question of residence of any person unless the right to vote has been claimed or exercised elsewhere.
