#### RCW 29A.08.112 Voters without traditional residential addresses.

- (1) No person registering to vote, who meets all the qualifications of a registered voter in the state of Washington, shall be disqualified because he or she lacks a traditional residential address. A voter who lacks a traditional residential address will be registered and assigned to a precinct based on the location provided.
- (2) For the purposes of this section, a voter who resides in a shelter, park, motor home, marina, unmarked home, or other identifiable location that the voter deems to be his or her residence lacks a traditional address. A voter who registers under this section must provide a valid mailing address, and must still meet the requirement in Article VI, section 1 of the state Constitution that he or she live in the area for at least thirty days before the election.
- (3) A nontraditional residential address may be used when a voter resides on an Indian reservation or on Indian lands.
- (4) A federally recognized tribe may designate one or more tribal government buildings to serve as a residential address or mailing address or both for voters living on an Indian reservation or on Indian lands. However, a voter may not use a tribally designated building as the voter's residential address if the building is in a different precinct than where the voter lives.
- (5) A person who has a traditional residential address and does not reside on an Indian reservation or on Indian lands must use that address for voter registration purposes and is not eligible to register under this section.

#### RCW 29A.04.151 Residence.

"Residence" for the purpose of registering and voting means a person's permanent address where he or she physically resides and maintains his or her abode. However, no person gains residence by reason of his or her presence or loses his or her residence by reason of his or her absence:

- (1) While employed in the civil or military service of the state or of the United States;
- (2) While engaged in the navigation of the waters of this state or the United States or the high seas;
  - (3) While a student at any institution of learning;
  - (4) While confined in any public prison.

Absence from the state on business shall not affect the question of residence of any person unless the right to vote has been claimed or exercised elsewhere.

# Washington Constitution. Article VI. Section 4: Residence, Contingencies Affecting.

For the purpose of voting and eligibility to office no person shall be deemed to have gained a residence by reason of his presence or lost it by reason of his absence, while in the civil or military service of the state or of the United States, nor while a student at any institution of learning, nor while kept at public expense at any poor-house or other asylum, nor while confined in public prison, nor while engaged in the navigation of the waters of this state or of the United States, or of the high seas.

#### DECLARATION OF DEPUTY PROSECUTING ATTORNEY

I, Lindsey Grieve, am a senior deputy prosecuting attorney with the King County Prosecuting Attorney's Office. I am assigned to handle the voter registration challenges related to the above-listed mailbox facility on behalf of the Prosecuting Attorney.

Attorneys and staff of the King County Prosecuting Attorney's Office ("Prosecuting Attorney Staff") and at my direction, staff of the King County Elections Department ("Elections"), have exercised due diligence to verify that the challenged voters do not reside at the above address listed in their voter registration records. The following steps were taken to contact the challenged voters and to learn their actual residential addresses.

- 1. At my direction, Elections staff sent a letter from the Prosecutor's Office by mail, return receipt requested, to the address provided in each voter's registration record. The letter explained the legal requirements for voter registration and asked the voter to correct his/her/their registration. The letters were sent on or around July 8, 2024. A sample of the letter is enclosed.
- 2. At my direction, Elections staff searched an online telephone directory to determine if the voters have address listings in the county.
- 3. At my request, Elections staff searched county property records, specifically the King County Assessor's property assessment database, to determine whether the challenged voters own property in the county.
- 4. It is my understanding from Elections staff that the challenged voters are not registered to vote at any other address in the state according to the statewide voter registration database.
- 5. At my direction, Elections staff searched the voter registration database of another state, Oregon, to determine if the voter is registered to vote in any other state.
- 6. If, based on the efforts described above, we found what appeared to be a voter's actual residential address, we have provided it with the challenge.

I declare under penalty of perjury of the laws of the State of Washington that having exercised due diligence to verify the evidence presented, that to the best of my knowledge and belief based on the above statements, the challenged voters on the attached list do not reside at the address provided in their voter registration records.

King County Voter:

King County Elections recently reviewed your voter registration record and noted that you appear to be registered to vote at an address that is not a valid residence as required by state law. The Elections Director sent you two letters requesting that you confirm your residential address. Having received no response, she referred the matter to this office.

State law requires that your residential address for voter registration purposes be the address where you physically reside. There are some exceptions listed in RCW 29A.04.151 (see page 3 of this letter), but it is not permissible to use the address of a mailbox facility, storage facility, or other business as your residential address if you do not reside there, even if you receive your mail at that address.

You provided the following address as your residential address for voter registration purposes:

# REGISTERED ADDRESS

This appears to be the address of a mailbox facility or business, not a location where a person would physically reside. While you may still use the mailbox facility or business as your mailing address and receive your ballot there, you must provide King County Elections with your actual residential address. Please do so by contacting King County Elections by telephone at (206) 296-8683 or by completing and returning the voter registration form on the reverse side of this letter by July 22.

If you do not contact King County Elections by July 22, this office may file a voter registration challenge which could result in cancellation of your voter registration.
