### Proposition No. 1

# **Replacement Capital Levy for Safety, Security** and Technology **Improvements**

The Board of Directors of Vashon Island School District No. 402 adopted Resolution No. 812, concerning a proposition to finance safety, security and technology improvements. This proposition would authorize the District to levy the following excess taxes, replacing an expiring levy, on all taxable property within the District, to make safety and security improvements (upgrading fire safety, entry controls, security systems, HVAC) and acquire computers and technology equipment for student learning:

# **Explanatory statement**

Passage of Proposition No. 1 would allow Vashon Island School District to replace an existing capital levy that will expire at the end of calendar year 2024. The replacement levy will be used to make safety, security and technology improvements, including: (1) upgrading fire safety systems and play structure at Chautauqua Elementary School; (2) upgrading entry controls, door locks, security cameras and other security systems; (3) upgrading and/or improving heating, ventilation and air conditioning systems and equipment ("HVAC"); and (4) acquiring, installing and implementing instructional technology equipment, infrastructure and systems.

King County Elections is not authorized to edit

statements, nor is it responsible for the contents therein.

The School Board determined these projects are necessary to address student and staff safety and security needs, aging and deteriorating building infrastructure, the existing condition of technology systems and the needs of the District's educational programs. Further information is available on the District's website at https://www.vashonsd.org/.

The proposed four-year replacement capital levy would authorize collection of taxes to provide \$1,950,000 each year from 2025 through and including 2028. The tax levy rate per \$1,000 of assessed value required to produce these levy amounts is estimated to be \$0.44 in 2025, \$0.43 in 2026, \$0.42 in 2027 and \$0.41 in 2028. The exact tax levy rate to be levied may be adjusted based upon the actual assessed value of the taxable property within the District at the time of the levy. Exemptions from taxes may be available, call the King County Department of Assessments, 206.296.3920.

VISD continues to be a strong steward of public dollars by investing in ongoing preventative maintenance to facilities and modernizing vital technology systems. We must renew this levy to meet both the modern needs of students and the expectations of our community. This replacement levy enables VISD to upgrade fire safety systems and the play structure at Chautaugua Elementary School. # **Statement in opposition**

There should be no tax measures on the lowest voter turnout month, February. Taxpayers don't even have their tax bills for the year yet. Tell the district to run tax measures in November when voter turnout is high.

WA has about a dozen public charter schools open to all. Our public charter schools are not allowed to run any local tax measures and they don't. They stay on a budget. They provide all the technology that students need and none that they don't. They don't nickel and dime taxpayers and tax them out of their homes. They don't have Enrichment Levies, Tech Levies, Capital Levies, Bonds, Replacement Levies, Not-A-New-Tax Tax Levies, etc.

The point is that most traditional public schools in WA are spendthrifts. More money, same poor results. It doesn't matter how much money they are given. They always seem to need/want more. What if we had school choice (vouchers) to give families a choice and taxpayers a break? Perhaps that is needed to introduce some competition for the monopoly to both improve and to become more efficient. And most importantly, many students learn better in environments other than what the assigned traditional public schools provide.

#### Rebuttal of statement in opposition

Vashon Island School District does not receive state funding for urgent and necessary safety driven capital improvements as part of the state funding model. Unfortunately, the model is outdated, woefully inadequate, and does not address our state's paramount duty to fully fund basic education. VISD faces this reality yearly when making necessary safety, security, and technology improvements. Our students deserve better than what the state provides. These are the facts.

#### Rebuttal of statement in favor

There is no reason to rush this or any tax measure for the February election without a full vetting. The district should have the courtesy of allowing hardworking taxpayers to at least see their property tax bill for 2024 (arrives in the mail, conveniently, in March) and our Federal Income Taxes (April). And the district should want a large voter turnout, no? That will occur in November.
