

No Stamp Needed!

We strongly recommend returning your ballot as early as possible.

Mailed ballots must be postmarked by April 23.

Your signature matters. Make it match.

Your signature doesn't need to be fancy or even be legible, but it does have to match what's on file. Not sure of what's on file? Check your driver's license or state ID.

Register to vote



Online: It takes two minutes and a Washington State Driver's License or ID to register online at **VoteWA.gov**. To register in time to vote in the April Special Election, register online by April 15.



By mail: Download and print a registration form from kce.wiki/VoterReg and mail to King County Elections: 919 SW Grady Way, Renton, WA 98057. It must be received by April 15.



In person: You can register in person through April 23, Election Day at King County Elections headquarters. More information about hours and services can be found at kingcounty.gov/elections.



Proposition No. 1

Community Center General Obligation Bonds - \$19,500,000

The City Council of the City of Enumclaw adopted Ordinance No. 2770 concerning this proposition for bonds. This proposition authorizes the City to finance the construction and equipping of a community center; to issue up to \$19,500,000 of general obligation bonds maturing within a maximum term of 29 years to finance such improvements; and levy property taxes annually in excess of regular property tax levies to repay such bonds, as provided in Ordinance No. 2770. Explanatory statement

If voters approve Proposition No. 1, the City of Enumclaw will respond to community programing and activity needs by issuing bonds for a new Community Center. The current senior center, housed in a 1927 building, requires extensive upgrades surpassing its value. Based on input from citizens, council members, and experts, construction of a new community center would allow the City to provide enhanced pre-K, youth, senior, community programs, activities, and events.

The City will use bond proceeds totaling \$19.5 million to construct a flexible Community Center catering to all age groups. Unlike the current structure, it will host various activities simultaneously, including pre-K, youth, senior, and family programs. The facility aims to enhance park program access, providing a full gym for sports and space for community events, activities, and festivals.

To support the project, the City identified \$3.35 million in grants and funds. An additional \$1 million Capital Grant request was submitted to the State Legislature in January 2024. The proposed \$19.5 million general obligation bonds would mature within 29 years or less, with repayment derived from annual excess property tax levies. The estimated excess levy rate is \$0.30 per \$1,000 of assessed property value. For instance, a home with an assessed value of \$500,000 would incur an approximate annual cost of \$150.00 (\$12.50 per month).

Homeowners aged 61 or older, or disabled, meeting low-income requirements may qualify for a property tax exemption. For exemption details, individuals are encouraged to contact the King County Assessor at 206-296-3920.
