





Soo Jeedinta Lambarrada 1A iyo 1B

Soo Jeedinta 1A (oo ay soo gudbiyeen Codsiga Hindisaha Lr. 137) iyo Soo Jeedinta 1B (mid beddelaad ah oo ay soo jeediyeen Golaha Seattle iyo Duqa Magaalada) ayaa khuseeya maalgelinta kharashka canshuurta mushahar bixinta oo loogu talagalay Horumariyaha Guriyeynta Bulshada.

Soo Jeedinta 1A ayaa waxay canshuur ku soo rogi doontaa kharashyada mushahar bixinta ee loo-shaqeeyayaasha ka ganacsada Seattle. Heerka canshuurtu wuxuu noqon doonaa 5% oo ku aaddan magdhogwa sannadlaha ah ee ka sareeya \$1,000,000 ee shaqaale kasta laga siiyo gudaha Seattle. Dakhliga ka soogala ayaa taageeri doona Horumariyaha Guriyeynta Bulshada, oo ah hey'ad horumarinneed oo dadweyne oo loo abuuray horumarinta, lahaanshaha, iyo dayactirk guryaha bulshada ee Seattle. Canshuurta la soo rogay ayaa noqon doonta mid lagu sii doro canshuurta kharashka mushahar bixinta ee Magaalada ee lagu soo rogay Xeerka Dowladda Hoose ee Seattle Cutubka 5.38.

Si beddel ahaan, Golaha Magaalada Seattle iyo Duqa Magaalada ayaa soo jeidiyay Soo Jeedinta 1B (Xeerka 127101), kaas oo qoondelyn doona \$10,000,000 oo ka mid ah dakhliyada canshuurta kharashka mushahar bixinta ee hore u jira ee shanta miisaaniyad sannadeedka ee soo socota si loo maalgeeliyo Horumariyaha Guriyeynta Bulshada. Dakhliga ka soo baxa ayaa wuxuu taageeri doonaa helitaanka iyo horumarinta guriyeynta bulshada ee Seattle. Horumariyaha waa inuu cadsadaa oo uu buuxiyaa shuruudaha qaarkood sida ay go'aamisay Magaaladu ka hor inta aan lacagta la bixin. Haddii kharashka loo qoondeeyay aan lagu bixin saddex sanno gudhood laga bilaabo markeedii ugu horeysay ee la qoondeeyay, waxay diyaar u yihiin inay taageeraan mashaariicda kale ee guryaha la awoodi karo.

Bayaanka sharaxaadda

Cabbirkan wuxuu codbixiyeyaa u soo bandhigayaa laba su'aaloood oo ku saabsan maalgelinta canshuurta kharashka mushahar bixinta ee ku aaddan Horumariyaha Guriyeynta Bulshada, maamulka horumarinta dadweynaha ee hore loogu aasaasay oggolaanshaha codbixiyaha ee Hindisaha 135 ee Febraayo 2023. Horumariyaha waxa loo abuuray in uu horumariyo, lahaanshaha, iyo ilaalinta guriyeynta bulshada Seattle.

Su'aasha ugu koowaad waxay tahay in la qato mid ka mid ah labada hindise oo beddelka ah, labadaba waxay ku lug leeyihiin maalgelinta Horumariyaha ee dakhliga ka soo baxa canshuurta kharashka mushahar bixinta. Su'aasha labaad waa labadaan soo jeedin midkee ayaa la hirgeliyya.

Haddii codbixiyeyaa shu ay su'aasha koowaad si aqlabiyad ah ugu codeeyaan "Maya", markaa ka dib soo jeedinta midkoodna lama aqbali doono. Haddii codbixiyeyaa shu ay su'aasha koowaad si aqlabiyad ah ugu codeeyaan "Haa", markaa ka dib soo jeedinta hesha tirada badan ee codadka ee su'aasha labaad ayaa la aqbali doonaa. Codbixiyeyaa shu waxay u codeyn karaan su'aasha labaad iyada oo aan loo eegin codkooda su'aasha koowaad.

Soo Jeedinta 1A

Soo Jeedinta 1A waxay canshuur cusub ee kharashka mushahar bixinta ku soo rogi doontaa loo-shaqeeye kasta oo ka ganacsada xadka magaalada Seattle. Caddadka canshuurta waxaa loo xisaabin doonaa 5% wadarta guud ee magdhogwa sannadlaha ah oo ka badan \$1,000,000 ee la siyo shaqaale kasta oo Seattle. Canshuurta ayaa noqon doonta mid lagu sii doro canshuurta kharashka mushahar bixinta ee Magaalada ee lagu soo rogay Xeerka Dowladda Hoose ee Seattle Cutubka 5.38. Ugu yaraan 95% dakhliga canshuurta ayaa loo qoondelyn doonaa oo loo wareejin doonaa Horumariyaha. Qoondelyn ugu badan ee sannadlaha ah ee lagu maamulayoo canshuurta waa 5% dakhliga canshuurta ama \$2,000,000, hadba kan hooseeya.

Kuwa soo socdaa ayaa laga dhaafi doonaa canshuurta: (1) Shaksi kasta oo ah qandaraas madax-banaan oo magdhogwiisa sannadlaha ah uu ka badan yahay \$1,000,000 lagu doro canshuurta uu bixiyo ganaci kale; iyo (2) ganacsiyada laga dhaafay canshuurta ee ay ka dhaafeen magaalooyinka sida waafaqsan qaunuunyada federaalka ama gobolka.

Soo Jeedinta 1B

Soo Jeedinta 1B waxay qoondelyn doontaa \$10,000,000 oo ah kharashyada canshuurta kharashka mushahar bixinta ee hore u jira shanta miisaaniyad sannadeed ee soo socota si loo maalgeeliyo Horumariyaha. Dakhliga waxaa loo isticmaali karaa kharashka iibka, dhismaha, ama dib u habeynta guryaha bulshada, marka laga reebo in maalgelinta loo isticmaali karo oo keliya kharashyada deganeyaasha guryaha ilaa 80 boqolkii ba dakhliga dhex dhixaadka ah ee aagga. Ilaa iyo 5% ee lacagta loo qoondeeyay waxaa laga yaabaa in uu isticmaalo Horumariyaha si uu ugu bixiyo kharashkeeda maamulka.

Horumariyuhu waa inuu shaqaaleeyaa sarkaalka fulinta iyo madaxa sare ee maaliyadda, oo uu muuijyaa inuu leeyahay xakamayn maaliyadeed oo ku filan, sida uu go'aamiyay Agaasimaha Xafiiska Guriyeynta, ka hor inta aan la helin maalgelinta mashaariicda guryaha.

Haddii lacagaha loo qoondeeyay mashaariicda guriyeynta aan lagu abaalmarin Horumariyaha saddex sanno gudhood laga bilaabo qoondeyntoodii ugu horeysay, lacagta ayaa laga dhigi doona mid diyaar ah iyadoo loo raacayo habka caadiga ah ee Magaalada ee maalgelisa mashaariicda kale ee guryaha la awoodi karo.

Seattle waxa soo food saartay dhibaato guryo la awoodi karo iyo hoy la'aanta oo aan kala joogsi lahayn. Iyada leh tirada dadka oo si xawli ah u sii koraaya iyo qiimaha maciishadda oo aad u kordhaysa, qaar badan oo naga mid ah ayaa qiimaha awged bulshadeena uga dhex baxaya. Way caddahay in qalabka hadda jira ee abuurista iyo ilaalinta guriyeynta la awoodi karo aanay ku filnay. Soo Jeedinta 1 waxay gacan ka geysan doontaa wax ka qabashada dhibaatadaan iyadoo ururinaysa lacag ay Horumariyaha Guriyeynta Bulshada Seattle (SSHD) u isticmaali doonaan abuurista iyo dayactirk guri bulsho oo ay dadweynuhu leeyihiin, si joogto ah loo awoodi karo, dakhli isku dhafan oo Seattle ah.

Guryaha ay abuurto SSHD iyada oo loo maraayo Soo Jeedinta 1A waxay ahaan doonaan guryo la awoodi karo oo joogto ah. Guryahaan la heli karo, la awoodi karo, deegaanka u fiican, ay sameeyaan shaqaale urur, guryaha tayada sare leh waxay diyaar u yihiin kiraysteyaasha soo gala dhammaan dakhliyada kala duwan - oo ay ku jiraan bareyaasha, shaqaalahaa daryeelka caafimaadka, bixiyeeyaa xanaanada carruurta, kuwa dakhligoodu go'an yahay, iyo bulshooyinka la takoorro ee laga yaabo inay sidoo kale ay barakacaan. Muhiimad ahaan, abuurista guryo badan ayaa ka caawin doonta hoos u dhigidda qiimaha guryaha ee qof kasta.

Codbixiyeyaa shu ayaa laga dhaafi doonaa canshuurta: Seattle waxay abuureen SSHD bishii Febraayo 2023 ayagoo si weyn ugu codeeyay hindisaha 135. Laakiin, cabbirka kuma aysan jirin ilo dhaqaale sababtoo ah in sidaas la sameeyo waxay ku xad gudbi lahayd "xeerka halka mawduuc" ee gobolka ee ku aaddan hindisooyinka. Ku codee Haa ee Soo Jeedinta 1 (iyo 1A) si aad u maalgeliso Horumariyaha Guriyeynta Bulshada Seattle.

Aan dhisno Seattle halkaas oo qof kastaa awoodi karo inuu ku noolaado oo uu ku horumaro.

Beeninta bayaanka looga soo horjeedo

Mucaaradku waxay ku dooddayaan in aanan wax ka qaban dhibaatada awood-u-helidda guryaha ee dhammaan reer Seattle. Waan khilaafsanhay -- in badan oo ka mid ah deriskeena ayaa la halgamaaya, magaaladeena waxay luminaysaa bulsho aad u badan oo ka dhigaysa mid weyn.

Wakaalad degmeed ahaan, oo ay abuureen codbixiyeyaa shu, Horumariyaha Guriyeynta Bulshada Seattle waxaa ka shaqeeyaa oo ay hoggaamiyaan khabirro ku taqasusay hantida ma-guurtada ah, horumarinta guriyeynta, qaab dhismeedka, iyo maalgelinta guriyeynta dadweynaha -- dhammaantood diyaar u ah inay shaqo tagaan dhismaha guriyeynta bulshada.

Doorashooyinka Degmada King ma saxaan astaamaynta, naxwaha, ama hubinta-xaqiqa ee musharaxa iyo bayaannada cabbirka.

Taageerayaasha guriyeynta bulshada ayaa sheegaaya in ay soo dejinayaan jihada "horusocodka" ee siyaasadda guriyeynta. Dhab ahaantii, guriyeynta bulshadu waxay u hagi doontaa ilaa 100 milyan oo doolarkeena canshuurta xaddidan si loogu dhiso guri dadka dakhligoodu sareeyo oo ah ilaa \$126,000 sannadki.

In ka badan 12,000 oo qof ayaa guri la'aan ku ah Seattle habeen kasta. 30,000 oo kale waxay halis ugu jiraan inay waayaan guryahooda kor u kaca kirada iyo duminta darteed. Dakhli kasta oo cusub oo canshuureed waa inuu ku socdaa caawinaadda dadka runtii saboolka ah. Tobanka sanno ee ugu horeeya guryaha bulshada, u doodeyaasha waxay rabaan in si gaar ah loo awoodi karo, dakhli isku dhafan oo Seattle ah.

Laba sanno ka hor, taageerayaasha guriyeynta bulshada ayaa ballan qaaday inay abuurayaan mashaariic hadda laga maalgelin lahaa iibinta curaarta iyo kirada laga qaado unugyadooda. Taa beddelkeeda, waxba ma ay samayn. Intaa waxaa dheer, u doodeyaasha guriyeynta bulshada waxay rabaan inay lacagtaan oo dhan siyaan hey'ad bilow ah oo aan caddeyn, Horumariyaha Guriyeynta Seattle, oo aan xitaa weligood dhisin hal guri oo keliya.

In ka badan laba darsan oo hey'ado aan faa'iido doon ahayn oo leh diiwaan la xaqiijiyay oo ah dhisidda guriyeynta dadka saboolka ah ee Seattle oo ah tobanaan sannadood oo dheer. Taasi waa meesha ay malaayiintaan u baahan yihiin inay tagaan. Ku codee "Maya" si aad u joojiso labada tallaabo ee taxaddar la'aanta ah inay noqdaan sharci.

Beeninta bayaanka lagu taageerayo

Marka ay timaado dhibaatada guriyeynta Seattle, waxaan u baahanahay xalal wax ku ool ah. Horumarinta guriyeynta la awoodi karo ayaa ah hawl aad u farsamo ah, ahna hawl adag. Soo Jeedinta 1 waxay bixin doontaa ilaa \$52 milyan oo doolar canshuureed sannadki, si joogto ah, urur aan la dooran, khibrad la'aan ah oo aan la heli karin, Horumariyaha Guriyeynta Bulshada. Soo Jeedinta 1 kuma jirto kormeer, wakhti ama natijjooyin loo baahan yahay ee kuwan horumarinta guriyeynta.

Soo Jeedinta 1 waa khatar aysan Seattle awoodin.

Soo jeedinta 1A waxay canshuurtaa ganacsiyada ugu hantida badan si loo abuurro sanduuq u go'an Horumariyaha Guriyeenta Bulshada Seattle (SSHD) si ay u fuliyaan waajibaadkooda ee codbixiyuhu ansixiyay. Magaaladu waxay ku qiyastay Soo Jeedinta 1A inay u ururin doonto \$50 milyan sannadkii SSHD si ay u abuerto guryo bulsho oo la awoodi karo, si guud loo leeyahay, dakhli isku dhafan ee guriyeyn bulsho.

Waxaan ku nool nahay mid ka mid ah magalooyinka ugu qanisan adduunka, laakiin dhammaan reer Seattle kama faa'iideystaan hantidaas. Soo jeedinta 1A waxay caqabod ku noqotaa kala duwanaanshaha, iyada la hagayo kheyraadka ganacsiyada ugu qanisan ee SSHD si loo dhiso keyd guri oo ay awoodi karaan dhammaan reer Seattle.

Dakhligaan loo qoondeeyay wuxuu abuuri doonaa in ka badan 2,000 oo unug, oo ay ku jiraan unugyo qoys, guryo bulsho 10-ka sanno ee soo socda. Soo jeedinta 1A waxay hubin doontaa in kalkaaliyeasha, macallimiinta iyo bareyaasha, dab-damiska iyo fanaanniinta ay awoodi karaan inay ku noolaadaan Magaaladeena. Soo jeedinta 1A waxay ay siinaysaa Seattle qalab cusub oo ay kula dagaalanto xasaradaha la awoodi karo ee guriyeenta oo ay fuliso waajibaadka ay abuureen codbixiyeyashu markii ay abuureen SSHD. Soo jeedinta 1A waxay si dhab ah u qaadataa dhibaataada guriyeynta waxayna maalgelin doontaa qaab caalami ah oo la xaqiijiyay.

Soo jeedinta 1B si dhab ah uma qaadanayso dhibaataada guriyeenta. Soo jeedinta 1B waxay hoos u dhigtaa canshuuraha ganacsiyada hodanka ah waxayna caburisaa guryaha bulshada.

Beeninta bayaanka lagu taageerayo Soo Jeedinta 1B

Soo Jeedinta 1B waxay \$10 milyan ka qaadaysaa guryaha la awoodi karo iyo adeegyada muhiimka ah si canshuuraha ganacsiyadeena ugu qanisan loogu hayo kuwo hooseeya. Wuxuu lahaataa dugsiyo dadweyne oo wanaagsan. Canshuurtaan muhiimka ah ee Barnaamijyada Waxbarashada iyo Canshuuraha Hawlgallada ee Dugsiyada Dadweynaha ee Seattle. Ansixinteeda waxay muhiim u tahay bixinta waxbarasho tayo leh ku dhawwaad 50,000 oo arday oo hadda diiwaan gashan.

Abuuritaanka dib u dhac badan iyo xafiis-dowlad maaha dariiqo looga baxo dhibaataada guriyeenta. Waa sida aan markii hore halkan ku nimid. Waa in aan ku dhaqaqnaa xowliga iyo miisaanka dhibaataadaan ay u baahan tahay.

Waxaan taageernaa guriyeynta la awoodi karo waana sababta aan u taageerno Soo Jeedinta 1B si ay u bixiso \$10 milyan sannadkii oo ah dakhli canshuureedka hore u jira muddo 5 sanno si loo tijaabiyo fikradaa in ay shaqeynayo. Soo Jeedinta 1B waxay ku daraysaa la xisaabtanka iyo shuruudaha warbixinta ee aanay lahayn Soo Jeedinta 1A. Soo Jeedinta 1B waxay u baahan tahay in Xafiiska Guriyeenta Magaalada, oo ah wakaalad guuleysata oo leh 40-sanno oo diiwaan dhisidda kumanaan guri, ay kormeeraan oo ay ka warbixiyaan horumarka guriyeenta bulshada PDA. Markii SSHD la abuuray 2023, isla taageerayaashii 1A waxay yiraahdeen "ma jirto wax kabbid dowlaade oo lagama maarmaan ah". Laba sanno ka dib, waxay rabaan \$50 milyan sannadkii. Waxay yiraahdeen 12% ee guryaha loogu talagalay dadka guri la'aanta iyo dakhliga yar soo gala, hadda waa 3%. Waxayna rabaan in canshuuraha ay kabaan guryaha dadka uu soo galu dakhli ah 120% ee dakhliga dhewe - ma aha deganeyaasha ugu saboolsan.

Macallimiinta iyo kaaliyeasha waxbaridda waa la kala diri doonaa, iyo barnaamijyada qiimaha leh ee ardayda taageera waa la dhimmi doonaa ama la tirtiri doonaa.

Dugsiyada Dadweynaha Seattle waxay codsanayaan ansixinta codbixiyaha ee ah canshuurta Hawlgallada oo ah \$747.0 milyan wadar ahaan oo la ururinayo muddada saddexda sanno ee 2026 ilaa iyo 2028. Canshuurta la soo jeediay aaya beddeli doonta canshuur wakhtigeedu dhacayso.

Ansixinta Soo Jeedinta Lr. 1 ayaa u oggolaanaysaa canshuuraha in lagu bixiyo barnaamijyada waxbarashada iyo Hawlgallada iyo in la daboolo baahiyaha waxbarasho ee ardayda dhigata dugsiyada degmada. Lacagaha waxaa loo isticmaali doonaa in lagu maalgeliyo barnaamijyada uusan Gobolka maalgelin ama uusan si buuxda u maalgelin. Lacagta ku jirta iyo midda lagu shubayo Sanduuqa Guud ee Degmada kuma filna inay daboolaan baahiyahaan iyada oo aan la helin lacag dheeraad ah.

Canshuurta Raasumaalka waxay hubin doontaa in dhammaan ardayda iyo macallimiirtu ay helaan jawi waxbarasho oo ammaan ah iyadoo dib u habeyn lagu samaynayo dhismeyaasha oo loogu talagalay badqabka dhul-gariirka, hagaajinta qaylo-dhaanta dabka iyo nidaamyada amniga dugsiga, iyo samaynta maalgeshiyada kale ee amniga ee muhiimka ah.
