## Department of Executive Services -- Airport Division Roundtable Meeting Minutes for December 8, 2025

### **Meeting Opening, Roll Call, and Quorum Update**

The meeting was called to order by Erik Utter (Roundtable Chair, Renton/ Kent/ South King County) at 5:00 p.m.

Welcome was led by Erik Utter.

Roll call was led by Ayako Shapiro (PRR). A quorum was present.

The November meeting summary was approved by general consent.

### **Public Comment**

John LaPorta made a recommendation to the Airport that the Facilitation contract be moved to the Office of Boards and Commissions from the Airport to remove any appearance of non-neutrality on the part of the facilitation team and so that the Roundtable can see the facilitation scope prior to finalization and recommend revisions. John further asked the Airport to notify the Roundtable in advance of presentations about if the Roundtable will be asked to make a recommendation or weigh in on something, or if the purpose of the presentation is just to inform the Roundtable members. His concern is that the Airport will present something as if it is just information, and then later tell the King County Council that the Roundtable members did not have any objections or recommendations about that subject.

Scott Cooms agreed with John LaPorta on both of his points and added a request and a concern. He asked if the Airport could consider extending the left turn lane by the Museum of Flight to decrease the number of accidents that take place there. David Decoteau (KCIA) noted that decisions about that roadway were likely up to the City of Tukwila. Scott then let the Airport know that the 20% increase in rent for tie-down tenants was a lot to absorb all at once.

Following a question by Roundtable member Lisa Krober (Tukwila), David Decoteau (KCIA) stated that the Airport followed the Leasing Working Group recommendations in setting rates and fees. Their recommendations were presented to the Board in the spring of 2025 and included a rent increase cap of 20 percent in any given year. David noted that the Airport had not increased fees for 10 years so was far behind the market rate.

### **Presentations and Updates**

#### **UPS Busy Season Update**

Morgan Kaivo (Cargo) spoke as a representative of UPS. He did not have a formal presentation, but wanted to let the Roundtable know what to expect as UPS enters its busiest season. He explained that peak season for UPS at the Airport is between Thanksgiving and Christmas. Outside of peak season he said that UPS has historically had four morning flights and four afternoon flights coming into Boeing Field Tuesday, Wednesday, Thursday, with fewer on Mondays and Fridays. Since UPS has been awarded the Postal Service contract, they typically also have two to three flights on Saturday and Sunday. During the peak, the plan is for five morning flights and eight afternoon flights from Tuesday through Thursday. Morgan noted that UPS employs over 400 people at Boeing Field, and that there is currently no plan to expand further. The USPS contract is for five years.

Questions and comments from Roundtable members:

- Erik Utter (Renton/Kent/ South King County) asked who had the USPS contract previously. Morgan responded that FedEx previously had 70% of the contract and UPS had 30% of the contract.
- Velma Veloria (Beacon Hill) asked if UPS could ensure that planes arrive before 10:00 or 11:00 pm. Morgan noted that all planned arrivals and departures are before 8:00 pm. There are unplanned departures very occasionally that may happen later.

### **Discussion and Decision Items**

#### **Bylaws update**

Erik Utter reminded the Roundtable that he had presented proposed changes to the bylaws during the November meeting. Those proposed changes were included in the meeting packet as well.

- The first proposed update is to change the bylaws to match the current King County Code and reflect the addition of a representative of the South Park neighborhood and the splitting of the Beacon Hill and Rainier Valley seats. Erik asked if there were any concerns and no Roundtable members indicated that they were concerned.

- The second proposed update is to, in the event that the Roundtable cannot come to consensus on a recommendation, reduce the number of meetings before issuing a majority and a minority opinion from three to two. Erik asked if any Roundtable members had concerns about this change.
  - Ken Moninski (Off-site Businesses) asked if issuing a minority report was a requirement and Erik responded that as far as he can tell, there is nothing in the bylaws that require a minority report in the event of a split decision by the Roundtable.
  - Velma Veloria (Beacon Hill) said she liked the idea of shortening the number of meetings before the Roundtable could take action without consensus and also appreciated the idea of a minority report.
  - Holly Krejci (Georgetown) appreciated the conversation and is fine with the proposal but pointed out that in general the Roundtable does not allocate enough time for thoughtful deliberation around difficult conversations and would like to advocate for that in the future. Holly also recommended creating an operational document for how the Roundtable structures agendas around difficult topics.
- The third proposed update is a technicality. The current bylaws stipulate a nominating committee as part of the election process for Chair and Vice Chairs. Erik noted that in his experience, the Roundtable does not use a nominating committee and instead just votes on the Chair and Vice Chair during the last meeting of the year. His proposed change would formalize that. The Roundtable members did not express concern about this change.

Mark McIntyre (Corporate Aviation) moved to adopt the changes to the bylaws as proposed and Velma Veloria (Beacon Hill) seconded the motion. The motion was passed unanimously.

### **Facilitation Contract Scope**

Matt Sykora (KCIA) showed the Roundtable members a table highlighting the differences between the 2025 and 2026 Facilitation contract scopes. The table was included in the meeting packet.

The biggest proposed change is to add up to five two-hour “special meetings” that the Roundtable could use to gather outside of the regularly scheduled monthly meetings. These could be for planning retreats or relationship building, for example. They would need to be open to the public and follow the same public meeting rules as the monthly meetings, but it would allow for other kinds of conversations to take place than those that typically happen at the Roundtable meetings.

Another proposed change is to require the facilitation team to be present in-person at 50% of the Roundtable meetings.

### **Airport Staff Report and Updates**

#### **Community Engagement Report**

##### Vision 2045 Open House

- Matt Sykora (KCIA) noted that public comments on the Vision 2045 Master Plan are due soon. Erik Utter (Renton/Kent/ South King County) clarified that there would be additional public comment periods.
- Matt reminded the Roundtable members that there would be a public hearing for the Part 150 Noise Study in January and that materials would be available two weeks before.

##### Update on Filling Vacant Roundtable Seats

- Dave Decoteau (KCIA) shared that the Airport had received two applications for the South Park seat, three applications for the At-large seat and one application for the West Seattle seat. The Boards and Commissions office recommended that the Airport not move forward with reviewing applications for a particular seat until they have at least three, so they are continuing to recruit for the South Park and the West Seattle seats.
- Matt Sykora (KCIA) said that he had reached out to all Roundtable members who were up for reappointment and that Ken, Lisa, Mark, Morgan, and Erik had all agreed to continue as part of the Roundtable.

### **Roundtable Chair Report**

#### **County Budget for the Airport**

Erik Utter reported that at a recent King County Council meeting one of the agenda items included Airport fee updates. Councilmember Mosqueda had offered an amendment maximizing the fees to the extent possible. There was a lot of public comment about the impact that would have on the Airport tenants and as a result she withdrew the amendment and reached out to Erik and other Roundtable members to get their perspectives. Erik noted that the legislation would probably come back to the Roundtable for review in 2026.

#### **Year in Review**

Erik shared with the Roundtable members and Airport staff an Annual Report that he had drafted. The report was included as part of the meeting packet. Erik noted that one of his goals when he took on the role of chair was to take action on concrete things that the Roundtable could really move forward. In 2025 the Roundtable moved forward, took action on or influenced:

- The Airport bus stop
- The facilitation contract
- The 2045 Strategic Plan
- Airport Rules and Regulations Minimum Standards
- RNAV minimum approach
- Updating the bylaws

In 2026 Erik hopes the Roundtable can:

- Set the priorities for the year
- Make specific recommendations for Vision 2045
- Engage the Georgetown community around the use of the new parcel
- Collaborate with Airport stakeholders
- Continue to pursue RNAV approach with the FAA

Erik challenged the Roundtable to improve in the following areas:

- Allow more time for meaningful exploration of topics on Roundtable agendas
- Break down topics that are highly technical and difficult to digest by engaging subject matter experts on the Roundtable prior to presentations
- Setting minimum standards for Roundtable member participation and clear processes for when those standards are not met.

Erik identified the following opportunities for Airport Management:

- Challenge: Transparency with the community is a challenge. This creates a lack of trust and that makes it harder for the Airport to meet its objectives in the long run. Being more transparent, even with topics that are less than popular would in the long run make it easier to get things done.
- Challenge: Community engagement is inconsistent. Some great work was put into the community engagement plan and the strategic plan but Erik is not sure that those documents and processes are being followed.
- Challenge: Limited maintenance opportunities for small plane mechanics. There are currently none on the Airport and getting approval for an off-site mechanic can take weeks. This reduces safety. Can the Airport develop a fast track approval for independent mechanics? And can the Airport encourage small businesses-mechanics to come “into the fence”?
- Challenge: Since 1990, operations at KCIA have declined by 61%, compared to a 35% average. During that time, Airport land use dedicated to small planes has decreased by 64%. This is really hurting the ecosystem – small businesses, mechanics, pilots and pilot training – that eventually supports larger corporate aviation. Erik recommends encouraging economic diversity through policy that incentivize investment in GA. Supporting workforce and pilot development to strengthen the pipeline.

The Roundtable members really appreciated the work that Erik put into the annual report and they felt that it sets a good precedent for future chairs to follow.

### **Chair and Vice Chair Election**

Ali Lee was elected Chair and Erik Utter was elected Vice-Chair for one year terms starting immediately. The Roundtable members and Airport staff congratulated them both.

### **Old Business**

#### **Bus stop**

Ali Lee (Magnolia) noted that King County Metro had asked for an updated letter from the Roundtable. Mark McIntyre noted that he had some concerns about the bus stopping on Airport Way and if that would pose safety issues. Ali said that Metro would need to do a feasibility study and that might result in the bus stop coming on to Airport property. In general there was no objection to drafting and submitting a new letter, which Ali agreed to lead.

Matt Sykora (KCIA) shared that one of the Vision 2045 alternatives reserves land for bus stops around the Airport.

#### **RNAV**

Mark McIntyre (Corporate Aviation) reported that he had received a response from the FAA on their RNAV approach letter. The letter mentioned that currently the instrument landing system approach (ILS) is defined as a precision approach and the RNAV approach is not. That may change in the near future, and if it does then the FAA can support the RNAV approach. They recommended resubmitting the letter when RNAV is categorized as a precision approach. Mark said he would follow up.

### **New Business**

#### **Tower**

David Decoteau (KCIA) noted that the Airport and the FAA recently concluded the first set of studies for siting the tower replacement. The preferred site is adjacent to the existing tower.

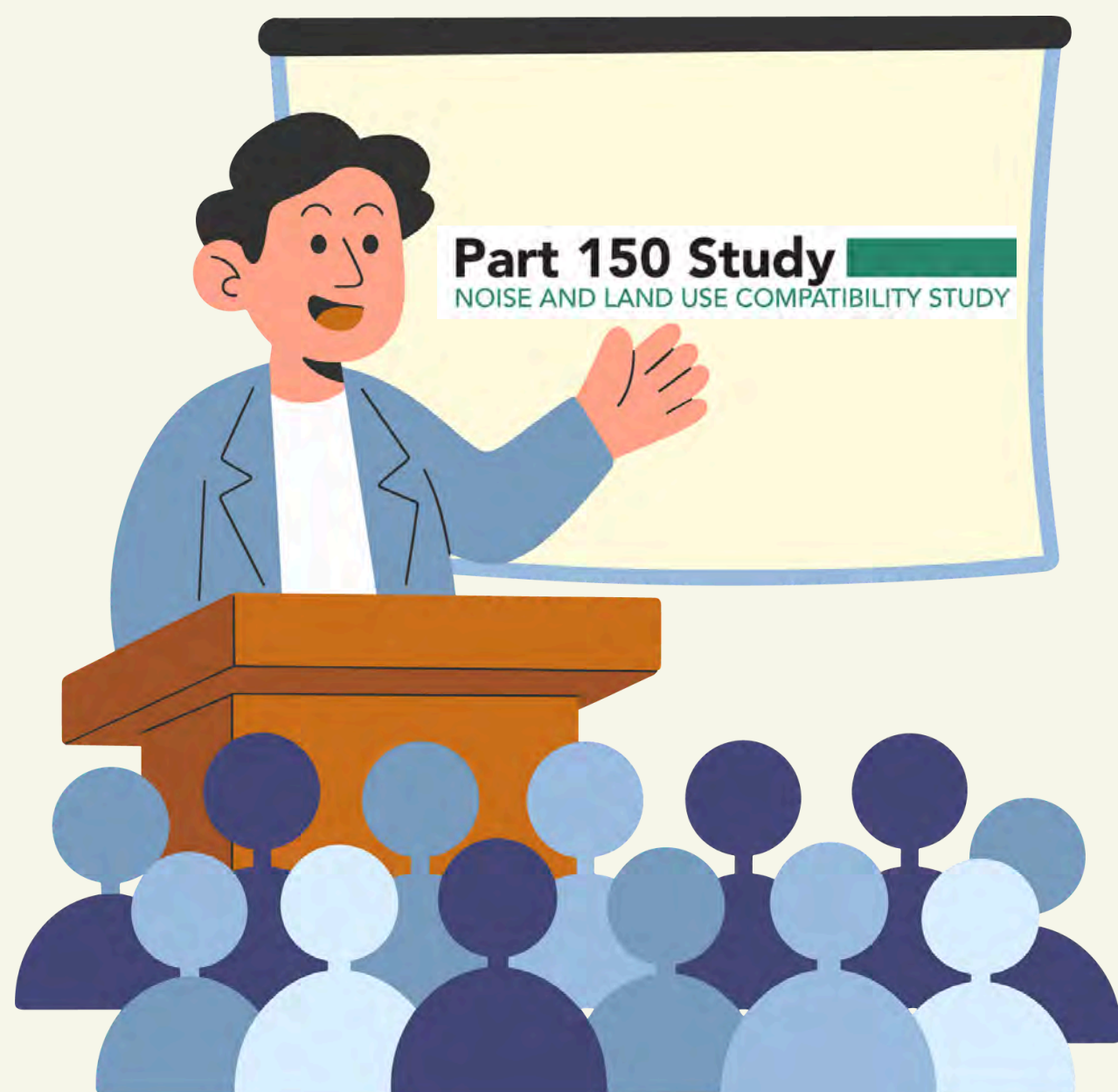

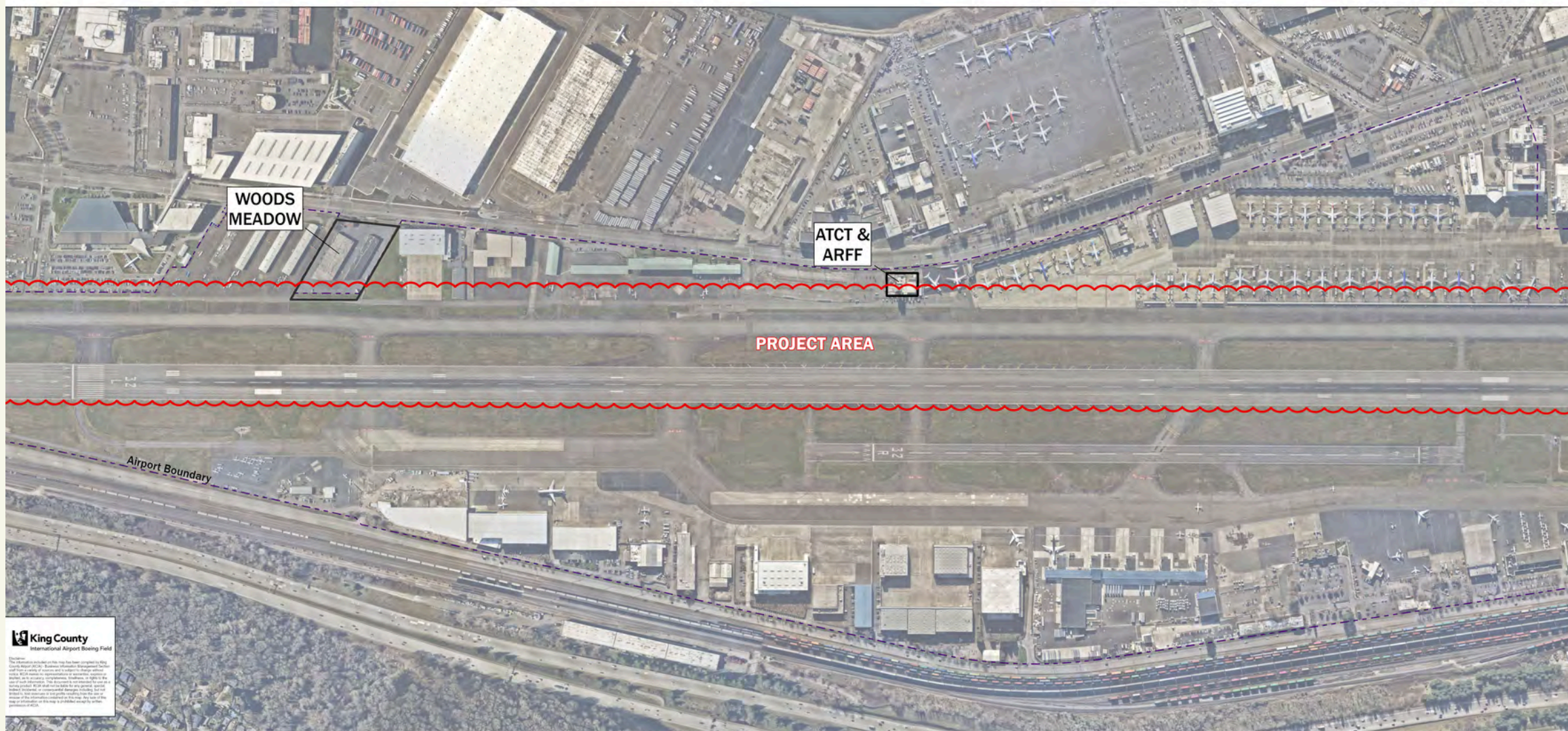

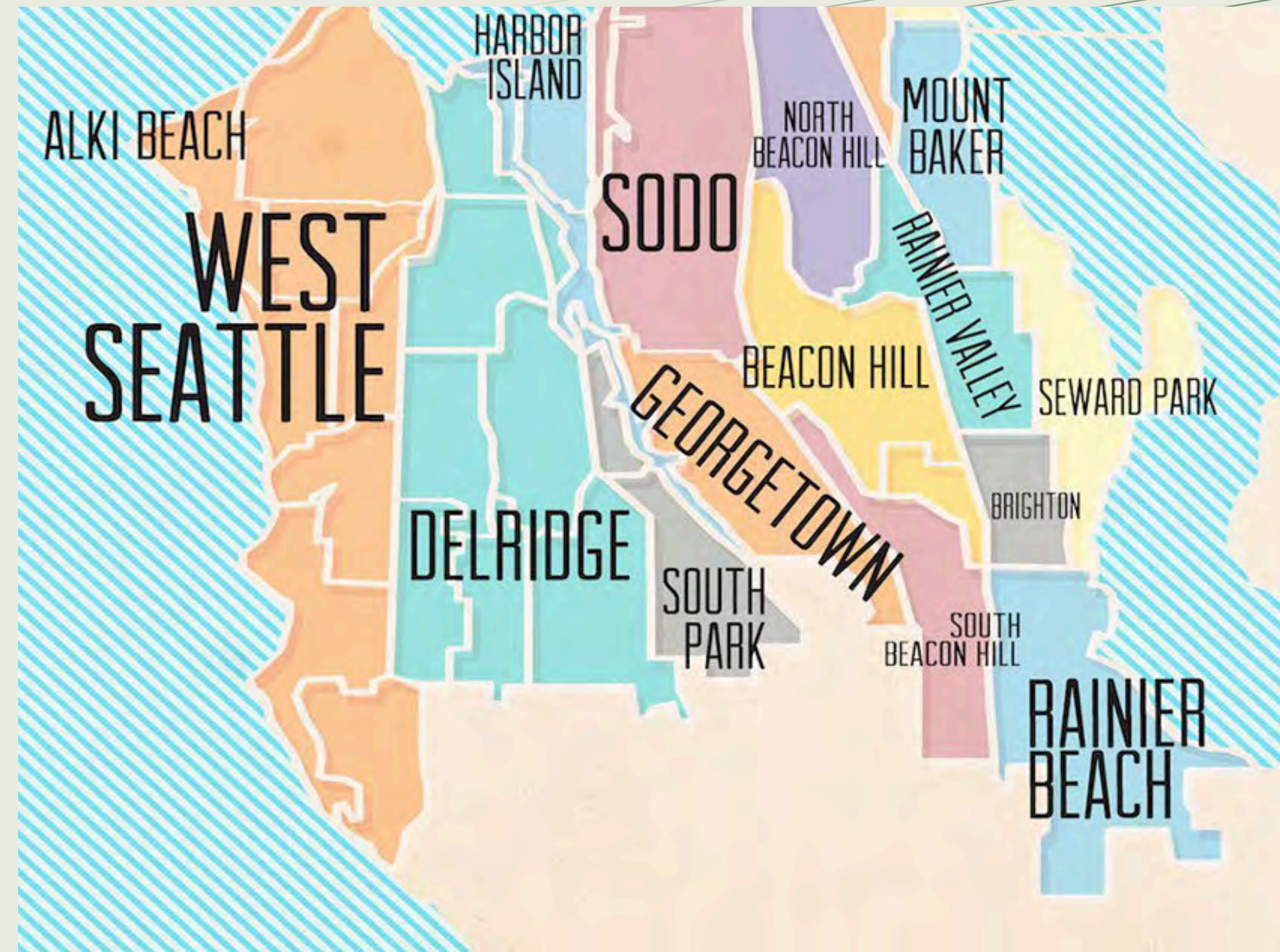
The airport receives no general tax dollars. It's financed by rents, fees, and some Federal Aviation Administration (FAA) resources.

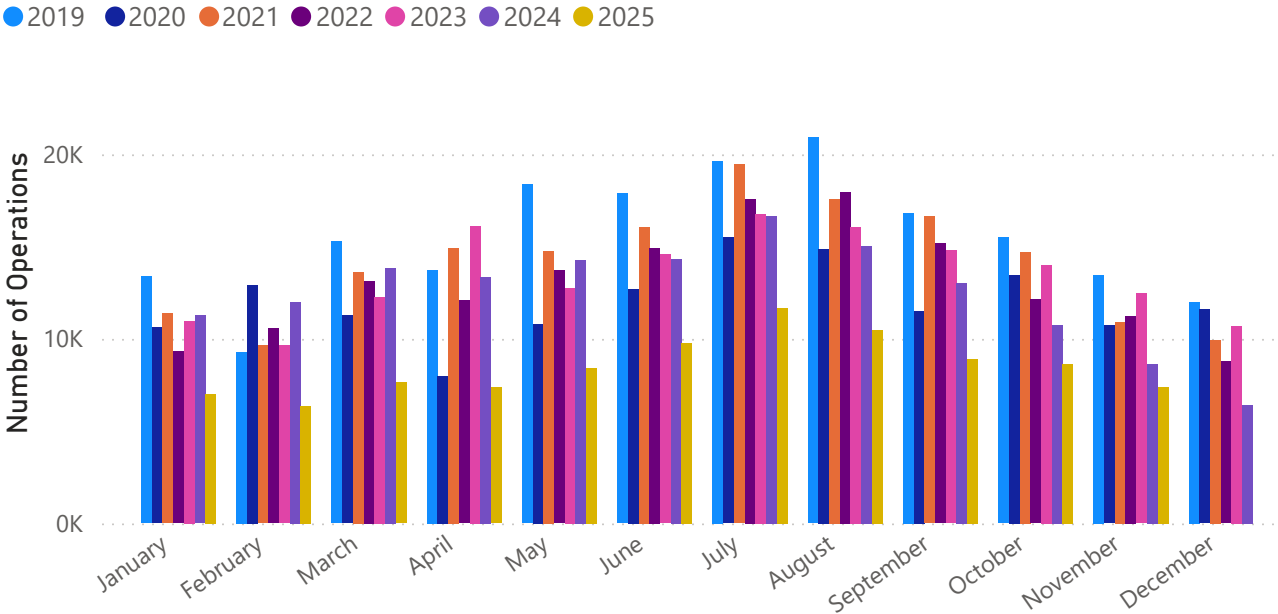

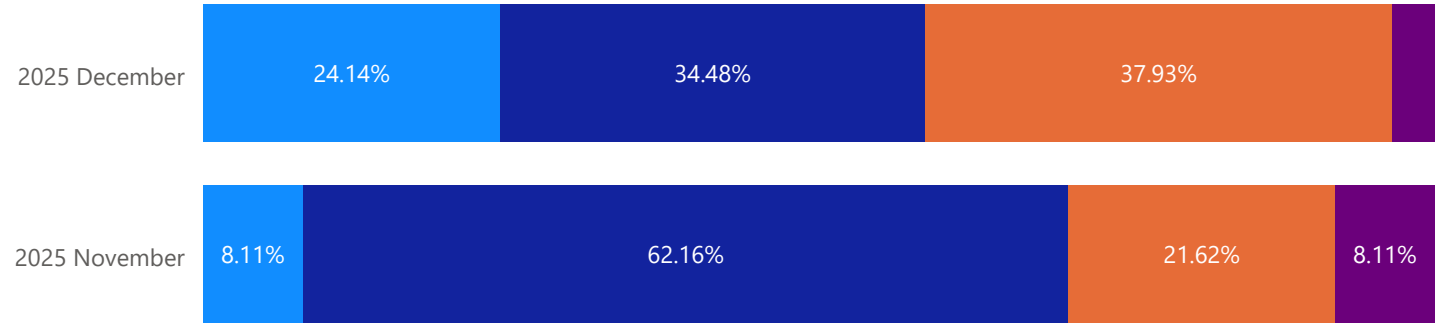

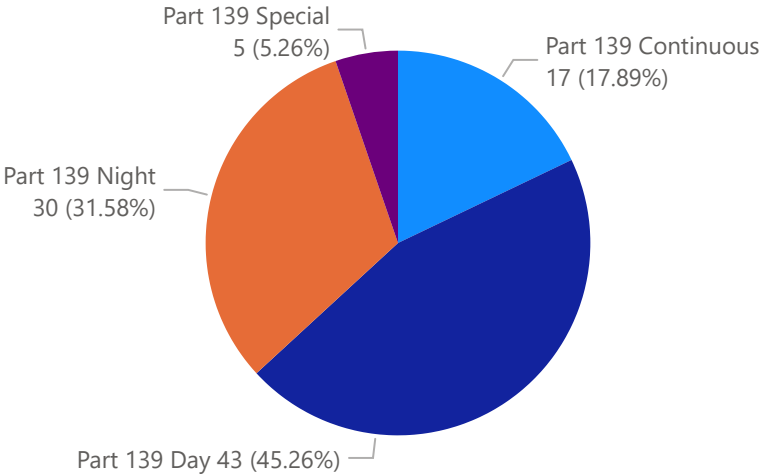

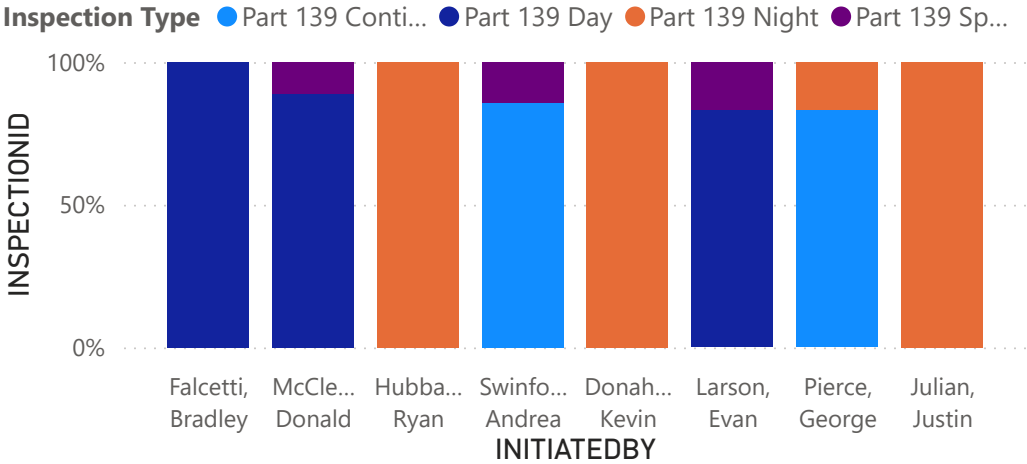

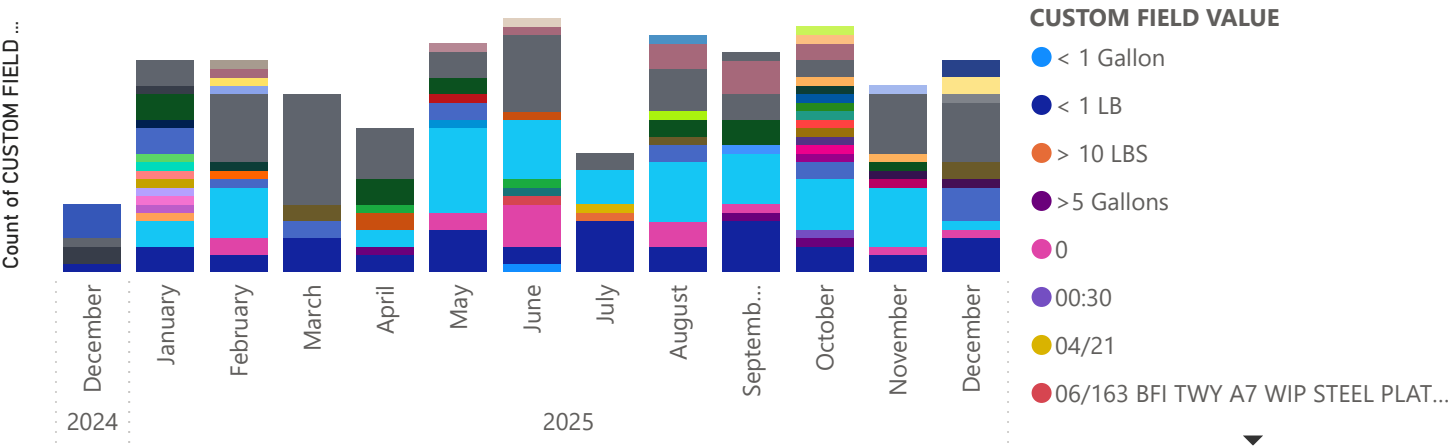

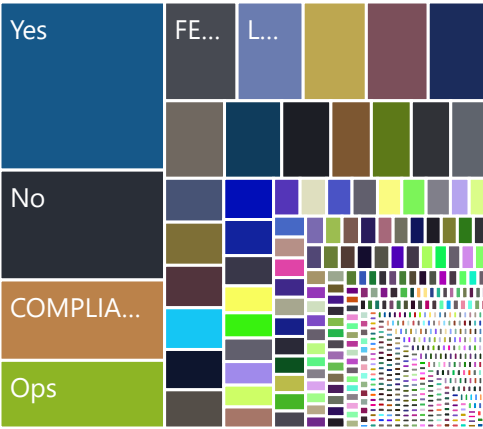

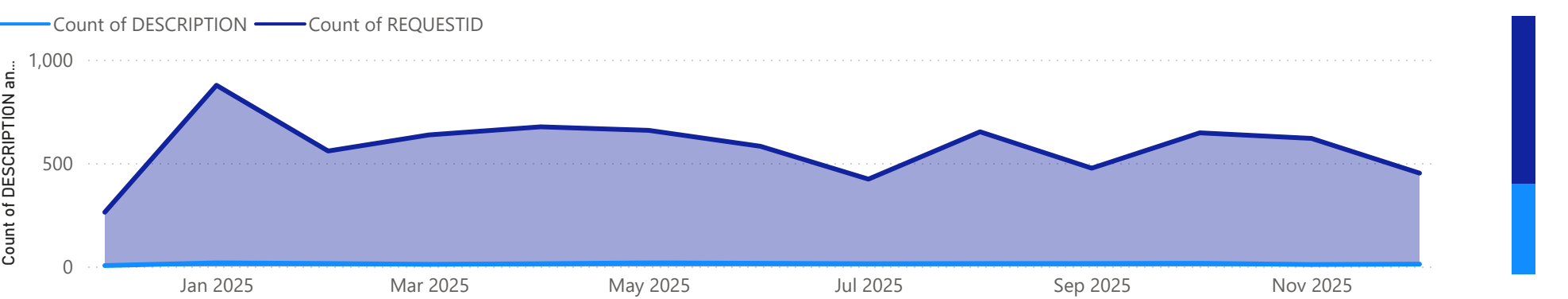
Count of Custom Field Name and Custom Field Values Over Time
